

"We're gonna need a bigger bus."

#### SCHOOLED

#### The memes on the bus go Partly Fake But parents of schoolchildren still

have cause for concern Many parents of children who ride school buses felt "taken for a ride" on May 20 — myself included. That morning, I noticed a meme on Facebook that appeared to be a screenshot taken from the CDC website; it read in part: "New CDC guidlines [sic] for reopening schools... Wear masks over the age of 2; no field trips, assemblies, or external organizations in the schools; the distance on school buses — one child per seat, skip rows." The meme was shared on various Facebook and NextDoor groups, and on school bus driver forums throughout ered by the district. Opined Bill, "I am assuming we will need more school bus drivers if they spread the kids apart on our buses, which already seemed at full capacity [pre-pandemic]. Besides bus drivers, we are going to need more buses and use more more gas."

Curious, I clicked on the meme that had piqued my interest. A popup window appeared: "Partly False Information Checked by independent fact checkers." I clicked the "see why" button: "The information in this post is a mix of true and false statements or it could simply

be incomplete. In some cases, the information is misleading. Fact-Check from USA Today Partly False. Fact check: CDC's guidelines for reopening schools are recommendations, not rules."

According to an article posted by Facebook on May 12, besides collaborating "with over 60 fact-checking organizations around the

world that review content in more than 50 languages," they are using AI (artificial intelligence) to detect misleading memes. The article showed how photos and screenshots taken from videos posted by mainstream media are sometimes slightly altered and then re-posted online.

On May 19, the CDC posted an updated list for schools and bus drivers. Underneath the "As a bus transit operator, how can I protect myself?" section, it read in part: "Limit close contact with others by maintaining a distance of at least 6 feet, when possible; consider asking bus passengers to enter and exit the bus through rear entry doors; avoid touching surfaces often touched by bus passengers; use gloves if required to touch surfaces contaminated by body fluids."

the U.S.; perusing the comments, I noticed that the debates were fairly balanced. Then I communicated with some local bus drivers.

"There is no way you can [follow] the social distance [on a school bus]," said Corrie from North County. "I am a bus driver with 256 kids a day. I make three trips; some kids don't even get home till almost 6. It's not possible."

"That's going to be difficult to adhere to with the seating, depending on how many kids ride and how many buses they will have in service," agreed an MTS bus driver who requested anonymity due to policy.

In April, Bill from City Heights considered a full-time bus driver job with the San Diego Unified School District that started at \$21.22 an hour — with paid holidays, paid sick leave, paid vacation leave, a CalPERS retirement plan, and with health/dental/vision benefits for the driver and qualified dependents that are fully covcould load from the rear," said the MTS bus driver. "It will probably have to be the front door for them, but I see a need for more drivers and buses to operate safely. We are not allowed to leave passengers behind but we do have a tenpassenger limit, and if there is a stand-by bus, they do send it out. One time I had 20 passengers and no back up and I had to proceed. I loaded 20, and left two people, but I was instructed to do so. We've been pretty good about rear door entry, and it's up to passengers where they sit, but when I had those 20 people I had people in every seat."

"Are you fearful when you drive?" I asked.

"I was in the beginning, but I try to stay calm and brave. I took an oath to become a bus driver and that's what I remind myself when I start to get stressed out."

#### Village vendors vexed by pedestrian proposal Restaurateur Resnick requests rescue

The once bustling Wednesday afternoon Carlsbad Farmers Market has re-opened with a fraction of its former clientele. "We don't know if or when we will ever get back to those [packed]

days at the market," says Christine Davis, executive director of the Carlsbad Village Association which oversees the 26-year-old attraction. "We are down from 52 vendors to 30 due to the mandatory spacing between booths." Still, after being dormant for two months, commerce in Carlsbad's downtown Village business district has begun to revive. Garcia's Mexican restaurant

was one of the first eateries in North County to implement the "parklet" curb cafe model to expand its outdoor dining space, and Mas Fina Cantina has since followed suit.

But the owner of two different State Street restaurants says COVID-19 has brought dire consequences to his eateries, and he's asking the city of Carlsbad for some intervention to keep his restaurants afloat. John Resnick operates Campfire and Jeune et Jolie. Last November, after being open less than a year,

Jeune et Jolie was named one of the 26 best restaurants in San Diego by *Conde Nast Traveler*. "I am incredibly concerned for my two businesses and the 132 amazing people we employ," Resnick told the Carlsbad city council in a letter. "Restaurants are particularly vulner-

> able," because, he says, eateries often have small dining areas and "... margins are extremely thin...Time is of the essence." He proposed two different ideas for the city to consider. One was for restaurants to be allowed to have food and beverage service in their parking lots. The other, more controversial idea has fellow State Street business owners talking: "I believe it would

be in the city's interest to temporarily convert [State Street] to a pedestrian thoroughfare for the summer." And it seems that Resnick resonated: the city of Carlsbad is currently polling business owners and residents on State Street, asking them if they would like all or part of their street to be closed to vehicles and open only for pedestrians. The plan to eliminate cars could impact just the 40 businesses on *continued on page 6*

#### **Can Lyft gift cover short** shrift?

Charity ought to begin at home, or at least corporate HO

On May 5, San Diego City Attorney Mara Elliott announced her office was joining a lawsuit against gig transit companies Lyft and Uber for violating Assembly Bill 5, authored by Assemblywoman Lorena Gonzalez, a fellow San Diego Democrat. Other plaintiffs in the case include California Attornev General Xavier Becerra and the city attorneys

of San Francisco and Los Angeles. "California law is clear: for the full range of protections afforded by California's Wage Orders, Labor Code, and **Unemployment Insurance** Code, workers are generally presumed to be employees unless the hiring entity can overcome this presumption by establishing each of the three

factors embodied in the strict 'ABC' test." the suit claims. "Uber and Lyft cannot overcome this presumption with respect to their drivers."

Accusing the ride-providing giants of "thumbing their noses at the California Legislature and the officials charged with enforcing these laws." Elliott added. "It's time for Uber and Lyft to respect the law."

Two days later. at the behest of San Diego city council Democrat Monica Montgomery, Lyft gave \$5000 worth of free rides to I Am My Brother's Keeper Community **Development Corporation**, based on Imperial Avenue in Montgomery's Fourth district, per a May 27 disclosure filing. The charity, led by executive director David Muhammad, special-

izes in workforce training, clean energy, and providing food to the poor - and is currently holding a COVID-19 food distribution event every Tuesday at the Jacobs Center, according to the non-profit's website. Muhammad "founded the Baltimore

distribution event every Tuesday at the Jacobs which solicits charitable

The non-profit's so-called green program is

run by Sister Maria Muhammed.

**Citizens for Positive Change [Community** Development Corporation], an entity that cultivated partnerships between familydriven organizations working to end our nation's youth homicide epidemic one neighborhood at a time," per his profile on the site.

The non-profit's so-called green program is run by Sister Maria, "known for working in numerous fields over the years until she found her love and niche in teaching at Muhammad University of Islam in Inglewood, and The School of **Original Thought in Baltimore, Maryland** where she was also appointed to the position of Dean of Girls," the site says.

Lyft's gift is another example of how, detractors say, the company has deployed charitable contributions during its ongoing battle with state officials to remain exempt from the requirements of AB 5, which would force drivers to be employees rather than freelancers. "Both [Lyft and Uber] have launched an aggressive public relations campaign in the hopes

 $\frac{1}{2}$  of enshrining their ability to mistreat their workers," asserts the Elliott suit, "all while peddling the lie that driver flexibility and worker protections are somehow legally incompatible."

In November, Lyft boasted that the Round David Muhammad holds a COVID-19 food Up & Donate program, contributions from its rid-

ers. had raised more than \$18 million from Lyft customers. "We're in awe of the collective impact they've made protecting LGBTQ+ rights, supporting U.S. veterans and military members, helping provide rides when they're needed most, and so much more," says a November 7 blog post by the company. "Curious which areas in the U.S. give the most? Here are the

top 10 cities based on the dollar amount donated: San Francisco, NYC, L.A., Chicago, Washington D.C., Boston, Seattle, Philadelphia, Denver, Miami."

In June of last year, Jeren Miles, Lyft's thenhead of Community Affairs, Public Policy, came up with \$250 for the 2020 San Diego mayoral campaign of Assembly Democrat Todd Gloria,

according to city filings. The San Francisco-based company gave \$50 to the San **Diego Regional Chamber of Commerce Political Action Committee on September** 30 of last year.

### UNDER THE RADAR

**Richly Rath Phil Rath**, the longtime Republican insider and close advisor to San Diego mayor Kevin Faulconer, continues to clean up on the local lobbying circuit, according to his latest personal statement of economic interests, filed May 27 and covering the period from September 12, 2019 through the end of last year. Rath's current mayoral patronage gig is as a consultant to the chief operating officer and administration, the document says, providing no other details.

On the outside, Rath owns PPR Solutions, Inc., which the disclosure calls a public affairs consultancy. That outfit, valued at between \$100,000 and \$1 million, took in more than \$100,000 in pro rata gross income for Rath, per the report. Clients constituting \$10,000 or more of revenue for the concern were restaurant chain Chickfil-A and marijuana vendor Loud, Inc. Also on PPR's

greater than \$10,000 list: Newland Sierra, LLC; Paragon Partners; Torrey Holistics; UMMC, Inc; Will Senn; SBC Inc; Lennar Homes of California; Vulcan Materials; Real Outrageous Partners, LLC; Strainwise; and Torrey South Ventures, LLC.

One the city's busiest lobbyists, Rath also lists himself as a partner in Rath Miller, Inc., another public affairs consultancy valued between \$100,000 and \$1 million, which provided more than \$100,000 of gross income to Rath, says the disclosure. The list of clients furnishing greater than \$10,000 of revenue to the company included developer Zephyr Partners, pot proprietor Torrey Holistics, and

Conduent, a so-called business services provider with a \$39,000 city consulting contract, according to a June 30, 2019 purchase order. Strainwise battled the Del Mar school district last November over a pot shop location sought by the Denverbased company. "Not only is this proposed dispensary directly next to our maintenance, operations, facilities and technology offices, which

in and of itself is extremely disconcerting, the proposed project has some potential environmental impacts that have not been thoroughly investigated through the CEQA process," Del Mar school superintendent Holly McClurg complained to the Union-Tribune.

Rath's web of lobbying contracts resulted in an \$11,000 fine levied against him in August 2018 by the city's ethics commission for "extremely egregious" violations of conflict-of-interest laws during his tenure as a Faulconer-appointed board member of the now-defunct Civic San Diego. The influence peddler admitted he failed to disclose cash he'd received from developer Affirmed Housing before voting on one of the firm's projects. Rath was subsequently slapped with a follow-up fine of \$5000 in the same case by the California Fair Political Practices Commission for breaking state law. "These violations are extremely egregious because they undermine public confidence in the

> integrity of the City's decision-making process," ethics commission chair **Deborah** Cochran said in an August 2018 news release.

Early this year, Rath, currently chief of San Diego's Medical Marijuana Coalition, helped shepherd a marijuanafriendly billboard law through Faulconer's office and the city council that kept 352 of 644 signs eligible for pot ads. The

to Assembly Democrat Todd Gloria's bid to be San Diego mayor, giving a total of \$1050 in November and December 2019. He subsequently came up with the same for Republican city councilman and failed mayoral candidate Scott Sherman in January and February of this year.

#### No more better tomorrow

Republican Chris Cate won his second term on the San Diego city council in November 2018 by beating Democrat Tommy Hough, leaving him with just two years before terming out. Cate now has his eye on District 77 of the Republican Central Committee. On May

> 4, another of his controlled committees, Citizens for a Better Tomorrow by Chris Cate, transferred \$24,247 all of its money — to his central committee election fund, according to a May 19 filing with the city clerk's office. In February 2018, Better Tomorrow's website, subsequently taken down, said the group planned to back a state ballot proposition to "end early release of rapists and child

traffickers and would add 15 crimes to the list of violent crimes for which early release is not an option." The committee also promised to seek a "Proposition 13 Portability Initiative," to "allow homeowners 55 years of age or older to transfer some of their Prop 13 property tax base to a home of any price, located anywhere in the state, any number of times." Twenty thousand dollars of the group's cash came from Allan Camaisa, vice chaircontinued on page 19

the one-block area of used for the Farmer's market (between Grand Avenue and Carlsbad Village Drive), or be expanded to include the entirety of the mile-long street.

David Graham is chief innovation officer for the city of Carlsbad. He says that at this time, it does not seem like the State Street businesses or the city council have reached a decision. "We don't yet have a consensus." He says the city will continue to poll the State Streeters not yet contacted by the Carlsbad Village Association. It is expected the Carlsbad city council will revisit the pedestrianization of State Street in June.

"When I heard about it, I about had a heart attack," says Carrie Moore, co-owner of the Trove Marketplace, an indoor emporium hosting some 70 different vendors. "It doesn't work for me." She says she understands the plan was connected with Councilmember Cori Schumacher's overarching plan to bring a trolley system to Carlsbad. "If you want a village full of restaurants, then I guess it might work." But Moore says a pedestrian-only State Street endangers stores that sell furniture or other large items. "It will handicap all businesses on this street except restaurants," agrees Skylar Ireton, whose Skylar's Home and Patio is next door to the Trove Marketplace. Besides, he says, the city is still avoiding the major issue facing businesses in the downtown village area: a lack of parking. "I've been here for ten years, and the city keeps saying they are going to build parking structures. But nothing ever gets done. They keep adding businesses, but they never address the parking problem." Adds Moore, "I have had people tell me they drove around the block four times before finally just giving up. They keep saying to use the train station parking, but when everything gets back up and running again, that fills up."

It's not only large-item retailers who are concerned: Cindy Wright of Mulloys Fine Jewelry says, "I don't think [closing the street] will help. As it is, the farmer's market kills our business every Wednesday."

But Will Lerner, a bartender at the Village Pub, one of Carlsbad's oldest businesses, thinks "it's a really good idea. If you want to call it a village, then let's make it a village and give people the freedom to roam." He says the diagonal parking in front of his bar is dangerous. "I've seen a lot of near misses."

Whatever the city's decision, Ireton says the store across the street from his will thrive with or without traffic, with or without a pandemic. He says Handel's handmade ice cream has a line down the block through most of the day. "I remember on March 20, which was right after the lockdown started, they had 50 people lined up waiting for ice cream. The line never stops." KEN LEIGHTON

Big-label beer started running low across Mexico in early April after government officials ordered all beer and spirits production to come to a halt, deeming it a non-essential industry amid precautions caused by the spread of the Coronavirus. Authorities have yet to set a resume date for production. The mandate led

for family parties. In a reversal of Prohibition-era practices, other cross-border travelers are taking beer from the United States into Mexico to make some quick cash. In the Facebook group

the country's two largest producers, Grupo Modelo and Heineken de México, plus independent craft brewers, to cease all operations. Many reacted to the ban by making large purchases, which forced retailers to place product limits on sales as stock depleted. As reported by the Reader's Matthew Suarez, a limit of three six-pack containers per customer was implemented in Tijuana.

As major-brand beer has become almost impossible to find in Tijuana, some crossborder locals have taken advantage of their essential trips to San Diego to take some cerveza back home. "I pick up a little something if I pass by a store," said Estaban, a Tijuana resident who makes regular trips across the border, picking up two 12 packs of Heineken at the Ralphs store on East Palomar Street in Chula Vista. "Finding beer is normal up here, so it's not a big deal," he remarked. At the Broadway Walmart in Chula Vista, some Tijuana-bound shoppers loaded their label of choice into their Baja Californiaplated vehicles. A shopper who declined to provide his name loaded beer, cleaning supplies, and electronics into his trunk. He said all his purchases were for home use, but that he was planning to share his Modelos with a neighbor in the El Soler neighborhood. A Walmart employee said beer sales have been a bit higher than they were before stay-at-home mandates went into place, and that there was a big increase in the days before Mother's

images of what they have in stock, along with with information such as price and delivery radius. Beer put up for sale in the group often features packaging and labels used in the U.S. User photos often show loaded shopping carts at U.S. Walmart locations or include mentions of crossing back with beer for sale. On



average, a 24-pack of Tecate, Coors Light, Michelob Ultra, or Bud Light for sale in the group ranges from 700 pesos to 900 pesos, about \$31 to \$40. (Moderators seek to prevent highly abusive pricing.)

Despite the high demand for commercial beer, some Tijuana retailers still have craft beer in stock. And independent breweries are selling their product directly to consumers in the absence of regular taproom activities and wholesale distribution to eateries.

Last week, Grupo Modelo's Victoria brand released Victoria Chingones, a product with an ABV of 1.8% which allows it to bypass the beer production ban. Although it eased the supply strain and can be found with ease, many are reluctant to consume the new brew. MARIO A. CORTEZ

#### VALLEY CENTER

#### Lilac Hills keeps coming up Proposed development proves as perennial as its namesake

It wasn't on the county planning commission's May 15 agenda, but conversation about Lilac Hills Ranch, a proposed subdivision near rural Valley Center, sprouted up again. The county had given the current developer, Ranch Capital, a May 20 deadline to withdraw the project - which includes 1,746 homes, retail and a 200-bed assisted living facility - due to serious fire safety flaws. Attempts to obtain easements for brush clearing from property owners along West Lilac Road, a planned evacuation route, had failed. Lacking a viable alternative, the project is headed to the board of supervisors on June 24 with a recommendation of denial, said Mark Wardlaw, director of Planning & Development Services. But the developer chose not to withdraw.

With the deadline looming, commissioners discussed finding "solutions" to the impasse. Last week, an attorney for two environmental groups warned the commission in a letter that their "discussion and action at the May 15 meeting violated the Brown Act." That is, Lilac Hills wasn't anywhere on the agenda, with the result that those who might want to



## Vet holds the line between protest and riot

I was late to the protest in La Mesa on Saturday night. I hadn't intended to go at all - what could I possibly add that social media and TV news would not have covered? But I stopped by the Vons a little after 8:30, found it was closed, and noticed the "Fuck 12 pigs" tag on the brick wall at the northwest corner of the parking lot. I walked up Allison, checking the many tags: besides "Fuck pigs," the most common were "Black Lives Matter," "ACAB," and George Floyd's unheeded plea, "I can't breathe." I arrived in time to see the last of the windows shatter on the Heartland Fire & Rescue pickup truck parked outside City Hall, and to see a group of young men set it on fire and pose for selfies in front of the conflagration.

Air Force veteran and current SDSU student Chris Mavry was not late to the protest. By the time I spoke with him at a little before 9 pm, he had been there for six hours, trying to keep the peace. I found him on Date Street, walking the no-man's-land between the line of silent sentries in riot gear guarding the Police Station and the angry crowd in the parking lot across the street. The protestors shouted: "Learn to love something, you hateful motherfuckers!" "You love to hide behind your masks and your guns and your badges; fuck all of you!" "You shot a woman between the eyes, assholes!" (The aftermath of that incident, which involved a bean-bag bullet, can be seen on the YouTube channel of California Citizen

Watch.) Also this: "Why are you pointing your gun? Shoot me, bro! What the fuck!" At that, Mavry faced the police, raised his megaphone, and led the crowd in a chant of, "Hands up, don't shoot!"

"Whenever the police start shooting, I stand in front of them," Mavry told me, "because I

know they probably won't shoot me. I'm not inciting violence, and I'm wearing this" — his camouflage Air Force shirt. "If I'm out in front, it keeps the danger off [the protestors]. We

> just gotta check each other, make sure violence isn't happening on both sides. I make sure our bad apples are talked to. If someone's throwing rocks, I tell them, 'Hey, that's not we're about right now."

As he paced north and south on Date, Mavry talked to the cops over his megaphone: "My fellow Americans, I just want to remind you about a few of your fellow Americans we have lost. Trayvon Martin, Breonna Taylor. I don't want to be here. I'm tired, bra; I'm so tired. But I'm more tired of

seeing my people killed on the nightly news. So I got to be out here. We don't want to be your conscience. We shouldn't have to tell you that it's wrong to kill a man. But when you love somebody, you're gonna let them know when what they're doing is wrong. We love you enough to tell you that you can do better. No man deserves to die in the street like an animal. That's not what I fought for."

He stopped his address to hustle over to a flare-up along University. "Hey brother, that's not what we're here for!" he called to the California Citizen Watch reporter, who was shouting at a man and a woman standing in front of the police: "Fuck you, bootlicker!" over and over. Then Mavry addressed the

man: "Hey how you doing? I'm Chris, a fellow American. You know they're killing Americans on the street right now?"

"You're telling me they're going apeshit right now?" asked the man, incredulous. "Who's dead right now?" asked the

woman. "You're in La Mesa." "My brothers and

sisters are doing some bad shit," admitted Mavry. "But we callin' out ours."

"Are you, though?" asked the woman.

"We are," replied Mavry. "I been doing that all night. I served in the Air Force for seven years, three combat tours."

"Thank you," interrupted the man, quite sincerely.

"And I sleep at night knowing my baby might die tomorrow for no reason other than the color of their skin. All we're here to do tonight is protest these ideals that our country stands for."

"There's a difference between a protest and a riot," said the woman.

In the end, Mavry couldn't possibly check his. There were too many of them, and they were too inflamed, their shouts of rage giving way to whoops of glee at their own destructive power. ("There's something on fucking fire, bro!") They burned a Vons delivery truck, and a second car on Allison. As I walked back to my own car in the Vons parking lot, someone hollered, "Who wants takeout?" The mob was looting Panda Express — and the beauty supply shop, and Vons. A woman held a red flower in the foreground as she took a picture of looters emerging from the smoky grocery store, laden with beer and booze. Someone else had stolen armfuls of baseball bats from Play it Again Sports and was passing them out. The mob put them to use on the shopping center windows. I headed home, but not before I heard someone shout, "Grossmont Center next!"


Sunday morning, I drove past the burned out husk of Randall Lamb engineering on Palm, and the two banks on Spring Street that had been torched the previous evening. I visited the mall and saw the broken-out windows of the Starbucks inside Target. There were more broken windows at the nearby BevMo — apparently, the bad apples had been thirsty. Still, Mavry had done his part, keeping the violence in check as he walked his self-appointed rounds. "Part of me didn't want to come," he told me. "You know it's not going

to be the best of humanity, on both sides. But if somebody doesn't take a leadership position and say, 'It's about *this*, not *that*,' who will? I don't know how I'm doing it; it just came alive inside of me. I don't want anybody else's children to die — theirs, ours, whoever."





uthor Marty Rubin once observed, "Parks and playgrounds are the soul of a city." A century before him, famed 19th century horticulturalist Andrew Jackson Downing similarly sang the praises of these urban spots of green when he wrote, "Plant spacious parks in your cities and loose their gates as wide as the morning, to the whole people."

The city of San Diego alone has more than 400 parks — and there are many more in the county's 17 other cities and unincorporated areas. But

while those parks are meant to provide a pleasant respite from daily life, sometimes bad things happen at them.

#### Worst of the worst

Balderrama Park is a small neighborhood park in one of Oceanside's more troubled communities. It's one of those areas built before zoning laws, where you'll find boxy, two-story apartment buildings scattered among shabby single-family cottages and bungalows. Some homes are wellkept; most aren't. High weeds, cars on blocks, and "Beware of dog" signs posted on chain-link fences are frequent sights.

Located on San Diego Street, a few blocks north of Mission Avenue, just east of Interstate 5, Balderrama Park offers residents a playground, tennis and basketball courts, a small recreation center, and a patch of green ideal for pick-up soccer games and family picnics.

Originally known as Eastside Recreation Park, the three-acre park was renamed in 1970 after Joe Balderrama, the first U.S. serviceman from the heavily Latino neighborhood (known to locals as "Pozole") to be killed in action in World War II.

He was 19 — just four years older than Annabell Flores, a young Latino girl with laughing brown eyes, when she was shot and killed early on the morning of September 3, 2016 in the park that bears his name.

Young Annabell — nicknamed "Littles" — was sitting by herself, unaware of what was about to happen. Two men wearing masks ran into the park and opened fire, without provocation. Police found Annabell lying on her back in the playground area, with a fatal gunshot wound.

Less than two years later, a judge sentenced two Oceanside gang members, Daniel Ramos and Elias Ramos (no relation), to 92 years to life in prison and 84 years to life in prison, respectively, for Annabell's murder. Daniel pulled the trigger, while Elias scouted out the site before the shooting, the judge said.

Prosecutors said the two gangsters were looking for a rival gang member at Balderrama Park, intending to kill him.

The prosecutor told the judge this crime was the "worst of the worst."

#### **Balboa Park**

It's the oldest and grandest of the city of San Diego's four regional parks, measuring 1172 acres and attracting 20 million visitors per year, the city says. Host to both the San Diego Zoo and the Old Globe Theatre, the park is home to more than than 15,000 trees; 14 specialty gardens; nearly 100 arts, education, recreational, social and sports organizations; and 17 museums and cultural institutions. Balboa Park was the site of two world's fairs, the 1915-16 Panama-California Exposition and the 1935-36 California Pacific International Exposition, which gave the park such iconic structures as the California Tower, the Spreckels Organ Pavilion, the Spanish Village Arts Center, and the Zoo.

Palm Canyon is described on the Balboa Park website as a "hidden ... tropical oasis, containing more than 450 palms (58 species) within its two acres." The canyon is crisscrossed with hiking trails. The original cluster of Mexican fan palms dates back to 1912. In 2001, the California Conservation Corps restored the trail that connects Palm Canvon to the Old Cactus Garden.

Shortly before noon on February 27, 1985, 40-year-old actor David Huffman was stabbed to death in Palm Canyon by Genaro Villanueva, a 17-year-old undocumented immigrant from Mexico. Huffman, who was appearing as Lenny in the Old Globe Theater's production of Of Mice and Men, had been sitting near the Organ Pavilion in his parked van, playing his bagpipes, when he heard a vacationing Canadian couple shouting that someone was standing in the doorway of their friends' motor home. He looked up and saw Villanueva take off running.

Huffman jumped in his van and drove after the fleeing teen. When Villanueva leaped through some bushes into Palm Canvon, Huffman stopped his van and ran after the teenager, down the meandering dirt hillside trail. A scuffle ensued; Villanueva pulled a screwdriver from his pants pocket and stabbed Huffman twice in the chest, killing him — and then fled. His body was later found by a group of schoolchildren who were taking a nature

walk along the trail at the bottom of the canyon. A coroner's deputy estimates Huffman bled to death in 30 to 45 seconds.

Villanueva was arrested two weeks later, after his parole officer saw a police sketch drawn with the help of the Canadian tourists.

After a quick trial in December of that same year, a jury convicted Villanueva of first-degree murder. Villanueva, who at the time of the killing was attending San Diego High School, testified that he stabbed Huffman in self defense because he feared the older, bigger man

would kill him, but the jury didn't buy it. In June 1986, Villanueva was sentenced to 26 years to life in prison for Huffman's murder. He was sent to the California State Prison in Centinela. In December 2011, Villanueva was denied parole for 15 years.

Just before his death, Huffman was slated to appear in the miniseries North and South. His credits also include the films The Onion Field. The Honor Guard and Blood Beach, and the TV shows Little House on the Prairie, Newhart, and Trapper John, M.D.

#### **Redwood Circle**

It's a large lawn area at 2700 Balboa Drive, just east of Sixth Avenue and north of El Prado, where numerous shade trees grow. The meadow is a popular spot for large family gatherings and wedding ceremonies and receptions.

On Saturday, August 4, 2018, police responding to a 911 call shortly before 10 am found 38-year-old Nicholas Turner lying in the grass, dying of an upper-body stab wound. He was taken to a nearby hospital and pronounced dead.

The 911 caller, 47-yearold Damon Crudup, was later arrested for the murder. The two were boyfriends. Both were homeless transients. Crudup pleaded guilty to involuntary manslaughter and received a fiveyear prison sentence.

#### **Morley Field**

It was named after John Morley, who served as a superintendent in Balboa Park from 1911 to 1939. The sports complex features 25 tennis courts, a swimming pool, a senior center, a playground, group picnic areas, an archery range, a multipurpose ball field, a velodrome bicycle track, bocce courts, a disc golf course, and other sports and fitness attractions.

On September 6, 2009, just before 8:30 pm., police received reports of gunshots in the Morley Field area. They found 23-yearcontinued on page 35





weigh in had no notice. Under the Brown Act, topics not on the agenda are limited to things like asking questions for clarification and brief announcements or reports. The letter said that the discussion "went far beyond" the types of comments allowed on non-agendized topics, and lasted for over 20 minutes.


The conversation began with a mention of the deadline to fix the fire safety issue. "I'm a bit dismayed," said commissioner Edwards, citing how much time and effort staff and the commission had put in, and volunteering to help resolve the issues before it went to the board. He suggested setting up "a short ad hoc meeting with an ad hoc group to report back to the commission."

But according to the letter from attorney Sara Clark, doing so "would directly conflict with county requirements" regarding impartial, transparent decision-making. The solutionfinding would "presumably take place behind closed doors and without any public input," leaving the public out of the conversation about serious safety issues. However, a few commissioners said they thought it was permissible to form an ad hoc committee without public notice, noting that they had done it before. "I for one think it's possible to find a solution, and I'd like the opportunity to forward that to the board" said commissioner Woods — if the director allowed them to form a subcommittee. "Which I think we can on our own, but I'm not sure on that issue."

"I don't want to discuss the item," the chaiman said, "but is it possible to, in a general question?" If an issue arose with a project, and commissioners are volunteering their time to meet with staff and the applicant, is that allowed? It was "probably something an ad hoc committee can do for a limited purpose and time," said county counsel Thomas Montgomery, but since it wasn't before them that day, they couldn't make any decisions. "I don't believe you can appoint an ad hoc committee to work with the applicant," he said — it would have to be put on a future agenda.

The idea didn't sit well with commissioner Seiler. "I'm getting a real uncomfortable feeling that we'd put an ad hoc committee together to promote a project that's already been found inadequate relative to fire protection," he said. "If commissioners go into an ad hoc committee to do that, to find a way to make this work, I think by right they should be recused from voting on that project. They now have a vested interest in it."

In an update on the project, Wardlaw, described how it was first proposed by the

Accretive Group in 2012, later rejected by voters, then in 2017 was picked up by a new applicant. "Then came the worst fires that California has seen." There was also a change in fire marshall services within the Deer Springs Fire Protection District. For those reasons, the fire authority reviewed the project and raised a series of concerns about its fire safety design and evacuation suitability. Despite clear direction about necessary changes, only a few were able to be incorporated, along with some alternative routes. But the main problem is the inability to obtain 20-foot easements along West Lilac Road. "We've been working with the applicant for over a year to address those issues and the fire authority has determined that the project is unsafe as currently designed," he said.

The meeting ended with chairman Barnhart announcing he would appoint commissioners Edwards and Woods, who also expressed interest, to an ad hoc committee. And that they would put it on the agenda the next time. "It's pretty tough to get a project through this commission if you've got the fire authority saying it's unsafe," the chairman said. "But I'm not so sure the accommodations can't be made." SHEILA PELL

continued from page 8 Last sold in 2013 for \$950,000 when it housed only a 1930sera triplex, the parcel is currently held by a Sacramento-based investment group that completed construction of the current building in 2017. To help offset the new owner's mortgage payments, lower levels include four twobedroom apartments, a dozen one-bedroom units, and a groundfloor studio. A pair of one-bedroom units currently show as available for rent with an asking price between \$1995 and \$2100 per month.

As of May 1, buyers have been offered the opportunity to purchase "a world class asset located in, without a doubt, one of San Diego's hottest neighborhoods." The original list price of \$13,250,000 remains unchanged to date.

## French breakfast in **Little Italy**

#### Such crunching, oozing goodness

inqué. Guess I just like the crazy French name. It's what French hipsters call a sidewalk bar where you can stop, slurp a beer while standing at the counter, and carry on with your day.

Now we have one here. Little Italy. But why "Zinqué"?

"Because in traditional places, the counter and tables are topped with untreated zinc," says Stephen, the morning's lone server. "Like

here. They are 'zinqué'd." He pronounces it Zin-Kay. "It's a slang name in French. It's cool."

This is at 8 in the morning. One of the things that brought me to Zinqué: You never have to fret about whether it's open or not. The place serves breakfast, lunch, dinner, coffee, and drinks, from like 7 every morning to midnight every night. And until 2 am Friday and Saturday.

Right now, there's a racket going on across the road. Workers are bashing off ply molds from level two of a high rise under construction. But, hey, makes a good show. Stephen has just brought me out a nice wide cup of steaming black coffee. I could have sat inside, but chose this li'l round corner table out on the sidewalk. That's the other thing. No barriers between you and the sidewalk at this cafe. Just brass studs in the concrete showing the limits for tables. So you really feel part of the life of the street. This is as inside-outside as you can get. I'd never even heard of Zinqué till last week, even though they've been part of this little chain that a French guy named Emmanuel Dossetti started off in LA, ten years ago. Stephen's telling me about it. "His first was in Weho. West Hollywood," says Stephen. "It has since become a minichain up in LA. He has half a dozen now," he says. "This idea of an all-day cafe where you can stop for a coffee or a full-on dinner really took off. He's just opened his newest place in Scottsdale Arizona."

'Course, 8 am is the egg-crack of dawn for me. Consolation was, I thought I'd stop by here for a couple of *oeufs* on toast. We're definitely beyond Little Italy's fashionable central zone, but The Waterfront bar (open as well at this time), and Rovino

egg, muffin, tomato, basil and gruyere cheese, also for \$8. Also a zucchini and egg white frittata bowl. Guess flavor will come from the avocado. parmesan, and pesto. There's also arugula on the side. This is \$7.

Plus a mini egg white frittata with zucchini for \$3.50, \$3.75 with cheese. Still, I get the feeling one bite would be it.

"We also have the brunch menu," says Stephen. He turns one of the printed pages.

Rotisserie make this a snug little gastro-corner.

OK. Breakfast? I check Granola with mixed

berries and yogurt for \$8, a breakfast sandwich of

Ah. More choice. Soft scramble with parmesan and herbs, but it costs \$13. Or "crispy, sunny eggs" with prosciutto and parmesan (\$15). A prosciutto and gruyere croissant with mixed lettuces goes for \$11, and baked eggs with chili and baguette is \$14. So is Quiche Lorraine. Moules frites (mussels and fries) is \$18, burger's \$15, and steak frites with chimichurri (parsley and garlic) sauce or peppercorn sauce goes for \$24. So a lot of items are up there, price-wise. And bottom line, I see a glass of wine (not that I'm thinking of having one now) is around the \$15 mark. That tells you what demographic they're aiming for. On the other hand, they do have a Monday to Friday happy hour, 4-7, where pork belly tacos go for \$6, salami toasts \$4, country pate \$5, and cocktails and aperitifs are \$5 off. So you'll end up paying maybe \$10. Glasses of wine are \$4 off, and beer, \$2 off.

Meantime, I've got a belly to fill. I think of the eggy dishes, but honestly, they sound a little anemic. Then I notice they've got a croque monsieur on the brunch list. And even the croque madame, which means a fried egg has been added on top of the cheesy, hammy, crisp-edged grilled thickbread sandwich.

My Scottish friend, Annie, calls. "I'm stuck!" I say. "What's the best French breakfast?"

"Don't worry!" she says. "Think flakey, mouthwatering hot croissants, melting, buttery. Paris cafe on a plate! Just be sure to have them warm with a dollop of salt butter, maybe jam. Gulp your coffee.

Dunk the croissant. Stuff it with ham and cheese. You'll be smilin' like a bylt haddie!"

Not sure what the heck "bylt haddie" means, but she does inspire me to just allow this French thing to work its charms.

And now I remember the croque madame I had at Clayton's Bistro a few months ago. - such crunching, oozing goodness. So I ask for that. It comes out golden and thick and with a little forest of mixed greens nicely oiled. And it has a subtle but luscious flavor of garlic behind the cheese and prosciutto. It's simple but oh-so filling. Stephen comes out to check on his sidewalk customers. He's an interesting guy. Somehow got to Dubai, reveled in the architecture there (his daddy's an architect), and works mainly to get funds to do more travel. Even in this age.

Next time, I'm going for a moules frites breakfast, if I have \$18 to splurge. Love moules frites.

Sun's snaking along Hawthorn when I get up to leave. It's going to be a hot one, but this has been cool.

If you prefer contact-free pick up with your gluten-free baked goods, order through the website two days in advance for curbside pickup. Choices include packaged boxes for \$20-24, each with

vegan and dairy-free options). Breakfast boxes include two each cinnamon rolls, muffins, and coffee cakes; bread boxes include half-loaves and bagels; dessert boxes net you assorted pastries, including that lava cake.



#### After a weekend of unrest. lunch at El Chingon

El Chingon Bad Ass Mexican; 560 Fifth Avenue, Downtown San Diego. At a nearby table, a group of young women are discussing the weekend protests, which saw thousands of San Diegans demonstrate against police brutality. Primarily they express concern the message of peaceful protestors could be drowned out by the opportunistic destruction of those who only showed up to loot. The four women work in Gaslamp restaurants, but their jobs didn't bring them down here today, El Chingon re-opens following a weekend of civil disquiet. and neither did this

lunch at El Chingon. They came downtown this Monday morning to help the cleanup effort that followed a tumultuous Sunday night.

As I drove into the city center, signs of yesterday's unrest were everywhere. Several blocks of Broadway were closed to traffic as police officers barricaded San Diego Police headquarters. Several retail storefronts exhibited broken glass; more had their windows covered with plywood - some since preemptively.



Other businesses worked to get their own plywood barriers up ahead of sundown. I chose El Chingon for



After the weekend protests, police barricade the blocks around San Diego Police Headquarters.

But the plywood was down by time the Mexican restaurant opened for lunch, and from the outside things appeared relatively normal. But then, before I could enter, wearing a mask, my temperature was taken and my hands sprayed with hand sanitizer.

Oh yeah. We're still in the midst of a pandemic. It's tough to reconcile so many different, urgent matters taking place simultaneously. Some of the boarded-up downtown businesses have been that way since the shutdown started in March, and as their ranks grow, the prevalence of plywood recalls many a dystopian sci-fi film.

Even for this food writer, it's tough to think about food at a time like this. Following the highly publicized riots, looting, and arson that took place in La Mesa Saturday night — in La Mesa! — a number of downtown businesses chose to close shop as protestors swelled in number downtown on Sunday afternoon, and especially after police deployed tear gas and flash grenades in efforts to disperse them.


El Chingon was open Sunday, but from what I gather, it closed by 4:30 pm. Service staff helped board up the windows, and security staff stayed on to monitor the property.

It's especially tough to reconcile a place like El Chingon with these confounding times. The place is built around colorful depictions of Mexican culture: it makes playful use of Día de los Muertos décor, pumps lively music through its loudspeakers, and specializes in agave spirit cocktails. More than anything, it's a fun place, designed for fun and celebration.

Now, thick plastic sheets form ad hoc barriers between booths to prevent the spread of coronavirus. TVs tuned to news coverage display images of both protestors and looters taking to the streets of American cities large and small.

The city is relatively calm this Monday lunchtime, and El Chingon still has a full menu to peruse, including take-out family meals of enchiladas, fajitas, and (thanks to sister restaurant Havana 1920), the classic Caribbean dish *ropa vieja*. For dine in, I'm at leisure to enjoy a \$14 taco plate. For my three tacos I chose Bajastyle fried fish, al pastor, and carne asada wrapped in fried cheese.

I can't imagine what the universe has planned next for the struggling restaurant industry, but I hope it's something great for a change. Because even though it feels like the world is falling apart around us, the next day these good folk of the restaurant industry are getting up, cleaning up, and continuing to provide welcoming spaces. *by Ian Anderson*

"We got lucky right off the bat as far as playing shows. We honestly thought we would just play house

parties," says singer Brian Clinebell, whose band The Kabbs was about to celebrate a decade of local gigging when the pandemic shutdown happened. "Our friend Tyrone Taylor introduced us to touring bands that would stay at his place, like Jay Reatard or NoBunny, so it was pretty cool hanging with these guys. Ryan Rousseau from Destruction Unit asked us to play with them at the Ken Club after we did a little house party. I think the scene was really good back in the day, a lot of bands hung out at the same

spots so everyone kind of knew each other. I think that helped us open for a lot of bands in town, and touring ones as well." Clinebell notes

that things were already getting more cutthroat before the live gigs stopped. "The scene was a competitive one, trying to put together a good show or get on a bill with some up-and-coming touring bands. It felt like a lot of us were all trying to

jump on the same shows." The Kabbs spent around a year working on their

new self-titled full-length, recorded with Mike Kamoo at Earthling Studios and mastered by Rafter Roberts. Featuring a lineup of Clinebell, guitarist-singer Ryan Combs (Oh, Spirit),

bassist-guitarist Kyle Whatley (Tropicle Popsicle), and drummer Tyler Ward (Oh, Spirit and Exfriends), the first single is called "Something to Lose." Says Clinebell, "The lyrics probably have the feel of breaking up with a girlfriend, or maybe the start of a relationship and blowing it at the start of something good. DCALS

Founded in 2017 and calling themselves homo riot hardcore punks, the Gay Agenda features David Hurtt (Stalins of Sound), Luis Soraire (who played bass with Temblad before switching to drums), Matt Penning, and Garrett Ficacci. The band was the brainchild of Hurtt, who wanted to create heavy punk music in an openly and unapologetically queer vein. Following up on their self-titled 2018 EP, which blends punk and metal into a queercore cacophony, their new full-length Penetrating is due June 5 via La Escalera Records. Recorded entirely live in one take, the album was mixed and mastered by Ed Talorda, with cited influences including Limpwrist, the HIRS Collective, Napalm Death, Tragedy, and Disrupt. The lead single now available, "Homo Riot," features Justin Pearson of The Locust, Retox. and Dead Cross. A vinyl version of the album includes a bonus track, a cover of Bjork's 1995 anthem "Army of Me," best known from the Tank Girl film soundtrack.



#### EVENING'S EMPIRE

"We're bouncing souls who found each other on Craigslist and spent the last two years in a cocoon turning into what you see now," says Evening's Empire singer-guitarist-keyboardist Sam Strohbehn. "Everything is new for us. We have new singles, a new album, a new website and social media, and new merch. The world is new. The timing is crazy, but what are you going to do?" The alternative rock band includes Rock 'n' Roll San Diego honcho Shannon Woods, aka Shannon Sabin of the reformed Dinettes, and bassist-singer David Skolnik. In advance of their debut album Alive

The cover art is a piece called 'Nostalgia,' made by an artist called Frank Moth that spoke to us. It's kind of a glimpse at recapturing the brighter future we used to all think lay ahead."



#### WAYNE RIKER

As a member of the Guitar Institute, Wayne Riker has cohosted workshops around the world with A-list jazz and blues cats such as Larry Carlton, Robben Ford, Marty Friedman, Dave Grissom, and Duke Robillard. Known for his Quick Licks column in Guitar Player magazine, he's also taken to telling stories between (and during) his instrumental performances, such as the time he met Jimi Hendrix cohort Randy California of Spirit, or how he was just about the only white guy at an intimate Hendrix concert, or the story behind how he almost went to Woodstock in 1969 but instead ended up at a jazz fest featuring a brand-new group calling themselves Led Zeppelin. His 12th CD, R&B Thunder, was recorded at Studio West and released last year, and features six local soul vocalists singing individual featured tracks. His Wayne Riker Gathering is recording a follow-up album due this summer, Blues Lightning, featuring guest vocals from Lauren Leigh Martin, Michele Lundeen, Leonard Patton, Shelle Blue, Scott Mathiasen, and Deanna Haala.

Based in Mission Beach, Timothy H has been a member of Mix Mob and the Dub Saints. "I've always liked the house beats out of Chicago," he says, "but there is something about this place [San Diego] that makes for a real positive and laid back sound." Citing influences such as Sublime, Run D.M.C, Chicago House Music, Bob Marley, Pearl Jam, and Pennywise, his debut solo full-length Loved Or Hated But Never Ignored was

released in 2012, with its first single "It's A Good Day." "When people say this is totally San Diego-style music, I take that as a huge compliment. This place has been my muse for this album, and that's great people can hear that." His 2017 single "Remedy" featured guest players from local stars PO.D. and Slightly Stoopid. A new reggae/rock/pop single, "Three Waves Crashing," dropped May 29 on all digital outlets.



#### THE NEW REGIME

Before becoming known for playing with NIN, Angels & Airwaves, Paramore, Beck, and M83, Ilan Rubin started his music career while still in grade school. He was 11 when he performed at Woodstock 1999 with local band Freak of Nature (aka FoN), which appeared on several Vans Warped tours, the same year that Modern Drummer declared him "Best Undiscovered Drummer Under the Age of 18." After a tour overseas with Welsh rock act Lostprophets, and still not quite of legal drinking age, he became the drummer for Nine Inch Nails. Rubin released a solo album in 2008, Coup, recorded under the band name the New Regime, a moniker he kept for a 2011 album, Speak Through the White Noise, entirely written, sung, and played by Rubin. Part one of his new four part EP series called Heart, Mind, Body, & Soul, was released in October 2019, with all four volumes now available. The backdrop of the new lyric video for "It's Gonna Be OK" was filmed on the streets of a desolate New York City during the COVID-19 lockdown.

I wish I could find the wherewithal to be a fan of classical music in the age of streaming. For a while, I watched out of obligation. That turned to watching out of guilt, and after the umpteenth youth orchestra performing 90 seconds of Beethoven that I've "gotta hear," I finally admitted the truth. I just don't enjoy it, at all. I'd rather look at an actual stream than another classical live stream.

I understand the importance of streaming classical music for organizations that need to stay in front of their audiences. I understand why a youth orchestra puts together a play-along. I also understand why they are short. It's a lot to coordinate. But though I understand it, I still don't like it.

What other options are there? For youth orchestras, there are none. For everything else, there are a bazillion options. Why would I listen to the much publicized live-stream of Yo-Yo Ma playing the Bach *Cello Suites* when I can already hear him play them on any one of his three recordings, or when I can watch the well produced 2015 BBC Proms edition?

The production values are the number one factor in my disregard of streaming music. They vary dramatically.

I must admit that there are a few I've come across who are doing it quite well. Frequent San Diego violin soloist Augustin Hadelich has produced some fantastic videos of himself on both violin and piano. But obviously, those aren't live streamed as he can't play both at the same time.

Another I've enjoyed is frequent San Diego Opera artist Stephen Powell. A baritone by profession, Stephen has created some great videos of himself singing the tenor repertoire with a wink and a smile. I love this type of thing.

Yo-Yo Ma playing Bach, again is okay, but an operatic baritone masquerading as a tenor is golden. However, most of the other opera streams I've witnessed have been boring. I've given up on the free Metropolitan Opera streams altogether. (Guess I'll probably never pay to see


I don't like any of them enough compared to the greatest voices of all time.

## **Blue collar blues**

t the same time many Americans are clamoring to get back to work, here comes a film about a man who refuses to be ousted from his job. Work gives us purpose; our jobs help to define who we are. What happens when an employee doesn't know the meaning of the word quit? Such is the plight of the inconspicuous toiler reluctantly made the center of attention in Working Man.

After decades at a routine job for a Rust Belt plastics company,

our titular laborer learns that his home away from home is shuttering. But that doesn't stop him from clocking in. Allery (Peter Gerety) is drawn to the plant, just as a George Romero zombie, back from the dead, might instinctively skedaddle to the shopping mall - it's a place that played an important role in their life. Neighboring co-workers look on in amazement as Allery makes

his daily trudge through their small town, lunchbox in hand, to the manufactory. Even after the power is cut off, Allery refuses to stand lost in the foundry. With nothing to manufacture, he whiles away the days polishing the machine shop.

Deep in denial but pressed for an explanation, Allery tells his wife Iola (Talia Shire), "It's just something I need to do." It's been years since their son committed suicide, and their marriage has yet to recover. There is no anger between the two, just seared silence. Self-sufficient Allery's lunch consists of 4 rings of braunschweiger palm-pressed between two slices of white, a thermos of coffee, and a powdered donut for dessert. Even though we don't meet up with him until late in his life, it's a safe bet that Allery's routine hasn't altered in ages — at the very least, since his son died. After nine months working alongside Allery, Walter (Billy Brown) swears he's never heard him speak. But past events in Walter's life help him feel sympathy and respect for his shell-shocked co-worker. Rather than allow the locals to judge him, Walter turns Allery into the factory idol. With several outstanding orders to fulfill, Walter - banking on the plant reopening after news trucks in the parking lot turn them into social media sensations - encourages his coworkers to return to their jobs, if only on a temporary basis. He also credits the decision to an unwitting Allery.

Iola's transition from shock and disbelief to cheerleading wife is subtlety personified. Shire is still playing Adrian Balboa, only now she's married to a different kind of fighter. Character actor Peter Gerety has 51 television shows and 45 features to his credit. Several of his movies have a permanent spot in my DVD cellar (The Curse of the Jade Scorpion, Changeling, Paul Blart: Mall Cop). The face seemed familiar, but without the help of IMDB, I was at a loss to name one. He's a chameleonic descendant of the royal families of Charles Durning or Kenneth McMillan, a

Films about passive heroes have a soft spot in my heart; how difficult must it be to make a non-entity compelling? Not a patch on The Last Emperor, Vera Drake, or Eternal Sunshine of the Spotless Mind, first-time director Robert Jury's Working Man finds suspense amidst the humdrum, and love among the rubble of a marriage put on hold.  $\star \star \star$

**The Lovebirds** — "Documentaries are TV shows that no one watches," Leilani (Issa Rae) fires back at her husband Jibran (Kumail Nanjiani), a documentarian who fancies himself a "social activist." No sooner does the couple decide to cancel their four-year relationship than they're witnesses to murder. That leaves the filmmakers with two mysteries to solve: whodunit, and how to reconcile the busted romance? The script calls for Leilani and Jibran to bicker incessantly, leaving director Max Showalter incapable of generating the illogical universe needed to make his unreasonable characters ring true. Prevailing pop-culture references supplant conversation - we interrupt our frantic dinner patter for a mood-shattering riff on the depth of metal milkshake cups. The poise, potency, and believableness that Issa Rae brought to The Photograph are nowhere in sight. Leilani's a non-stop panic attack, while Nanjiani's Jibran desperately whines over her dialogue. I wanted to enjoy my time spent with these characters, but Showalter never gave me the chance. 2020.  $-S.M. \star$ 

**Survive the Night** — It's Of Mice and Men meets Desperate Hours when a pair of thickheaded criminals on the lam take refuge in the home of negligent sawbones Rich (Chad Michael Murray) and his family. The main draw is Bruce Willis in a supporting role as Rich's competitive dad. It's not the worst of Willis (I missed Trauma Center, his previous pairing with director Matt Eskandari), but his performance couldn't be any less effective were he computer generated. How dumb does it get? "We're not here to hurt anyone," Mathias (Jon Olson) informs his hostages just moments after Jamie (Shea Buckner), his trigger-happy brother, takes out a member of the family. And with a yawning hole in his leg, Mathias elects to wait until sunrise to search the grounds for the doc to finish stitching him up. 



### news of the WeiRD

- Some sports teams eager to return to the field have taken to placing cardboard figures of fans in stadium seats to enhance the experience for viewers, but the FC Seoul soccer club in South Korea was forced to apologize May 18 after propping up sex dolls in the seats for its match against Gwangju FC, The New York Times reported. "We had tried to add some fun in the no-spectator match," the club explained. "But we have not checked all the details, and that is clearly our fault." "Details" included the buxom physiques and obvious logos of sex toy marketers on the dolls' clothing that fans watching quickly noticed. "We had confirmed that although the mannequins were made to look just like real people, they had nothing to do with adult products," the statement said, but the club admitted it had neglected to do a background check of the supplier, which makes sex dolls.

 Dinner at the renowned three-Michelin-star Inn at Little Washington in Virginia can set diners back a pretty penny -- unless they're not eating. When the Inn opens on May 29, some of its patrons will be mannequins, reported the Associated Press, attired in fancy 1940s clothing and placed strategically at tables to help with social distancing. "We're all craving to gather and see other people right now," said Patrick O'Connell, the Inn's proprietor and chef. "They don't all necessarily need to be real people."

#### **Rebellion Served Cold**

- An unnamed ice cream shop in Hong Kong is offering tear gas-flavored ice cream in support of the region's pro-democracy movement, reports the Associated Press. The shop's owner explained he wanted "to make a flavor that reminds people that they still have to persist in the protest movement and don't lose their passion." "It tastes like tear gas," said customer Anita Wong. "It feels difficult to breathe at first, and it's really pungent and irritating. It makes me want to drink a lot of water immediately." The owner tried several different combinations to achieve the flavor and found that black pepper came the closest. Before coronavirus restrictions, he said the store was selling 20 to 30 scoops per day.

#### Why Not?

- In Japan, people are enlisting the help of a long-forgotten mythical creature believed to ward off plagues in their battle against the coronavirus. Amabie, a mermaid-like being, first appeared in Japanese folklore in 1846, when she was reported to have appeared to a government official and predicted a rich harvest and a pandemic. She told the man the pandemic could be thwarted by drawing her likeness and sharing it with as many people as possible, BBC reported on April 23. Now, images of the spirit are appearing over five continents, and in Japan, face masks and hand sanitizer with her image are popular. One long-haul driver painted her on the side of his truck, saying, "I travel all over the country with my (goods) and Amabie to pray for the disease to go away." Even the country's Ministry of Health, Labor and Welfare has joined in, tweeting an image of Amabie and encouraging people to "prevent the spread of the virus.'

#### **Going the Extra Mile**

 A nurse in the western Russian city of Tula has been disciplined for "noncompliance with the requirements for medical clothing' after photos appeared on social media of her wearing only a bra and panties under transparent PPE on a COVID-19 men-only ward. The unnamed nurse told her superiors at the Tula Regional Clinical Hospital that wearing clothing under the PPE was "too hot" and that she didn't realize the protective gear was see-through. The Scottish Sun reported on May 20 that patients didn't seem to mind, though one admitted there was "some embarrassment.'

#### Oops

 On May 15, staff at a Hamilton, Ontario, retirement home transferred all of its residents to a hospital because of an outbreak of COVID-19. That is, except for one. The following evening, after repeated alerts from the man's family, he was discovered in his room at the Rosslyn Retirement Residence by a security officer who had been dispatched to look for him. He was "alert" and was subsequently transferred to the hospital, the CBC reported. "This was clearly not something anybody would have intended to do," and the lack of a master list of residents contributed to the snafu, said Winnie Doyle, executive vice president of clinical operations at the hospital

where most of the residents were sent. "This was ... extremely distressing."

#### **Just Funny**

- University of Arizona wildlife biology professor Michael Bogan caught Saturday morning cartoons as they came to life in a video he recorded of a coyote chasing a roadrunner May 9 in downtown Tucson. Bogan could be heard on his recording saying, "There is literally a coyote chasing a roadrunner. I can't believe it. That is a straight-up cartoon." The reenactment of the classic setup between Wile E. Coyote and the Roadrunner caught Bogan's attention near the Santa Cruz River, Fox News reported. And, as life often imitates art, the real roadrunner escaped unharmed from the wily coyote.

#### Florida

- A Mother's Day bouquet became a weapon during an altercation in Pinellas County, Florida, early on May 11. Sandra Kay Webb, 32, allegedly became angry with her husband because he bought flowers for her children to give her for Mother's Day. The Smoking Gun reported that Webb threw the bouquet at her husband and hit him with it, then spit on him. Webb was charged with domestic battery; she admitted throwing the flowers, but denied the spitting.

continued from page 16 old Brandon Robinson on the ground next to his motorcycle, suffering from a gunshot wound. Robinson died later that evening from his wounds. According to police, "The preliminary investigation revealed Brandon was attending a birthday party in the park when an unknown suspect fired a gun, striking and killing Brandon."

Robinson had been sitting on his motorcycle, curbside on Jacaranda Drive near Pershing Drive.

The following spring, the murder victim's father, Larry Robinson, was interviewed by NBC news. He said Brandon, his youngest son, worked two jobs and most likely happened to be at the wrong place at the wrong time. "Was he the intended victim?" Robinson told News 7, "We didn't think so. Not at all. Not a little bit."

A police spokesman

agreed, saying, "There was an unrelated fight, and perhaps somebody pulled out a gun and fired a round, and Brandon was an unintended victim and struck with a stray round that was fired."

In 2016, San Diego County Crime Stoppers and the San Diego Police Department's Homicide Unit asked for the public's help to solve the then-seven-year-old case. Crime Stoppers offered a \$1000 reward, while the Governor's Office offered an additional \$50,000 for information that would lead to an arrest in the case.

Speaking to the media, Robinson's mother, Donna Jones-Robinson, held up a photo of Brandon and said, through tears, "He was a sweetheart, and he really didn't deserve what he got."

**3000 Park Boulevard** The northern gateway to Balboa Park is the appropriately named Park Boulevard. Just before the zoo parking lot, on the west side of the street, is an expansive lawn, studded with shade trees, that leads to the historic War Memorial Building, designed in 1950 by a gathering of prominent San Diego architects to honor veterans.

On December 12, 2016, around 2 am, police responded to a call and found 67-year-old Gregory Huster lying dead on the grass just off the road. He had suffered trauma to his body. Ten years later, San Diego Crime Stoppers offered a \$1000 reward for any information about the still-unsolved murder. According to a Crime Stoppers news release, "The preliminary investigation revealed that Huster may have been sleeping when he was attacked."

### **Chicano Park**

It lies beneath the Coronado Bridge, between National Avenue and Interstate 5 in Barrio Logan. Chicano Park is the pride of San Diego's Latino community. The park had been promised for years by transportation officials after they built Interstate 5 directly through the heart of Barrio Logan. Then, in 1970, it was learned the promise had been broken and the land would be used for a new California Highway Patrol station. Activists mounted a huge protest, forming a human chain around bulldozers. The decision was reversed and the park was built. Today, the seven-acre Chicano Park features more than 80 Chicano murals, as well as sculptures, gardens, picnic tables and playgrounds.

On July 2, 1988, at about 2:30 am, Rudolpho

"Nene" Rios was shot twice in the head while hanging around the park. He died two days later. The 20-year-old was a member of the Logan Red Steps gang, and his accused assailant, an 18-year-old member of the rival Lomas gang. The park, at the time, was in Red Steps territory. Rios was shot as he was standing with a Red Steps gang member nicknamed Dopey near the park's sandbox. The fatal blast came from a car. A suspect was identified, based on Dopey's description, but he was acquitted in a jury trial.

# Linda Vista

**Community Park** This is one of the city of San Diego's "community parks," a designation reserved for larger parks that measure at least 13 acres in size and serve a population of 25,000. Near the

entrance of the park is a barbecue pavilion; other features include a skate park, basketball, tennis, and badminton courts, a baseball diamond, and a recreation center that routinely hosts community events such as "Family Fun Fridays" or the Mexican Independence Day Fiesta. The 15-acre site was acquired in 1955 and the recreation center was built in 1960. Significant renovations were made in 1998. One Yelp reviewer, however, cautions, "The biggest negative of this park is the evening. With poor lighting and few walkways, it is not a place that can be enjoyed after the sun goes down."

On November 8, 2019, a 19-year-old man was gunned down near the basketball courts shortly before 5pm. Nam Nguyen was with friends at the park when they got into an argument with another group of young men.

In a statement, San Diego Police Homicide Lieutenant Martha Sainz said "a park staff member saw what was going on and told the groups he was going to call the police. Minutes later, the suspect pulled out a handgun and shot the victim. The suspect fled from the scene prior to police arriving." Nguyen was rushed to a nearby hospital, where he died.

### Kate O. Sessions Memorial Park

This park is nestled on the foothills of Mount Soledad, where La Jolla meets Pacific Beach, and affords visitors sweeping views of Mission Bay from the rolling green hillside. The park also features sports fields and a playground. The park is named after



Kate Sessions, a famous horticulturist known as the Mother of Balboa Park. In 1892, Sessions leased 30 acres of land in what was then known as City Park from the city of San Diego to grow her plants. She promised to plant 100 trees a year in the mostly barren park, as well as 300 trees a vear in other parts of San Diego. Most of the older trees still seen in Balboa Park — towering eucalyptus, cypress, pine, oak, and pepper trees — were planted by Sessions.

After her Balboa Park lease expired, Sessions moved her nursery operations, first to Mission Hills and then, in 1912, to the Mount Soledad foothills above Pacific Beach. In November 1957, 79 acres of city land east of the old Sessions nursery was dedicated as Kate O. Sessions Memorial Park.

On February 19, 1991,

brothers Robert and Vincent Garcia, 20 and 18, were driving along the park's Park Drive around 10 pm when they stopped after noticing they were being followed by a pickup truck. Steven McKinley, also 18, got out of the truck and started arguing with Robert Garcia over a small debt he believed he was owed. McKinley went back to his truck, pulled out a small-caliber pistol, and shot both men. Robert lay dead on the ground; Vincent, shot in the chest and abdomen, drove to a nearby fast-food restaurant and called police. McKinley fled in the truck, which was later found abandoned at Oliver Avenue and Strand Way. Police later arrested McKinley at his home on suspicion of homicide.

### Kelly Street

**Neighborhood Park** This Linda Vista park is a 17-acre city park in the western part of Linda Vista, surrounded on three sides by the Tecolote Canyon Natural Open Space Park. The park's stated size is deceiving, as most of its acreage runs into the open space. Only in the southeast, near Kelly Street, is there a circle of green lawn and a playground. Police have reported an uptick in gang activity, and a corresponding increase in violent crime, in the residential neighborhood near the park, which in 2019 saw three shooting incidents that left a 16-year-old boy dead and three others wounded.

The fatality occurred on May 23, when 16-yearold Carlos Valdovinos was gunned down in the park. According to newspaper reports, homicide detectives with the San Diego Police Department arrested Andy Chanh Phonsongkham, 20, in connection with the slaying. Phonsongkham was charged with murder and a special circumstance allegation that could result in the death penalty. According to court records, Phongsongkham is a member of an Asian street gang, while Valdovinos was an associate of a Latino gang.

Just a few weeks after Valdovinos was killed, a 20-year-old man and a 15-year-old boy were shot near a memorial for Valdovinos. And in August, a 19-year-old male was shot and wounded near the park.

### Lindbergh Neighborhood Park

It's a small park that butts against Interstate 805 just south of Balboa Avenue in Clairemont. The centerpiece is a playground set inside a large sandbox. On the other side of

a walkway that bisects the park are basketball courts. The park is frequented by local residents, many of them families with young kids. The large expanse of lawn is often the site of impromptu soccer games. "Safe park in a safe neighborhood," writes one *Local Guide* reviewer.

However, early on the morning of August 27, 2010, police officers responded to a report of gunfire in the park. They found a 15-year-old girl, Joanna Vargas, suffering from a single gunshot wound. Paramedics tried to revive her, but she died at the scene. Young Joanna's time of death: 1:36 am. According to a San Diego Police Department news release, a "preliminary investigation has revealed that Joanna and her female cousin went to the park with two males. As the group stood in the park, an unknown suspect

fired a round at them, striking Joanna. The surviving witnesses noticed a white SUV facing north in the 4100 block of Ashford Street at the time of the shooting. The vehicle drove away at normal speed and was last seen turning westbound on Balboa Avenue. Whether the SUV is related to the shooting is not known."

#### Southcrest Community Park

It's a welcome patch of green, studded with generous shade trees, in the blue-collar community of Southcrest, between Mountain View to the north and east, Shelltown to the south, and Barrio Logan to the west. At the center of the park is a recreation center with indoor and outdoor basketball courts, a weight room, and community meeting rooms. The Southcrest Civic Club built the original building and then donated it to the city of San Diego. Materials and labor were donated by local merchants, residents, and labor unions. The center was dedicated in 1950.

One Yelp reviewer noted, "There is a great hillside with some shade trees for picnic with great views over the city of San Diego. The time I visited, there were tens of families watching kids play baseball, and a few setting up tents and blow-up play slides/bouncy houses to have family/community gatherings."

But a critic lamented on Foursquare, "Too many loose dogs and homeless."

Shortly before midnight on Friday, February 7, 2020, an unknown assailant shot and killed a woman and wounded a man in Southcrest Com-

munity Park. The murder scene was between two trees towering over a concrete picnic table, near a homeless camp. Leah Michelle Horne, 19, and Adan Duque, 16, were shot by what witnesses described as two Latino men in their 20s, wearing dark clothing. Horne died from her injuries at a hospital, while Duque underwent emergency surgery and survived. Horne's death was spotlighted on the Facebook page of Dear Humans, which claims to be "the voice of murder victims worldwide." According to a GoFundMe campaign aimed at helping her dad pay for the cost of her memorial, "Leah was a young, passionate and beautiful woman at the tender age of 19. She was known by all as a firecracker with such an endearing love for her family and of her friends with so much heart. Leah

lost her life tragically and brutally to a senseless murder.... Her dad is struggling with not only the loss but now he's saddled with dealing with the financial aspect of laying her to rest."

### Libby Lake Park

A neighborhood park in northeast Oceanside, Libby Lake Park's signature feature is a manmade lake surrounded by a footpath. Neighborhood kids come here to feed the ducks and then burn off some energy on the playground. The lake is surrounded by lawns generously planted with shade trees, and in the evening, around sunset, the light bounces off the lake and creates some spectacular photo opportunities.

Looks can be deceiving. Libby Lake Park is one of the most dangerous parks in the county, situated in the heart of Latino gang territory and, based on Yelp reviews, a place you especially want to avoid after dark. "I live in the area so I know about this park and the violence...," wrote one Yelper. "I take my daughter to the playground during the daytime and I walk my dog. It sucks that I still get scared being around here, but I live across the street and it's a beautiful park to walk. I just don't stay late! It can get sketchy during the night."

Another reviewer, also on Yelp, wrote, "This park is notorious for gang activity. I had already been to this park a couple of times before finding out how much of a hotbed it appears to be for gang members and others to hang out in ... and had I known prior, I would never have brought my son here."

Libby Lake's negative reputation was reinforced by a pair of fatal gang-

related shootings in 2011 and 2013.

On the night of May 3, 2011, a teen couple was brutally gunned down while sitting on a hillside, looking out over the darkened lake. Police found the bodies of Sandra Salgado, 14, and 16-year-old Fernando Solana around 10:30 pm after being called to the scene by reports of gunfire. Relatives said the teens were boyfriend and girlfriend, with no gang ties.

Prosecutors later said four members of a predominantly black street gang went to the park to smoke marijuana. One of them, AL'C Bejaran, had a gun. He saw the pair sitting on the hillside and shot them. It was done in retaliation for an earlier attack on one of his fellow gangsters. Bejaran pleaded guilty to two counts of murder and was sentenced to life in prison without the possibility of parole.

Less than two years later, another deadly shooting took place at Libby Lake Park. On March 13, 2013, a hail of bullets claimed the lives of Edgar Sanchez Rios, 16, and Melanie Virgen, 13. Two other teens were injured. The attack came at 9 pm. The bodies of the two dead teens were found lying near a memorial for the victims of the earlier shooting.

In May 2016, two gang members, Martin Melendrez and Santo Diaz, were were charged with the murders, which prosecutors say were committed in retaliation for gang activity.

Melendrez pleaded guilty to murder and was sentenced to 40 years to life in prison without probation. Diaz pleaded guilty to voluntary manslaughter and was sentenced to 39 years in prison.
