Open and shut caseConfusion over essentials and indulgences as lockdown eases

"I don't think we'll be opening the bar until September or until there is a vaccine," says Dany, *aka* Drago, founder of Dragon Rojo Rockbar and a hospital worker by trade. "I keep the bar as my side gig, for the love of rock music. I worry about my employees, but health is my main concern. I get daily messages asking me when the bar will open. We won't until it's safe. All the other bars jumped the gun. They weren't counting on the enormous public backlash."

Dragon Rojo is one of the first bars near the entrance to Tijuana's "tolerance zone," Zona Norte. In all my years in Tijuana, I have never seen the 24-hour bars in the area closed. Early in the afternoon on March 25, I took a stroll in Zona Norte with my friend Juan, who works as a seasonal fisherman in Alaska. He flies frequently between his home state of Guanajuato and his job and his route takes him through Tijuana. Days before his arrival, I promised him that despite the virus, Tijuana was not going to shut down. The day he landed was the day the bars closed. Still, we went to investigate. The cops detained

us immediately after we turned the corner on Callejón Coahuila, a street famous for its sex workers who solicit customers from doorways and corners day and night. They asked us our reasons for being there, and said my friend Juan was "Poncho," a famous drug dealer in the area. We were released minutes after proving that he was not in fact Poncho. We walked around the area and noticed girls

offering their services while wearing both provocative clothes and protective facemasks. We did not find any bars open.

Seventy-nine days later, on June 12, Miguel Ángel Badiola, the secretary-general they said they were opening on Saturday, and suggested the bar across the street. The bouncer at YouRevolution bar told me there was a 50-peso (about \$2.50) cover charge to enter the empty bar. I refused and went home.

of the restaurant association, announced that restaurants could re-open, as long as they adhered to the safe-distance rules. Businesses rushed to open their doors, even bars and strip clubs, since food was served inside the clubs. Bouncers at the door wore protective plastic faceguards, squirted sanitizing

gel in the hands of patrons, checked temperatures, and made sure people kept six feet apart while waiting in line. But once inside the club, the safe-distance guidelines were nowhere to be found.

On re-opening day, I went to Norte Brewery to enjoy the sunset and a pint of craft beer. At the entrance, they checked my temperature and my vitals, and gave me sanitizing gel. All the beertenders wore plastic faceguards, cloth masks, and plastic gloves. There were only five tables available, and

there was no seating at the bar. Employees sanitized and wiped the tables and chairs as soon as a patron left. After Norte, I headed down to Dandy del Sur, a cantina on Calle Sexta. The security guard told me they were at capacity and didn't let me in. He did, however, let me go into the bathroom. The bar was at around a third of its usual capacity. I tried to go to the bar El Copeo nearby, but

On Saturday, El Copeo had a long line around the corner and Dandy del Sur had double the number of people it had on Friday. After a public backlash, the governor of Baja, Jaime Bonilla, said that bars were not authorized to open and called on citizens to report the ones that did. By Sunday, all the bars and strip clubs were shut down again. Breweries and restaurants remained open with safe distance guidelines in place.

Essential businesses are ill-defined. Barbershops, nail salons, shoe shiners, maquilas (factories), and many others remained open during the quarantine. Schools, parks, beaches, and other public spaces remained closed. Parque Teniente Guerrero, downtown Tijuana's park, was closed to the public; yellow tape was placed at the entrances. Police were sent to kick people out of the park, including the many homeless who spent the night there. Minutes after being kicked out, they returned. Hotel Cascadas, the hotel above the strip clubs, never closed. Internet reports indicated that the penthouse bar never stopped serving, and that you could find sex workers. Hotel Ticuan also stayed open during quarantine, and their restaurant remained operational.

The border has been shut down for tourists since the beginning of the quarantine. The opening date for tourists keeps getting extended with the latest announcement setting the reopening to July 21. As a dual

citizen, I've crossed the border a handful of times during quarantine. Border lanes have been heavily reduced. At the beginning of the quarantine, the waiting time to cross was minimal. As the days went by, more people started crossing again, yet the U.S. border patrol did not open any more lanes, making border waits chaotic as usual. The Mexican border patrol did not stop me on my way back.

Fishermen plead: clear the pier

But surfers and diners keep creeping in

"If you want to fish, you have to be west of the checkered flag," blared a voice from the PA speaker above us. "There's also no fishing on the south side of the [Imperial Beach] Pier at this time."

"There's nobody even surfing down there," yelled back fisherman Nick Cline. "Not even swimmers. And now we are not allowed to fish on the south side?"

"Oh no, he's yelling at the lifeguard," said Dell.

"Look at the dogs on the pier and this bicycle," continued Leonard, Dell's husband. "Nobody says anything to the dog owners and bicycle riders."

Cline, Dell, and Leonard have been fishing on the wooden-planked Imperial Beach Pier for years, until it was closed on March 17 to minimize the spread of COVID-19. I spoke to the three — and others on and around the pier — on June 13, four days after it reopened to the public. "They talk to you over the loudspeaker and tell you to move past the no-fishing zone, where the surfers are down below," Cline told me. "The surfers are not even supposed to be within 20 feet of the pier, yet we can't fish there." A "No Fishing in the

Time's up for overtime

Campus cop cost criticized

Does the growing budget of UCSD's campus police department need a closer look? A new university audit has called out officials for failing to monitor employee overtime costs adequately. The report's findings coincide with a national movement questioning the costs and practices of campus law enforcement in the wake of the death of George Floyd at the hands of Minneapolis police. At the University of Chicago, a June 12 student sit-in included calls for full budget transparency, a 50 percent expense cut, and the eventual elimination of the campus police force altogether. In San Diego, the payroll costs of policing UCSD jumped 6.4 percent between 2018 and 2019, with a staff count of 94 - including 38 police officers - bumping the total to \$8.6 million, according to the audit, released March 25. Overtime expenses fell by 3.2 percent during the period, but that was likely due to a hike in department staff numbers, the report says, adding that reining in payroll abuse calls for new enforcement measures.

Despite the overtime drop, auditors faulted the school for failing to adequately track the

practice, risking "excess payroll costs, which may have a negative financial impact on the Department and the University." "Documentation of Overtime and over-schedules were not consistently maintained for Department management pre-approval as required by policy and collective bargaining agreements," the audit

found. Making matters worse, the document says, "Some overtime purposes were not documented in the timesheet system to justify business necessity." Auditors say they found that "some employees routinely worked a high number of overtime hours almost each pay period. Most of these overtime hours were not fully documented and/or pre-approved. Our analysis noted that six employees' overtime represented 29% of total overtime hours and 32% of gross overtime pay. Further review of the six employees with the highest amount of overtime disclosed that the employees had more than 750 hours of overtime coupled with a high frequency of overtime hours for a majority of the pay periods. For instance, out of 26 biweekly pay periods, these six employees had 17 to 25 pay periods in which they averaged between 35 hours to 70 hours of overtime a week."

The failure of university officials to police such potentially suspicious activity, per the findings, "may lead to abuse of overtime and unplanned payroll costs."

In response to the findings, "Management stated that some of the overtime was

More Moores wheels and

deals Who will be the lucky bidder to turn the run-down, city-owned San Diego Sports Arena and dilapidated environs into a glitzy and lucrative forest of new high-rises? Judging by a flurry of reports emanating from city hall, the public will be the last to know. "Four developers last week submitted detailed plans for how they each envision transforming the area and replacing the 54-year-old arena with a modern version," says a June 17 Union-Tribune

account. But details, including the identities of the principals, remain top secret. "City officials are declining to reveal the names of the developers or the proposals they submitted until next month." Offers the paper: "That is standard practice when the city issues requests for proposals, which require developers to submit sensitive and proprietary information about their finances."

Whether or not that's true. some hints have already shown up in disclosure statements filed by two of the city's most influential and controversial lobbying firms. California Strategies & Advocacy, LLC reported in a May 30 filing that it's working for H&S Ventures regarding "improvement of Pechanga Arena/ Sports Arena San Diego located at 3500 Sports Arena Blvd., or entitlement of a facility in the San Diego region to host the San Diego Gulls, an American Hockey League team."

As noted here last August, H&S is one of the many holding companies for Orange County billionaire Henry Samueli, owner of the Anaheim Ducks, along with the San Diego franchise. At the time, the *U-T* reported that H&S,

operating as Anaheim Arena Management, had the inside track to take over the sports arena lease this May. "From the outset of this process, our goal was to improve the experience for the arena's users and guests, enhance the volume and quality of programming and increase revenue for San Diego taxpayers,"


Tim Ryan, chief executive of Anaheim Arena Management, was quoted as saying,

"We are excited that the selection panel agreed with this vision and selected our bid." But the murky deal somehow evaporated behind the closed doors of city hall without further explanation to the public.

H&S rival AEG Management, the incumbent operator of the venue, is also believed to be interested in some kind of development arrangement. The L.A-based outfit, owned by Denver billionaire Phil Anschutz, is using lobbyist Southwest Strategies, like California Strategies a heavy-giver to city politicos, to persuade the mayor and council to grant a "short term lease extension for the Sports Arena facility," according to an April 4 filing covering the first three months of this year. Southwest picked up a \$9000 fee from AEG for its trouble, per the document. Last year alone, Southwest chief Chris Wahl kicked in \$1125 to city council Democrat Barbara Bry, running for mayor against Assembly Democrat Todd Gloria, who got \$2300 from Wahl. Republican council-

man **Scott Sherman** picked up \$1150 for his ultimately failed mayoral campaign. City Attorney Mara Elliott got the same for her 2020 reelection bid. Public release of the names of sports arena hopefuls by GOP mayor Kevin Faulconer is not expected until July, giving the would-be developers and their lobbyists time for more closeddoor maneuvering.

Even though the university employs thousands of people, and has students measured in the tens of thousands, the count of police personnel sounds high. Why? UCSD likely will need more cops as its imminent expansion plan calls for a mammoth cluster of high-rise buildings – from nine to 21 stories - to be constructed at the farthest western edge of its campus bordering residential neighborhoods of La Jolla. Surf Zone" sign stood nearby. It read, "To prevent swimmers, waders and surfers from accidentally becoming entangled and possibly hooked when fishing lines are cast or dropped within the surf zone, fishing is not allowed within the surf zone when recreational swimmers, waders and surfers are in the ocean closer than 150 feet of the pier."

"What happens if you continue fishing?" I asked Cline.

"They'll either drive their lifeguard truck up, or they will call the police if you refuse to do what they tell you, and you can get a ticket or get arrested."

Leonard and his wife Dell recounted a time when their buddy Bill was fishing within the surf zone after it was implemented on the pier "about five years ago. Bill fished in his wheelchair," Leonard said. "He would put his

poles on this side, and surfers would come up here and grab his lines and pull his poles [away]. The surfer-versus-fisherman thing has been going on here for five years. It all started

when they took down the signs that read something like, 'No coming within 100 and a half feet' on both sides of the pier. And look at the surfers shoot underneath the pier. The signs were meant for the surfers to stay away from the pier so they wouldn't make contact with the fishermen."

Fonzie was fishing close by. "This is the only pier where they allow the surfers to be close to the pier,"

he said. "In OB and Oceanside, they get citations for surfing that close — and here, the lifeguards won't cite them." I asked a couple surfers if they knew about the alleged conflicts, and they said "no" or "no comment." Many Yelpers who left five-star reviews for the pier

were stoked to watch the surfers and boogie boarders down below. Others mentioned the Tin Fish restaurant at the end of the 1491-foot pier. When the pier and the restaurant reopened, Cline was disappointed to learn that he and his buddies were no longer allowed to fish at the end of the pier, on the north side of the restaurant. Three wooden picnic tables had been added there during the pier's near three-month shutdown. "When you shut off the whole backend of the pier to us, that closes [access to] all the big fish, because they won't swim into the shallow water," Cline said.

Ed Kim, the owner of the restaurant, disagreed. "The first Tuesday when we re-opened was not a good fishing day," Kim said. "If they are not catching anything there on the side of the pier, they are not going to catch anything out on the end of the pier. But yesterday, they caught a shark right there on the side, and it's pretty much evenly spread out. A lot of the fishermen liked to lounge out there on a beach chair on the end of the pier, and it's more of their zone and I kind of get that — I used to deep-sea fish, and it's fun. [The fishermen and fisherwomen] are good customers that come in for beer and things like that."

Cline says he fishes at the pier daily, and he's a patron at Kim's restaurant. "My suggestion to them is if they want to put more

seating in, they have all of this excellent foundation underneath the old boat launch area and that's not being accessed. This whole area on the south side of the restaurant is closed. Why don't they build the seating area or more restaurant there, and allow us to fish on the end of the pier? Every day, the bottom half is closed to us for the surfers, which is where all the perch and corvina are. The county, or city of IB and Port of San Diego, or whoever is in charge of this area needs to remove the tables [north of] Tin Fish and allow us to fish there again. They keep restricting our fishing more and more, and it is not fair. I'm begging you to please remove the tables."

"On the flip side of that," Kim responded, "many patrons or citizens of IB also have a voice, and used to say, 'Why can't we sit there and enjoy the sunset? It's all being occupied by the fishermen."

New No Drone zones But without buzz fuzz, how to

enforce prohibitions?

A new ordinance regulating the use of drones in Del Mar will take effect on June 17. The rules will "add to guidelines set by the FAA," a city report says. While the Federal Aviation Authority regulates and sets guidelines for drones, local governments can control some aspects. However, the areas available for local regulation are limited.

Poway restricts drone usage during emergencies. Chula Vista has limits on police and fire department use of drones, related to privacy or harassment. San Diego prohibits reckless flying. Oceanside and Carlsbad rely on federal standards. But Del Mar takes it a step further. "I'm very pleased to see Del Mar getting out in front of this issue, and getting some rules on the books before we have conflicts and clashes," said council member Dwight Worden last month when the ordinance was introduced.

Clem Brown, Del Mar's environmental sustainability and special project manager, said the city will ban drones in some public areas "where we didn't want recreational hobbyists to operate." Curbing drone use in those locations has been a priority for the Parks & Recre-

ation committee, Brown said, citing safety and nuisance issues. "Those were our most heavily used parks, beaches and open space areas."

In Del Mar, drones are also used by the public for commercial film and photography, and those operators can still fly in the public space as long as they have the required credentials and city permit. City and public safety uses, which cover drone services

such as assessing environmental conditions, projects, traffic, and emergencies, are exempt. It's drone hobbyists who will lose ground because of the city's no-fly zones. Hobbyists can fly "anywhere not specifically prohibited in the public space" or on private property. That means no more recreational use in most city parks and facilities, to include Seagrove, Powerhouse, and Crest Ridge parks, as well as Scripps bluff preserve. Also off-limits are sections of the San Dieguito Lagoon River Park, over which Del Mar has jurisdiction. And no drones on city beaches. (One park that didn't land on the restricted list is the 5.3 acre Shores park.) But what about someone sitting at Seagrove park, wanting to send their drone out over the ocean? "They could launch from the beach and fly perpendicular out over the

ocean, but not up and down along the beach,"
Brown said.

Flying above the Del Mar Fairgrounds requires permission from fairground officials. And the bluffs overlap the North County transit corridor, where commercial or hobby flying is barred by transit district regulations. In addition to a 400-foot height limit, both recreational and commercial drone operators must register and mark their aircraft. Commercial operators will have to obtain a city permit, as well as a permit from the Federal Aviation Administration.

While the ordinance covers city public space, it doesn't tackle drones over homes. There, Federal law kicks in, even when operating a drone on private property. "The FAA

Honey starts at \$10. Choose the dark for flavor

Harbinson Canyon's sweet gold

To bee, or not to bee? That is the question in bucolic Harbison Canyon. I have just made an eye-popping discovery about the Canyon — sandwiched between east El Cjaon and Alpine — and it ain't some nudist colony's Open Day.

It's more about bee colonies.

Back in the day, it turns out, this was the world's #1 sweet spot for honey.

I was buying a \$10 jar of dark honey at this roadside stall, just where the Canyon starts tumbling east towards Alpine. While I was waiting for change, I looked up "Harbison Canyon" on my iPad, and came across this entry for "John Stewart Harbison."

"In the spring of 1874, [Harbison] moved

with his wife and daughter to a homestead near the Sweetwater River, 23 miles east of San Diego, in a little valley now known as Harbison Canyon. Within seven years' time, he was the largest producer of honey in the world, operating 2000 to 3000 hives."

Say what? "In the world?"

Carol Morrison, the archivist at the Alpine Historical Society, says Harbison's honey did indeed span the world.

"There's one story that I heard that Queen Victoria in England tasted some of Alpine's honey. I'm very proud of that fact."

She says that with the nearby Alpine area at a higher altitude, and Lakeside at a lower altitude, Harbison Canyon was in the sweet spot. "You have different plants growing in different altitudes. Sage, buckwheat, manzanita: bees can range for seven miles, so they have the opportunity to collect nectar from a variety of different plants."

John Harbison was the son of a beekeeper, born in Pennsylvania. He came out to California for the gold rush. "He discovered that he could make more money selling hives and bees than from gold," says Morrison.

His innovative spirit — he was always designing new hives — and knowledge of bees meshed perfectly with history. The transcontinental railroad link was secure, so he could easily export his honey to the east coast. And beyond. And speed isn't important with honey. It is pure sugar and doesn't need preservatives. They say it can last for centuries.

What did Harbison's honey taste like? "I

buy my honey from a man in Lakeside," says Morrison, "and his honey is much stronger-tasting. Store-bought honey is just sweet. This has a flavor like buckwheat. It takes a while to get used to it, but it's excellent. Put it in your oatmeal, throw in a handful of blueberries, and it's absolutely wonderful."

So what happened? How come Harbison bees aren't still honeymakers to the world?

Disease and pesticides, says Jaime Garza, from the County's Department of Agriculture. "They caused a 34 percent loss in managed bee colonies last

year. It's not catastrophic, just means more work raising queens for bee growers."

But mostly, you can probably blame the lemon growers, who invaded the area during the last century, for squeezing bees out.

Or are the honey moneymakers still buzzing discreetly around Harbison Canyon? According to Garza, we may never know, because it turns out beekeepers are cagey about the deals they do with landowners to set up their hives. They find places with the right sort of plants to feed their bees, to help the little buzzers create honey with the most vitamins and best flavors, and that becomes their closely-guarded secret.

"Go ask them," he says. Then he adds, "Good luck."

To be or not to be a cop

There's something haunting about this sidewalk's chalk portraits as they fade. Coronado student artists drew remarkable pictures on the concrete around the beachfront memorial for George Floyd, not far from the Hotel Del Coronado: the faces of African-Americans shot by police over the years.

"Say their names!" says the chalk sign beside them on the sidewalk. And the names are right here. Breonna Taylor. Sandra Bland. Tamir Rice. George Floyd. Philando Castile. People passing by talk quietly, as if they were mad. They're mad because they're like, 'Why is this still happening? It has been so many years since slavery ended. Why is it still happening?'"

"I have an uncle who is actually a cop, a sheriff," says Diego. "He believes that cops do get [trained] way too quickly. And there's not enough checks on wannabe cops. Like there definitely are people out there who are racist and who do abuse their authority when encountering an African-American. I don't know how this is going to come out with the country. Either it's going to change,

in a church. They can't avoid scuffing the faces that look up from the pavement. But nobody's doing it out of disrespect.

Carlos, who stops on his walk with his friend Maria, doesn't get it. "In our generation race just isn't an issue," he says. They stop to look at the faces. "She was 7 years old," says the sign beside a chalk portrait of Aiyana Jones, who was killed 9 years ago in a police raid gone wrong in Detroit, which resulted in no convictions.

A group of four friends pauses. Aaron, Jonathan, Michael, Diego Orozco, all around 20.

"I think police have too much power and authority," says Diego. "In other countries you have to go through multiple trainings. You have to train for years to become a cop. I think our cops should go through more training."

"Black Lives Matter," says the chalk art beneath their feet.

"We have family members who are also African-American," says Michael. "There's no barrier between races in our family."

"People have different attitudes depending on where they grew up," says Jonathan. "Like,

my dad's from Pennsylvania and my mom's from Mexico. My dad's family are white. At first they would not accept my mom completely. They didn't know any better. But over time, they started accepting her. We should just accept each other. That's what makes us better as humans, because right now, we're hurting. A lot of people are

or it's going to go worse than it already is. Right now, you have to choose a side. It's not the time to be in the middle."

"I don't know if I want to be a cop any more," says Jonathan. He is studying criminal justice at Southwestern College with a view to joining the thin blue line. "I mean, if all this is happening, and with police brutality, I don't want to be put into that group. I think there may be an attitude within the cop world that may be hard to change. I don't know if I want to be put into that situation every day, like having to use extra aggression. A lot of people are dropping out. I don't know if it's the coronavirus, but they're dropping out."



Just outside Amarillo, Texas, off Highway 40, is the Cadillac Ranch, a row of vintage Cadillacs stuck headfirst into the ground. The quirky roadside attraction was immortalized by Bruce Springsteen in the 1981 song of the same name.

On the main street in Mitchell, South Dakota is the Corn Palace, a Moorish Revival building decorated with murals

and designs made from corn and other grains.

BROWN - EZELL FOR D

A small marker off Highway 154 just south of Gibsland, Louisiana, marks the spot where outlaws Bonnie Parker and Clyde Barrow were shot to death by police on May 23, 1934.

Closer to home, there are the huge concrete-and-steel Cabazon Dinosaurs off the I-10 just before you get to Palm Springs, made famous in the film *Pee Wee's Big Adventure*.

The following is a list of 20 roadside attractions right here in San Diego County, ranging from the odd and unusual to the notorious. Most are privately owned and not open to the public, but all are clearly visible from the safety of your car.

Garden of the Beasts — Harper's Topiary Garden

3549 Union Street

MISSION HILLS

The hilly front slope in front of Alex and Edna Harper's home has for more than 25 years been a living sculpture garden. More than 50 bushes have been meticulously trained, trimmed and shaped to resemble animals, including elephants, monkeys, roosters, and

a whale. There's also a dinosaur, a pyramid, a surfer, and even the gardener who helps the couple create and design their work. New designs frequently appear as the Harpers continue to come up with new additions to what was originally a drab cluster of fast-growing cape honeysuckle plants.

The Red Sidewalks

Between 30th and 32nd Streets Redwood and Juniper Streets

BURLINGAME

This small community east of Balboa Park is known for its rose-colored sidewalks. They've been a hallmark of the community since development began in 1912. Back then, a dull red tint was added to the concrete for the sidewalks in order to give the tract a distinct look. The 40-acre site, originally known as "The

Tract of Character" and now a San Diego Historic District, includes more than 170 "uniquely and architecturally interesting homes," according to the city planning department. Drive around and you'll find an eclectic mix of homes built in the Craftsman, Mission Revival, Spanish Colonial Revival, Prairie School, Art Deco, and California Ranch styles.

Silence is Golden

Norma Drive

TALMADGE

This quiet residential street in the east San Diego community of Talmadge runs east of Fairmount Avenue and consists mostly of modest little cottages and bungalows, many of them restored or rebuilt. Homes on the west side back up to a canyon that slopes





down to Mission Valley. They look like homes in any other gentrified mid-city community, but there's a Hollywood connection. Talmadge was established in 1925 by Joe Shenick, president

Jehovah's Witness — Beth Sarim

KENSINGTON

Kensington is home to hundreds of classic Spanish-style houses, many of them backing up to lush canyons. But this elegant 10-bedroom home comes with a rich religious history. It was built in 1929 for the Watch Tower Bible and Tract Society, the parent organization of the Jehovah's Witnesses, as a winter home and executive office for Watch Tower president Joseph Franklin Rutherford.

The house was named Beth Sarim, Hebrew for "House of Princes," in anticipation of the resurrection of such Old Testament prophets as Abraham, Moses, David, and Isaiah, who were expected to be headquartered in San Diego instead of Jerusalem. The deed,

written by Rutherford, even states that the property should be held "perpetually in trust" for the Old Testament "princes," and was to be surrendered to them once they arrived.

Rutherford died in 1942. Abraham, Moses, and their fellow prophets never showed up, and in 1948 the home was sold to a private party.

Rotating Home

4903 Mount Helix Drive

LA MESA

The Rotating Home of Mount Helix is a pleasant surprise for those venturing up the drive to Mount Helix in the East County community of La Mesa. Perched high up on the northern slope is a circular home, with 5300 square feet of living space, that rotates through 360-degree views of the Coronado Bridge, downtown San Diego, the Pacific coastline north to La Jolla, and the Laguna Mountains.

Al Johnstone and wife Janet completed the home in 2004, spending three years and \$1 million to create what they describe on their web-

site as "an example of ... Kinetic Architecture... the only structure in the world, that we know of, that is a fully functional rotating structure with all the utilities in the rotating portion."

The second rotating floor rides on top of a stationary 50-foot-diameter first floor on 40 eight-inch bearings. It is driven by a 1.5 horsepower DC motor and makes one complete rotation in anywhere from 33 minutes to 24 hours. According to the couple's website, Al designed the house and found or built all the specialty parts required to make the house rotate. Neither Al nor Janet are engineers, so they hired several different engineers to verify and sign off on Al's work.

Giant Lemon

Broadway and Main Street LEMON GROVE

Most cities in San Diego County have artsy signs welcoming visitors to their burg. Lemon Grove has a giant lemon — a 3000-pound salute to the fruit that gave the East County city its name. Measuring about 10 feet long and six feet wide, the lemon — installed next to the trolley tracks — was

built as a parade float for the July 4, 1928 Fiesta de San Diego parade. Two years later, the lemon was plastered over to make it more or less permanent and christened as Lemon Grove's official welcome sign, sitting atop a concrete base engraved with the slogan, "Best Climate on Earth," which the town adopted back in 1925.

Japanese Friendship Bell

Shelter Island Drive

POINT LOMA

The 1.2-mile drive along the man-made Shelter Island peninsula offers splendid views across the bay to the downtown skyline. It's also home to an array of public art installations in what's officially known as Shoreline Park. But the most interesting sight just might be the huge bronze Japanese "friendship" bell at the very end of the drive, where the road loops back. The bell was donated by the city of Yokohama, the first of San Diego's 16 sister cities, in 1958. It was cast by artist Masahiko Katori, best known for the more than 100 bells he created for Buddhist temples throughout Japan. He

also cast the famous Hiroshima Peace Bell in September 1964. Katori died in 1988 at the age of 89.

OB'S HIPPIE HANGOUTS The Black

Ocean Beach Hostel

OCEAN BEACH

Ocean Beach was San Diego's answer to San Francisco's Haight-Ashbury in the 1967 Summer of Love, and just as in the city by the bay, the hippie culture has never really left.

The Black is a 1960sstyle "head shop" where you can still buy glass and ceramic pipes, incense, psychedelic art, and even Fabulous Furry Freak Brothers and other underground comics. The Black bills itself as a "smoke shop" and has an assortment of high-end cigars for sale. But don't be fooled, this place reeks of the 1960s, and we mean that in only the best way.

One block up Newport is the Ocean Beach Youth Hostel. It's painted in bright colors like something out of a Ken Kesey book. It was built in 1909, after the streetcar line to

Ocean Beach was constructed, and from 1914 until its conversion into a youth hostel flourished as the 20-room Newport Hotel. It now has 25 dormitory-style rooms that sleep four to six each.

The duplexes of Clairemont

Clairemont Drive and Clairemont

Mesa Boulevard

CLAIREMONT

The duplexes of Clairemont are a throwback to a different time. They're virtually unchanged from when they were first built in the middle 1950s along Clairemont Drive and Clairemont Mesa Boulevard. Stretching out for several blocks on both streets, they call to mind the classic folk song "Little Boxes," by Malvina Reynolds. The nondescript cottages, each with about 800

does tend to regulate this area very strictly," said deputy city attorney Loren Gilmore. And drones are still subject to existing privacy laws. But filing complaints with the city and enforcing the rules won't be easy. The ordinance could end up as an example of rules without teeth, said deputy mayor Terry Gaasterland. "Because there's pretty much no way to figure out who's flying it or where they are." Further, Gaasterland wondered if the city's restrictions might push drone users into the private areas. "If we're pushing them back from the bluffs and beaches and parks, we may be pushing them into the streets and backyards."



Fair's finances foul Former farm fest now cashcrunched carnival

Del Mar Fairgrounds executive director Tim Fennell has named COVID-19 as the key reason why his 160-employee district, now \$20 million in the red, could implode and leave the future of the Del Mar Fair and its 340-acre prime seaside property up in the air. The *Union-Tribune* ran two front-page articles in three weeks about the fragile financial state of the fairgrounds. The first was headlined, "Fairgrounds may close if no financial aid received." The latest, a June 16 article, claimed the floundering district is operating in "survival mode." Both cited the pandemic and declining interest in horse race wagering as the reasons why the state-run enterprise is upside down. For its part, the fair-

less fairgrounds set up its own website, urging denied fairgoers to say nice things about the fair to their elected officials. But some long-time elected officials — and an Orange County watchdog — say there is a systemic dysfunction that has torpedoed the Del Mar Fairgrounds: the 22nd District Agricultural Association.

Shortly after he asked the governor for a

over the years, the fair has morphed from a twoweek exposition celebrating local agriculture to a four week-long carnival. "It started decades ago when the county was much more agricultural. The mission of the fair board seems at opposite interests with the local community. It seems the whole mission has become to just bring in as much cash as possible. They've got all these full-time state employees with fullyloaded benefit packages." Though she is not currently in office, Lesa

Though she is not currently in office, Lesa Heebner was elected three times to the Solana

teleconferenced meeting of the Orange County Fair board on May 28, asking for a \$5 million emergency loan. Reggie Mundekis was in virtual attendance; she says she has attended every monthly meeting of the Orange County fair board since Governor Arnold Schwarzenegger suggested selling all of the state-owned fairgrounds in 2008. "The Del Mar Fair is fond of bragging how it is the largest fair in the state and the sixth largest in the country, so why would they be in financial problems?" asked Mundekis after Fennell's appeal for financial help. She noted how the Orange County board maintains a \$53 million surplus. "And we don't even have horse racing. How can Del Mar have no reserves? This all just doesn't make

sense." She said Fennell was not forthcoming

showing how beautiful Del Mar is and how beautiful the beach is. But they were giving absolutely no financial information. That's when the board said maybe it was not such a good idea to make this loan decision today. It made me think maybe there are things that are not being disclosed."

BBB-minus or "negative" rating. She says she tried to get other details on two other loans for \$18.5 million and \$15 million — that the district secured in 2018 to transform the Race Place wagering facility into a concert venue, but that that data was not provided to her or available on the fairground's website. "I told them, they have over 150 people on payroll who are doing nothing right now because the place is closed and they can't find these loan documents? These are things that should be kept in a file." While Mundekis admitted that she is not a concert-industry specialist, she asked, "How will they ever make that concert venue money back, especially now with the concert industry the way it is? The Orange County Fair doesn't have all these bonds and debt. This has a good opportunity to come crashing down unless they start making good decisions." Mundekis claims that a state audit of a Bakersfield fair board uncovered mis-uses including "state credit cards for lobster dinners" and "state employees working for private companies...They had to put in new procedures."

But "new procedures" would be an understatement for the Del Mar Fairgrounds, said former county supervisor Pam Slater-Price, who for 20 years oversaw the 3rd District that Beach city council. Regarding the fairgrounds' appeal for a \$5 million loan from the Orange County fair board and the \$20 million request from the state, she said, "The financial situation is embarrassing, especially when you compare it to the much smaller Orange County fair board's financial situation." She noted that when former board member Chula Vista attorney David Watson resigned from the fair board two months ago, he "saw the writing on the wall." (When he left, Watson was quoted as saying the district is facing "extreme financial turmoil.") "I don't think the governor is going to allow the allow fair to go away," said Heebner. "But the place is so beautiful, and so many different things could be happening there." She said that one of the reasons she is now running for mayor of Solana Beach is to make sure that locals who live near the fairgrounds get a greater say over how the fairgrounds impact the adjacent neighborhoods. "The fair traffic gets so bad that Highway 101, Stevens Avenue, and Via de la Valle are so clogged that at times you can't move for 45 minutes. People fill up on turkey legs and fried butter, and afterwards, have no appetite for dining or shopping in Solana Beach." Heebner said that in her



Online brouhaha leads to business increase at Chula Vista Brewery "Veteran-owned," notes an easy-

veteran-owned, notes an easy-to-miss sign on the Third Avenue storefront of **Chula Vista Brewery**. In fact, brewery cofounder Tim Parker retired from the Navy at the end of 2019, following two decades of service, during which the enlisted sailor successfully made the rank of chief petty officer.

Military retirement ceremonies tend to be celebratory occasions, typically highlighted by career photo retrospectives. That part proved a challenge for the camera-shy Parker. "Most people got all these pictures of themselves in uniform, but I'm like a ghost," he says with an easy laugh. "I've always been out of the spotlight. It's not really my nature to be in front of the cameras."

However, this has changed in recent months, as Parker has transitioned from being deployed at sea much of the time, to being a full-time presence at the brewery he launched with his wife, Dali, in 2017. He's become more visible in the brewery itself, but also on the brand's social channels and in the press. Media coverage has increased, in part because Chula Vista Brewery has become better known as an award-winning San Diego beer company. But also, lately, because Parker has emerged as a rarity in the craft beer industry: an African-American brewery owner.

"I think it's funny," he says, "Most people didn't realize until recently that it's a black-owned brewery. Most people didn't even realize that it was veteran-owned."

In the wake of the protests that continue to sweep the nation and the world, allies of the movement have put a spotlight on supporting black-owned businesses, even as the New York Times reports that such businesses are being disproportionately hurt by the covid-19 pandemic.

But last week, Chula Vista Brewery received a different kind of attention: a spate of vitriolic customer reviews lodged on Facebook, Google, and Yelp, charging the brewery with discrimination against Trump supporters, and racism.

The original reviewer was South Bay resident Patrick McKerney, a racecar mechanic and East County native who visited the brewery with his wife, Michelle, on June 14. That night, he lodged a Facebook review, writing in part, "Completely got treated like crap from the moment we walked in... The host said a racial comment under his breath as we were walking to the table... Never felt so violated in my life. Horrible experience. All because I had a Trump hat on."

Additional reviews, posted by friends of McKerney, soon followed, echoing the allegations: "This place is racist" and "You're a disgrace to America."

It might have ended with the original post, Parker says. "Honestly, if it was just one review, and he was filing a complaint, I would chalk it up as one of those, "Okay you can't please everybody" things." However, when multiple "fake reviews" turned up on multiple platforms, "that's when I felt like, 'All right, I've got to say something."

The brewery responded directly to McKerney's review: "We don't care about political viewpoints, we accept everyone... However we will not tolerate fake reviews [or] allow any slander to our business simply because of your bigotry."

The brewery then posted a notice to its fans, announcing "Don't believe the hype," along with screenshots of the "fake reviews."

That's when the internet took over. Chula Vista Brewery's post was shared to several local Facebook groups and by the Los Angeles-based Worst Beer Blog, which has 17,000 followers on Facebook and 27,000 on Instagram. McKerney likewise shared the response to his own Facebook page, where his friends commented and reshared.

By Monday, fans of the brewery had mobilized

to defend it, adding dozens more reviews across various platforms, and engaging in comment battles with McKerney and friends. Beer fans added positive reviews praising the brewery's beer, owners, and staff, while McKerney's supporters added comments including, "Not allowed to wear Trump hats, they hate white people or even Mexicans who look white."

However, as the conversation devolved, the negativity did not remain one-sided. Brewery fans also attacked McKerney directly, labeling him a racist, threatening his business, and banning him from other breweries. One commenter suggested he and his wife wore Ku Klux Klan hoods during sex.

A still-angry McKerney willfully engaged with his detractors, but decries those invoking his wife, or reposting pictures of her children. "I'm more mad now because they keep involving my family and kids," he says.

While the McKerneys and Parkers cite several minor issues occurring that afternoon, including a lack of ID, COVID-19 space restrictions, a \$22 food order charge, and the size of a cup of water, McKerney contends the negative review was ultimately prompted by disrespect shown his wife. He says the brewery host, a black male, looked at Michelle, who is Filipina, then back at Patrick, a white man in a Trump 2020 baseball cap, and muttered, "Why whitey?"

Brewery cofounder Dali Parker, a Chicana South Bay native, was present during the McKerneys' visit. She says the host flatly denies making any racial comments, telling her, "I was raised better than that." She adds that neither the McKerneys nor members of their party registered any in-person complaint at the time,

and that the rest of the party stayed and continued to drink for hours

Patrick McKerney insists he would have dropped the matter entirely if he'd been refunded the money spent and been issued an apology instead of having his review challenged. He did not know the brewery was owned by people of color, and objects to the racist label being applied to him. "My wife is Asian," he says. "All my friends are black and Mexican. I don't know how I'm racist!"

He says this is the first online review, positive or negative, he's ever written, but he felt he couldn't let the perceived disrespect slide. "I believe it's because I had that fucking hat on. It's got to be either political or racial."

The Parkers insist no one in the brewery noticed the Donald Trump hat, and Parker maintains that many Navy friends, and several of the brewery's best customers, are Trump supporters. He doesn't think the onslaught of negative reviews will scare anyone away or hurt the business going forward.

"Actually, it kind of backfired," he says, "Business has picked up since then."

Moving on, his focus will be on opening a second, larger Chula Vista Brewery location — a 10-barrel brewpub and BBQ restaurant in Eastlake — by the end of the year.

"My goal is always to move forward," he says, "and bring people with me if I can."

More full of detail than the Kojiki, the Nihon Shoki has proven to be more reliable and therefore of greater value to historians and archeologists. The work was completed by Prince Toneri (676-735) with the help of Ō no Yasamuro (d. 723), compiler and perhaps composer of the Kojiki.

Curry and more curry

I will be back, both for the Thai street food and the beer.

e're at the source here. Where it

This is Home Brew Mart,

Ballast Point's original outlet in Morena-Linda Vista, right under the University of San Diego, that Catholic campus on a massif that makes you think of Masada in Israel. The strip mall is called "The Presidio," and it's where Ballast opened for biz in 1992.

And where their brewery opened in 1996.

Not only that, but it turns out yesterday (and this was last week), was their first day to open the doors of their Home Brew Mart tasting rooms since Corona (virus, not beer) hit.

A recent development: now, they're serving whatever interesting beers they want. They don't have to "run them by Corporate" at Constellation Brands, the behemoth that Ballast Point left for its new, way smaller owners, Kings and Convicts.

I'm finding this out from Quinn, who's waiting for me to make up my mind about which beer to order from their groaning list.

I have a zillion questions to ask about how come Ballast left the big boys, but my main question right now is, "Do you have food here?"

"No," says Quinn. "But you can bring it in,

Huh. Maybe not a bad idea. But first I've gotta have a slurp of something. "I'm thinking IPA or

Hmm. He's pointing out porters: Black Marlin, Mocha Marlin, Victory At Sea double coffee, raspberry cocoa Victory At Sea. On and on. But the one I go for is this strange, Indian-sounding one, Indra Kunindra.

And boy, can't say they don't warn you. Whiffs precede the actual grog. Curry and more curry. Quinn also mentions coconut, kaffir lime leaves, cumin, and hey, cayenne peppers. Wow. This has to be the first beer I've had that actually burns you like an level eight Indian curry.

"Think I know where I'm going to get food," I say as I hand over the \$5.50 for this half-pint.

"I'll keep it safe," says Quinn.

I head out for a touch of hunting and gathering. Natch, the strip mall has a Domino's, a Mexi-

> can, a donut shop, and an Italian joint. Really though, no contest. If I want food that fits Indra Kunindra, it's gotta be Thai. So I drop into J&T Thai Street Food.

It's still take-out only here. The sign upfront says to stay six feet apart, so I'm too far away to

read the wall menu. Luckily, I can capture that squiggly square and so manage to read it on my iPad. Chicken soup's \$3.50, calamari soup's \$4.50. J&T Spicy noodle soup (\$8.75 for chicken, \$9.75 for beef) is three stars hot. Grilled salmon with curried rice is top dollar at \$11.75.

Then I see it: Pad kee mao. Drunken noodles, \$8.75. Oh man. Flashback! Lost youth! Bangkok. End of a long night working radio with my friend Ithiwat. To Petchburi Road and its all-night garden cafes. Lots of beers, lots of Thai bands, rock bands, upcountry luk thung bands. And after a couple of hours, we just had to have something to soak up all that booze. "Pad kee mao!" we'd vell. "Pad kee mao!" "Drunken noodles!" "Mao" is "drunk."

The idea of drunken noodles was to soak up your Singha beer and Mekhong whisky and thus sober you up enough to keep going all night long. You could get these noodles anytime, any place on the street. But specially here in these famous beer gardens. And guess what? I spot them today, on J&T's menu, and delight in the promise of those nice, wide, floppy, rice noodles in a spicy gravy sauce. Their sign says this is a place for "Thai Street Food," and it sure looks like they're coming through. Turn's out "J&T" are the founders, Jit and Tom.

"Uh, yes, I'll take the pad kee mao," I say. It costs \$8.75, with chicken. (What I like about this place: appetizers are all standardized to \$5.50, and entrees like yellow or red curry or pad kee mao, are all \$8.75, unless you go for more expensive meats.) The rest of my pad kee mao is basically

steamed veggies like bok choy in this kind of gravy sauce, and those big, wide, spicy (I asked for an "8" on the spicy scale), sloppy noodles.

Of course, on the way back to Ballast, I have to ruin everything by spotting another temptation: the menu at Giovanni's Italian Restaurant. Because, turns out, Giovanni's does Thai too. A salad. Also to-go only. It's a big square box loaded with mixed greens, peanuts, green onions, carrots, and the great Thai thing of grilled limes and Thai peanut dressing. Costs me \$10.

So I haul all this back to the table at Ballast. "Oh wow," says Quinn. "You on a diet?"

"I should be," I say. I take a slurp of Indra Kunindra, then tuck into my drunken noodles.

Oh yeah. Goes perfectly with the Indra Kunindra. All that curry taste!

"We're so much happier now," says Quinn. "Those other people were inching us towards middle-of-the-road. 'Acceptable' beer. That's not who we are."

Al fresco fiasco?

Was Little Italy's al fresco dining experiment too popular for its own good?

1532 India Street, Downtown San Diego. It was a good night for the restaurants, I have no doubt. On Saturday, June 13, Little Italy closed streets to car

traffic and allowed restaurants to extend their seating out onto the asphalt.

The neighborhood was San Diego's first to try a concept being tested in many cities across the United States, including New York City, Chicago, Detroit, and Washington D.C. The reasoning behind the move is that the risk of airborne coronavirus transmission is thought to be far greater indoors than outside. So, by setting up more outdoor seating, diners who don't feel ready to be seated within the confines of a restaurant, might venture out for al fresco table service.

For restaurants, it mitigates a significant problem. The social distancing guidelines required to re-open during a pandemic mean that most eateries can only seat about half their usual number of diners. So, while they may be open for business, they may not physically be able to do enough business to cover the costs of doing business. Being allowed to set up outdoor tables theoretically gives them room to serve more customers.

Take India Street restaurant Bar One, for exam-

ple. By the looks of things, the tiny restaurant was able to seat more diners outside on this evening than it would be able to indoors under normal circumstances. Dozens gathered among outdoor tables, roped off from the street with the help of bar stools. And, like most of the neighborhood's restaurants, potential diners gathered outside, just before dusk, awaiting tables.

And therein lies the problem. This closing of the streets dining event attracted crowds. Outside

virtually every restaurant, clusters of San Diegans gathered, vying for outdoor tables. And by my count, the vast majority of people who came to Little Italy for al fresco dining were not wearing masks.

It feels counterintuitive to harp on this point, given the preceding week of protests that saw thousands of protesters take to the streets demanding police reforms. But on this night in Little Italy, it seemed as though people had either forgotten the covid-19 outbreak is active, or had decided

they do not care.

Lines outside of restaurants, combined with hundreds of prospective diners crowding the streets, made it difficult, and at times impossible, to maintain the six-foot rule. People did what people tend to do when walking together in crowds: walk at different paces, stop to chat

with friends, compress at bottlenecks, edge around one another.

I don't mean to sound judgmental: I showed up, like everyone else, for the implicit romance of al fresco dining, under clear skies, in beautiful weather, in what reigns as the city's best dining neighborhood. However, in a county bracing for a surge in coronavirus infections due to re-opening of businesses and beaches, and which is tracking at least one outbreak of cases connected to a local restaurant, the numbers of unmasked revelers in Little Italy on Saturday night was troubling.

Word is, Little Italy plans to try this again, and I would expect similar, if not greater crowds to

attend. But I think it's fair to question whether the mitigated risk of outdoor dining is compromised by the sheer volumes of people taking to the streets. Perhaps if multiple neighborhoods opened streets to dining at the same time, the population would be better distributed. Or if restaurants were restricted to reservations only, fewer diners would cluster outside restaurants in search of a table.

For those who do plan to attend future street closings, I would suggest reservations are a must, and to be explicit about wishing to dine outdoors. Everybody wants to eat outside, but the restaurants are still seating guests in their dining rooms, and it seems pointless to me to brave the crowds in the street, only to dine indoors.

And if you're concerned about the risk of covid-19, avoid Little Italy's outdoor dining experiment altogether. Counting on fellow San Diegans to limit the spread of the virus doesn't feel realistic. And restaurants open in San Diego are more than happy to serve you take-out.

Dining in restaurants: allowed, but still optional

Sushi Tadokoro; 2244 San Diego Avenue, Old Town. When 2020 began, I did not expect to spend two and a half months writing about take out and delivery. Since dining rooms re-opened in late May, it's been fun, and at times felt a bit daring, to return to writing about on-premise restaurant experiences. Even if those experiences have been eerily dystopian, characterized by half-empty restaurants, sneeze guards, and cubrebocas.

However, I should still be writing about take out. Because, despite being open, most local restaurants are still counting on take-out orders to survive the pandemic. Especially the smaller ones.

Restaurants including Sushi Tadokoro, in Old Town. Its namesake owner, Takeaki Tadokoro, brings traditional edomae-style sushi to San Diego, including delicacies he learned to prepare growing up as a young sushi chef in Japan. His small sushi bar and dining room is the kind of place a food-lover like yours truly goes to eat on his birthday. Preferably omakase, with a great bottle of sake to start things off.

It's not just that Tadokoro offers exceptional or hard to find food and drink. The restaurant's smallness, its intimacy, is part of the appeal. Don't get me wrong — several of the city's finest restaurants are large, high-volume affairs, and necessarily well known. But what use is an urban dining scene without the intimate, less talked about places? The restaurant name you keep in your back pocket to impress a date, or perhaps a friend from the 'burbs, who can't get anything resembling Tokyo-style edamame sushi where they live?

Sushi Tadokoro is open with seated dining for lunch and dinner, and the restaurant space elegantly accommodates distanced dining, with shoji screen dividers between tables, a clear plastic barrier between chefs and sushi bar patrons, and paper order sheets sheathed in plastic. Tadokoro and his wife have overachieved on the clean air front, having

invested hundreds of dollars each on ultraviolet, ionic, and HEPA air filtration systems to protect staff and diners further.

However, for a sushi joint that maxes out around 30 diners in the best of times, Tadokoro can only fit half or less its normal capacity, at the busiest of times. In the restaurant business, if a busy Saturday night can't make up for a slow Tuesday, the restaurant is in trouble.

So, as inviting as the Tadokoros have made their authentic Japanese dining experience, even during the pandemic, they also find themselves in the unexpected position of encouraging customers to order take-out orders. They've prepared both sushi and sake to-go menus.

The sake menu discounts mid- to high-end bottles you're unlikely to find anywhere other than a quality Japanese restaurant in this town. The sushi menu features a full list of individual nigiri and cut roll options, as well as select sashimi orders. But it includes highlights from Tadokoro's lunch specials menu, including a \$26 nigiri combo (8 pieces plus a half roll), and \$40 chirashi box that features a wider assortment of fish, served over rice. For those who can afford it, there's an omakase (chef's choice) special for \$85, which is 20 percent cheaper than pre-

keep such things on the menu as iwashi (sardines), golden eye snapper, nodoguro (seaperch), and uni from Hokkaido.

There are benefits to dining

covid dining.

That omakase will be the best way to sample the sort of rare finds that help make Sushi Tadokoro a valued presence in San Diego dining, including prized Japanese imports. Chef Tadokoro tells me that, after an initial disruption, he's able to get fish from Japan again, even if it costs him more to in at Sushi Tadokoro — such as ordering a sweet and succulent black cod. But the truth is, we don't all need to rush out to support local restaurants, just because they're welcoming diners again. Our support is just as valuable — arguably more so — when we take it home. Even when it's something special.



THUNDERLUX

Laura Jane Willcock (Tell Mama, the Tighten Ups) and her paramour Thomas Yearsley (the Paladins) founded bluesrockers ThunderLux in 2013, soon joined by Leo Dombecki (Jazmin, Ike Turner) and Emily O'Bannon-Robles (the Tighten Ups, Runhoney). A self-titled EP was released in early 2015, but a follow-up has been a long time coming. Dombecki suffered a stroke in his hotel room while on tour in Colorado and was just getting back up to speed with the group when O'Bannon-Robles fell and shredded her leg, placing the band temporarily out of commission. "When she had recovered,

there was one final show before Leo announced his plan to move to Washington state in the summer of 2016," says the band. "The end of ThunderLux felt too painful to even finish the album, and it lay abandoned on an external hard drive in the vault." But while the Paladins and the Tighten Ups have been on hold due to the pandemic, the project has been revisited by Willcock and Yearsley. "The 13 ThunderLux songs were right there," says the duo, "ready for development, mixing and mastering, with a little extra tracking to flesh out a few songs." Their self-titled album drops July 1.



LATEX GRENADE

Based in Rancho Bernardo, thrash/punk crossover band Latex Grenade released their debut self-titled EP in 2010. Their first national tour found them playing at SXSW Austin and headlining at the Winter Snow Show with FM94/9 at Bear Mountain. A new EP dropped in 2018, *The Cage*, recorded at Bellville Studios in Cape Town, South Africa. Late last year, the band hit South Africa again for their second visit and tour of the country, where they supported the Springbok Nude Girls on their Beautiful Evolution Tour. Two years after the release of *The Cage*, the thrash/punk crossover band just released a video for the title track.

Singer-guitarist Geoff Davis told Underground Press that "The song 'The Cage' shows the immense hypocrisy of American politics right now. We currently have a president who has polarized the nation to dangerous levels, throwing gasoline on already tense situations. We have a president who has repeatedly failed to condone Nazis and white supremacists, as countless acts of domestic terror have engulfed many of our communities. We have a system that has failed us, leaving us with two political parties comprised of blind followers and corrupt pseudo-elected politicians put into power by big-money super PACs."



THE MULROYS

Rock and roll Americana-pop duo the Mulroys (formerly known as Rollers, not to be confused with local cover band The Rollers) has its roots in Long Island New York, with childhood friends Theron "TJ" Royer (Crash Encore) and Erik Mullin (the Wearies). They specialize in a blend of spirited rock and roll with elements of country, reggae, blues, and contemporary pop. After relocating to San Diego, the duo formed the band Grow, which played on the Vans Warped Tour as well as making the rounds of local venues. When that group split, Royer did time in San Diego

bands like Defrost, Tailgunner, and Crash Encore. Mullin moved to the Bay Area and played for several years with the Wearies. In 2017, the duo reunited in San Diego to form Rollers, releasing their debut EP Somewhere Along the Way (produced by Christian Cummings). They spent the next couple of years performing as an acoustic duo, occasionally backed by a live band. They just recently changed their name to the Mulroys, enlisting local drummer Mark Maiggard (Louis XIV) and Michigan bassist Chris Diener to record and release a self-produced album called Splitsville.

Last year, alt-country blues rockers Drug Hunt, originally known as Bad Vibes, signed to local Blind Owl Records and changed their name. 



n one seemingly simple sentence, musician Laura Mvula concisely sums up the everlasting appeal of Ella Fitzgerald: "She made it seem like anything is possible." (It's likely that at one point or another, generally in the shower, we've all tried to mimic Ella's sprightly free improvisation — usually with disastrous results.) Her music has been a constant in my life, and Leslie Woodhead's Ella Fitzgerald: Just One of

Those Things serves as a fine introductory course on all things Ella.

I am from the generation of working class families that hired African-American "cleaning ladies" to come in and help with light housework. Once a week, Iona would appear at our apartment, bucket in hand. Sometimes, she'd be accompanied by her youngest son Henderson, and together we'd shoot marbles or watch The 3 Stooges. The radio was always on when Iona was in the house. Not yet kindergarten age, it was the first time I recall hearing "A-Tisket, A-Tasket" or "The Basket Song," as it came to be known on Thorndale Ave. For weeks after, it became a Thursday afternoon standard. Iona's rendition rivaled Ella's.

Ella arrived in Harlem just in time to help lead the Black Renaissance and eventually dethrone Louis Armstrong as America's top scat singer. In her youth, Ella was billed as the "greatest little dancer in Harlem," but that all changed that fateful night she took to the stage. Norma Miller was in the audience the night Fitzgerald made her debut at the Apollo Theatre, and she laughs at the memory of booing the then-unknown performer. She also recalls that the moment Fitzgerald opened her mouth to sing, the boos were replaced with a silence "so quiet you could hear a rat piss on cotton."

Bandleader Chick Webb thought it unwise to stick Ella on a tour bus alongside six horny musicians. She had already endured countless jokes about her size and not being glamorous enough to front a jazz band. Webb was hardly one to poke fun at someone else's physical appearance, but the dwarf with the tubercular spine sized her up and had the audacity to gibe, "I don't want to take that ugly thing on the road with us." Webb didn't live past 30. Much to the disdain of her bandmates, it was Ella's name that replaced Webb's on the bandstand.

From swing, to novelty recordings, to Be-Bop and beyond, Ella made a career out of reinventing herself. Jazz impresario Norman Granz created the Verve label in her honor. But her biggest cheerleader proved to be showbiz legend

Marilyn Monroe, who paid regular visits to the Apollo. According to Ella, thanks to Marilyn, she "never had to play a small jazz club again." It also opened the door to the Songbook series, the most popular (and profitable) undertaking in her career. Take it from this rusty Casanova: there is no better singer — not Sinatra, not Tony Bennett, not Peggy Lee — to make out to than Ella Fitzgerald.

Ella was confronted by the evils of racism firsthand. She MOVIES

was allowed to live in Beverly Hills, but only when Granz's name was on the lease.

Never one to mix politics with pleasure, she only once publicly voiced her thoughts on the subject; the radio interview never aired. (Pieces are included in the film.) Divorced and never remarried. Ella was one of the hardest working performers in showbiz, living life out of a suitcase for weeks out of the year. Her adopted son Ray Brown, Jr. shows up, but has little insight to offer as to why he and his mother spent a decade estranged.


One wishes there were more clips of Ella performing — perhaps securing the rights proved too costly. (Two of her most famous achievements — the collaborations with Louis Armstrong and her glass-shattering ads for Memorex tapes — go unmentioned.) And at 90 minutes, it sometimes feels more like a checklist of career highs instead of a comprehensive biodoc. ★★★

I Am Vengeance: Retalia-

tion — The review should have been filed last week when the film debuted, but after learning it was a sequel - and given my anal-retentive bent — a look at the original was crucial. Pro-wrestlerturned-marquee-aspirant Stu Bennett's gamble paid off with this followup to director Ross Boyask's British thriller. (British thriller? How's that for an oxymoron?) True to form, Bennett enters swinging, landing more punches than bullets. And instead of following the standard "avenge the death of a friend" plotline, this time, Boyask opts to follow an equally conventional "capture the bad guy and transport him to prison" thread. The action never stops, but what makes this sequel superior (though not by much) is Boyask's emphasis on humor — and the addition of legitimate action star Vinny Jones to lend credence. Boyask doesn't direct as much as he pauses the action long enough to move things to another part of the set, where the fisticuffs continue. For



Irresistible — A big time political strategist (Steve Carell), still stinging from Mrs. Clinton's loss, spends the summer in South Carolina, helping to turn a retired veteran (Chris Cooper) into the Democatic mayor of a small conservative town. If you're determined to pattern a Red State/Blue State variation on Frank Capra, there aren't too many actors out there better suited to assume the Jimmy Stewart role than Cooper. But director Jon Stewart shifts the focus from Mr. Smith to Carell's variation on Boss Jim Taylor, with Rose Byrne in the Jean Arthur role. The ending is nothing short of ingenious; be sure to stick around during the closing credits, wherein campaign finance expert Trevor Potter validates Stewart's brilliance. But the level of the banter exchanged between Carell and Byrne seldom rises above that of penis jokes, making many of their exchanges easy to resist. The star of the show is Mackenzie Davis as Cooper's clearthinking daughter; let's hope she can live long enough off the interest of her Terminator earnings to keep energizing low-budget films with her formidable presence. 2020. —S.M. ★★

Tommaso — With six years sobriety in tow, Abel Ferrara awards himself with an autobiographical AA coin of a movie. His sixth collaboration with Willem Dafoe, this is a typical family affair for the controversial filmmaker. Filmed in the director's apartment in Rome, Dafoe stars opposite Ferrara's wife (Cristina Chiriac) and three-year-old daughter

(Anna Ferrara). But this is not a film

like This Is Not a Film, which was shot in Jafar Panahi's home while the director was under house arrest by the Iranian government. Self-indulgent? Of course. Overlong? Yes, but not agonizingly so. And Ferrara may have kicked the drug habit, but the same can't be said of his fetishistic practice of mentally undressing practically every beautiful young actress on the call sheet. (There must be a better

way of illustrating the perks of a job.) Dafoe is a superlative Ferrara substitute, but if you're looking to find the two in top form, a download of Pasolini is in order. When this one was over, I turned to my viewing companion and sighed, "It's not much of a step forward from Dangerous Game," to which he unkindly replied, "I liked Ferrara better when he was high." 2019. —S.M. ★★

 Shaun Michaelsen, 41, told police in Jupiter, Florida, he was only trying to be a "cool father" when he let a friend's 12-year-old daughter drive his Jeep on June 8. Officer Craig Yochum saw the Jeep make an illegal U-turn and speed away, the Associated Press reported, so he followed as the vehicle hit speeds of 85 mph in a 45 mph zone. The underage driver told Yochum that Michaelson, who admitted he had been drinking, told her to drive fast. He was arrested and is being held in the Palm Beach County Jail.

Least Competent Criminal

- An unnamed 29-year-old man in Berlin, Germany, triggered alarms at a supermarket on June 5 when he tried to leave without paying for \$5.65 in merchandise. The Associated Press reported that police had little trouble apprehending the man because, in his hurry escape, he left his 8-year-old son behind. Not only did the burglar's "accessory" help police identify him, but the thief fell down as he was escaping and ended up in the hospital.

Can't Possibly Be True

- The Daily Star reports that a 30-year-old man turned up at Zhaoqing First People's Hospital in Guangdong, China, on June 3 suffering from abdominal pain. Doctors performed a series of scans before discovering a freshwater fish in the man's large intestine, the presence of which he explained by saying he had accidently sat on it. "Do you think I'm an idiot?" one of the doctors replied. The spiny fins of the Mozambique tilapia had caused ruptures in the man's intestine and had to be removed through his abdomen by surgery, but the man survived the ordeal and recovered.

The Entrepreneurial Spirit

- Canadian Glen Richard Mousseau's adventure with Michigan law enforcement began on May 10, when he was arrested in St. Clair County driving a U-Haul truck and in possession of \$97,000. He cooperated with authorities, admitting he was the owner of a submarine seized by the Border Patrol April 23 and he had been using it to ferry drugs between Michigan and Ontario, Canada. Mlive.com reported Mousseau agreed to await the investigation's outcome in a local hotel, but on May 22, federal agents said he had absconded, leaving behind five phones, a laptop and a diving suit. On June 5, Border Patrol officers observed packages thrown into the Detroit River from a vessel entering U.S. waters and found Mousseau unconscious in the water with 265 pounds of marijuana tethered to him with a tow strap. He's being held on charges of smuggling and possession of a controlled substance.

Fail

- Several sailors of the Royal Navy found themselves in over their heads on May 30 as their plan for a barbecue and beers got out of hand. A witness told *The Sun*,
"They were smashed and hadn't bothered to watch for the tide." The Daily Star reported that one partier became cut off from the group, and when another went out to rescue him, they both struggled. Emergency services had to be called in, and one of the sailors had to be lifted off a cliff with a winch, the coast guard confirmed. The Royal Navy expressed its regret that emergency services were needed, but they "remain arateful for their help."

Overreaction

 Richland County (South Carolina) sheriff's officers are searching for a man and woman who held a Pizza Hut manager at gunpoint on May 29 in Columbia -- because they didn't receive the 2-liter bottle of Pepsi they had ordered for delivery with their pie. The manager told WIS the couple entered the restaurant complaining about the delivery, then came behind the counter and as the man held out a gun, the woman removed a bottle of Pepsi from the cooler. Once the goods were in hand, the man put his gun away, and they left the store.

Bright Idea

- A tech startup called ChampTrax has a novel solution for the problem of professional sports being played in empty stadiums. Jason Rubenstein told Fox4 News in Kansas City, Missouri, that his company's Hear Me Cheer technology allows fans watching at home to enable a microphone on a phone or laptop as they watch a game; the sounds fans make will then be captured and aggregated into a single track for the broadcast. "If you're alone in your home, what's the point of booing if no one can hear you?" Rubenstein asked. ESPN featured Hear Me Cheer on a June 9 boxing broadcast and during the NFL draft in April, and the company says it is in talks with other networks and sports leagues.



Richard Morris, a longtime Clairemont realtor, says the duplexes are "cash cows," generating as much as \$4000 a month in rent. "As soon as one comes on the market, it's insane how competitive people are on those

things," he says. The typical purchase price is in the mid-\$700,000s.

Shootout on Fifth Avenue — William Penn Hotel

in 1920, was ground zero for the biggest and most notorious gun battle in San Diego history. On the afternoon of April 5, 1965, 28-year-old Robert Anderson walked into the Hub Jewelry and Loan Company on the ground floor of the hotel to buy a gun, only

to turn it on the credit manager, Louie Richards, who, after being shot, fell just inside the doorway. Another clerk fled into a second-story room and called police. Anderson holed up inside the store and began shooting at police, who shot back. They commandeered a Coca-Cola delivery truck for cover and sent a rescue party to retrieve Richards' body "while the sound of gunfire rattled and echoed throughout the street," according to a Channel 8 newscast at the time. Another police officer snuck into the hotel to rescue the clerk

and managed to shoot Anderson. By then, a total of 65 police officers had fired more than 1000 bullets. (Anderson was convicted and sentenced to death, but in 1972 his death sentence was commuted to life in prison. He was paroled in 1976 and moved to Seattle, where he died in 1999 at the age of 62.)

Two days, two deaths — Spreckels Mansion 1043 Ocean Boulevard

CORONADO
This elegant mansion,

across the street from the ocean just north of the Hotel del Coronado, was built for San Diego business titan and sugar king John D. Spreckels, who also built the Hotel del and owned vast amounts of downtown property, the two daily newspa-

pers, and the San Diego and Arizona Railway. The original home was built with steel-reinforced concrete construction and initially featured four bedrooms, six baths, and about 6600 square feet of living space.

More than 100 years later, the home — which

has since been expanded to nine bedrooms plus a guest house — was the scene of a tragic, fatal accident and a second, mysterious death. In July 2011, then-owner Jonathan Shacknai's son, sixyear-old Max, fell down the stairs and, four days later, died of his injuries.

In the meantime, two days before young Max died of brain damage, the wealthy pharmaceutical executive's girlfriend, Rebecca Zahau, was found nude and hanging by a rope around her neck from a second-story balcony overlooking the interior courtyard. Au-

thorities ruled her death a suicide. Her family disagreed and filed a wrongful death suit. In the civil action, Jonah's brother, Adam Shacknai, who found Zahau's body, was found responsible. But the case was dismissed when Zahau's family reached a settlement with

Adam Shacknai's insurance company.

Jonathan Shacknai sold the home in 2011 for about \$9 million to a Utah-based limited liability corporation. It was subsequently listed for sale several times at prices as high as \$17.9 million; as of March 2020, the home is being offered as a rental for \$80,000 a month.

Fear and loathing at the Travelodge

Thompson didn't attend the game; he traded his two tickets for an ounce of cocaine and spent most of his stay here inside his secondstory suite, drinking and doing drugs. The night after the big game, there was a party in his suite;

among the guests were political consultant and pollster Patrick Caddell, one of the architects of George McGovern's unsuccessful 1972 run for the presidency. Thompson got belligerently drunk and screamed at everyone to leave the

room. Thompson would only venture out of his suite to eat at the hotel restaurant, known at the time as Baker's Square. He caused a fracas when he chased a girl into the kitchen because she rebuffed his advances.

Rudford's — in the footsteps of Kennedy

2900 El Cajon Boulevard

NORTH PARK

On June 6, 1963, President John F. Kennedy was riding in his black Lincoln bubbletop convertible eastward along El Cajon Boulevard toward San Diego State, where he was to deliver the commencement address. In one of the most famous photos of that day, the President can be seen cruising right past Rudford's, a classic diner that had been opened in 1949 by John Thomas "Tommy" Rudford. The restaurant remains open to this day and hasn't changed much in appearance, neither inside nor out. Kennedy, of course, was shot to death less than six months later in Dallas, sitting in the exact same spot in the exact same car.

Raymond Chandler's house

6005 Camino De La Costa

LA JOLLA

This sprawling mid-century house on a corner lot at the north end of Bird Rock was once the home of famed mystery writer Raymond Chandler, the author of such literary classics as Farewell, My Lovely; The Long Goodbye; and The Big Sleep. The last was made into a film noir classic by director Howard Hawks, with Humphrey Bogart in the lead role and a screenplay written by William Faulkner.

Chandler moved into the house in 1946 with his wife, Cissy, 18 years his senior, and their cat, Taki, according to a February 2018 story in the La Jolla Light. After Cissy died in 1954, he remained there until his death in 1959. While in the house — which at the time was a single-story ranch-style home; a second story was added later, in 2007 — he drank heavily, wrote the novels The Little Sister and Playback, and tried to kill himself. According to the La Jolla Light story, on February 22, 1955, Chandler was found in the bathroom of the home, "wrapped in a shower curtain and trying to summon the nerve to insert a gun into his mouth. San Diego Police were notified when the mystery novelist phoned a friend, distraught, saying that he planned to kill himself. Chandler got off one shot, which missed. A second failed to fire just before the officer discovered him."

But he loved the house, according to the Light, and once called it in a letter "a far better home than any out-ofwork pulp writer has any right to expect."

The Cardiff Kook

Chesterfield Drive and Coast Highway CARDIFF

The official name of the six-foot-tall bronze sculpture of a surfer is Magic Carpet Ride. It was commissioned by the Cardiff Botanical Society at a cost of \$120,000 and installed in 2007 at the entrance to the San Elijo State Beach campground. The sculpture, mounted on a sixfoot-high granite base, was crafted by Matthew Antichevich, an artist and sculpture instructor at Mount San Jacinto College in Riverside County. Locals soon christened it the Cardiff Kook, "kook" being a pejorative slang name for a beginning surfer, and began decorating it in outlandish

manners. The Kook has been dressed up as Santa Claus, Uncle Sam, and a Mexican lucha libre wrestler. Since the pandemic began, the Kook has been wearing a mask.

The Boat Houses of **Encinitas**

726 and 732 Third Street ENCINITAS

These two homes, built in the shape of boats, occupy two narrow lots near the ocean's edge in the heart of Encinitas. The SS Moonlight is at 726 Third Street, while the SS Encinitas is right next door at 732 Third Street. Both homes were built in 1928 by Miles Kellogg, an architect whose father was a sea captain. He constructed the side-by-side homes "using timber salvaged from the local bathhouse and a hotel that failed to survive Prohibition's dry years," according to the Encinitas Historical Association, which acquired them in 2008 for preservation. The Encinitas boat houses are among the first local structures to be built of repurposed materials, and represent what the association calls "early California 'courtyard architecture' as well as the kind of vernacular design associated with historic Highway 101." Each house is 15 feet tall and 20 feet long and consists of about 1100 square feet of living space.

Little Egypt

959 Cornish Drive CARDIFF

San Diego County is home to several examples of the short-lived Egyptian Revival school of architecture, including several apartments along Park Boulevard. None are as pure and authentic as this stately



home in Cardiff. The spark for this unusual architectural style was the hit 1921 movie *The* Sheik, with Rudolph Valentino, and the discovery a year later of Tutankhamen's tomb. The unearthing of the final resting place of the boy king by British explorer Howard Carter and his colleagues was a huge media sensation. "The fact that Carter was being assisted by archaeologists and photographers from an American museum, the Metropolitan Museum of Art in New York, added to a sense of national pride and personal involvement with the discovery," according to the Journal of San Diego History.

This particular house was built in 1923 by land developer and builder O. L. Steel, on a hilltop lot in what he hoped would become a tract of Egyptianstyle homes surrounded by avocado groves. The house retains its carefully painted columns, planters, and bas-relief winged suns over the windows and pharaoh heads on the walls by the front porch. Steel later built a second, smaller Egyptian-style home down the hill from the first house, in the 1200 block of San Dieguito Drive.

Log Cabin **Apartments**

1660 North Coast Highway ENCINITAS

Back when the Coast Highway was the main north-south artery in coastal California, the two-lane road was dotted with auto courts. later known as motels, catering to travelers in search of cheap and easily accessible overnight accommodations for

themselves and their cars. This charming little roadside village of 15 red cabins was built in 1935, when Highway 101 was the only way to get from Los Angeles to the Del Mar racetrack, San Diego, and Tijuana. Famous overnight guests

reportedly included a honeymooning Desi Arnaz and Lucille Ball as well as Sammy Davis, Jr. and his dad, who lived in Cabin No. 5 during the Del Mar racing season in the 1960s. The cabins were converted into apartments in the 1980s.

The Last Supper — Miguel's Cocina

5980 Avenida Encinas CARLSBAD

On March 26, 1997, police discovered the bodies of 39 victims of a mass suicide in a Rancho Santa Fe mansion. The 21 women and 18 men had

been members of the Heaven's Gate cult, whose leader, Marshall Applewhite, a former music professor, preached that suicide would allow them to leave their bodily "containers" and enter an alien spacecraft hidden behind the Hale-Bopp comet. In late March 1997, as Hale-Bopp reached its closest distance to Earth, Applewhite and 38 of his followers drank a lethal mixture of phenobarbital and vodka and lay down to die, believing they were on their way to a higher existence.
