



BANKERS HILL AIDS v. COVID Is the city using one pandemic to minimize another?

On July 28, an appeal of the environmental determination for the Olive Street park in the uptown area was defeated by a unanimous vote of the San Diego City Council. City staff had determined that the infill project, a .74acre pocket park on city-owned land in Bankers Hill, was exempt from analysis under the California Environmental Quality Act. Not

During the first three months of the COVID-19 health emergency, beginning in March, "sales of cigarettes in Mexico diminished by 45 percent, [an equivalent to] 254.5 million packs," reported El Financiero on July 27. "This means that in those three months, 209.1 million packs were no longer purchased, compared to 463.6 million in the same period last year, after it was determined that smoking is a risk factor for the so-called SARS-COV2."

Over the weekend, I spoke to Baja smokers about the news. "I've been smoking about the same amount," said Elice Tucker, 56. "Most of my friends down here in Rosarito, both Mexicans and Americans, are smokers. I believe most of them are smoking the same amount."

In 2015, Tucker retired and transplanted from Clairemont/University City to the tourist and beach city south of the border. Recently, she was part of a massive food drive that assisted "about 5000" Rosarito families, many of which were employees of faltering businesses

so, said appellant Jennifer Hasso, who owns an historic home next to the site, and who is suing the city over alleged trespassing to assess the land where the park would be built.

The city posted a notice of right to appeal the determination on April 13. The appeal was filed two weeks later. "We got the notice while other government agencies were closed" due to COVID, Hasso's attorney said, with the result that they were unable to contact state and local agencies and obtain needed records. It's another loose end brought on by the shutdown — the city claims the project isn't covered under the governor's COVID-19 order.

Other issues brought up in support of environmental review ranged from biologia regional AIDS memorial. Since planning began in 2016, critics have complained that the neighborhood park is the wrong location for the memorial, which would honor San Diego's 8000 victims. Somewhere more accessible like Balboa Park would be better, they argued, adding that the park is too small for San Diego's first and only public AIDS memorial, especially one designed to include a large scenic overlook deck above Maple Canvon. "The memorial is critical to CEQA," Hasso's attorney said. "Unfortunately, it does appear the city is aware of that, and is actively watering down the description to get around CEQA. The city's small little watered down park" and the actual proposal "are fundamentally at odds with what is necessary for the CEQA analysis."

Brying all the way to the bank...

...vs the sickly transit of Gloria money How much of a hit has the coronavirus pandemic inflicted on San Diego political fundraising? Based on a comparison of first-half 2020 campaign contributions versus the 2016 take, a sizable but not overwhelming one, partially ameliorated by a lockdownfree June. Final numbers now posted online by the city clerk's office for the first six months of 2020 show that mayoral candidate Barbara Bry made the most of what has turned out to be a brief break between local Covid-19 waves. As the San Diego lockdown largely lifted beginning June 1, the Bry campaign and an ostensibly independent political committee backing her mayoral bid pulled in a total of \$366,219. Gloria, on the other hand, managed to come up with considerably less during June's lockdown hiatus, \$159,418.

Bry's total haul benefited from higher individual giving levels, including \$10,000 from Mission Valley developer and Trump convention delegate Tom Sudberry, which went to Success San Diego in Support of Barbara Bry, a committee not bound by the city's \$1150 campaign contribution maximums. Maximum donors to Brv's official campaign fund, known as Barbara Bry for Mayor 2020, included \$1150 each from La Jolla lobbyist Matthew Peterson, Ben Arnold of Southern Realty Development. Aaron, and Dan Feldman of developer Sunroad Enterprises, developer Chris McKellar, mega-apartment mogul Stuart Posnock, and contractor Douglas Barnhart, along with Barnhart-Reese partner Tamela Reese.

The largest single June contributors to Todd Gloria for Mayor 2020 included Mission Valley landowner Lawrence Cushman, lobbyist Richard Ledford, lawyers Charles Christensen and Krista Cabrera, ex-city manager, now developer Jack McGrorv, Lvnne Gorguze, wife of ex-councilman and current House Democrat Scott Peters, and Steve South, president of the EDCO trash hauling giant. Each came up with maximum donations of \$1150 each. Peters kicked in the same. Cybele Thompson, who quit her job in July as director of the city's Real Estate Assets Department following a stinging report about the handling of the controversial Sempra high-rise deal, gave \$100 to Gloria on June 25.

Political giving reduced to less than healthy levels

The failed campaign for this year's Measure C posted the city's biggest cash haul during the first half of this year. The measure would have hiked the tax on hotel stays in the city of San Diego to pay for a controversial convention center expansion and homeless relief program. Measure C failed to obtain the required two-thirds vote of approval needed to levy new taxes, and the city's hotel lobby threatened to take the matter to court to overturn the electoral mandate. But the COVID-19 pandemic, which shut down the convention business across the nation, has put a damper on such talk for the time being, as hotel lobbyists have set about requesting rent relief for their once-lucrative waterfront properties on city-owned land. During the early days of

2020 leading to the March 3 election, the proconvention center tax group raised a total of \$1.13 million from hotel owners and related ventures, with the two most significant single contributions of \$250,000 each arriving from Marriott International, Inc. and the Manchester Grand Hyatt San Diego.

According to the city's online campaign disclosure data, the midyear filing deadline of June 30 saw the city's mayoral run-off candidates, Todd Gloria and Barbara Bry, both Democrats, locked in a tight fundraising battle. Barbara Bry for San Diego Mayor 2000, along with Success San Diego in Support of Barbara Bry, a so-called independent expenditure committee, garnered a total of \$263,695 in contributions. The latter picked up \$10,000 on February 10 from parking magnate Scott Jones, and \$35,000 on February 21 from the Browning Family Trust, whose trustee is ex-Democratic state senator Steve Peace.

But fundraising has been so tight that Success San Diego was forced to borrow money from its supporters, a phenomenon continued on page 36

politics Democrat **Terra Lawson-Remer** is far out in front of Republican incumbent **Kristin Gaspar** in the fundraising battle between the two campaigns for San Diego county supervisor. According to disclosure filings with the county Registrar of Voters, Gaspar took in just \$66,373 in monetary contributions between February 16 through June 30 of this year. Lawson-Remer got \$301,286 during the same period, per her filing.

Contributing to the Democrat's funding heft was a total of \$12,275 worth of donations from East Coast givers, including \$850 on May 2 from **Adam Berenzweig**, whose facial recognition and "mind-reading" company was bought by Facebook in 2019. He told *DigitalTrends.com* in September of last year about the firm's wristband that "decodes electrical signals from neurons in the spinal cord," the site reported. "I could certainly see a future

where people are wearing this device all day, and that it's the thing that is used to interact with people's phones, the lights in their house, and the radio in their car," said Berenzweig, who now works for Facebook.

Other out-of-town Lawson-Remer donations included \$850 each from retired Wall Street hedge fund mogul **Malcolm Wiener** and his wife **Carolyn Wiener** of Greenwich, Connecticut, and \$850 apiece from **Jonathan and Thomas Wiener**, of the same city. The *Connecticut Post* reported on June 5, 2015 that the couple hosted a lavish \$200,000 fundraiser at \$2700 a person for **Hillary Clinton**'s 2016 presidential

bid. "The reception, held at the \$29.7 million Roman villa of Malcolm and Carolyn Wiener, was closed to the media," the account noted. Known as Villa Candia, the Wiener mansion was "developed by 19th-century New York political boss **William Tweed**," and is "known for its extensive collection of rare art."

Encinitas retiree **Pete Peterson** kicked in \$1700 for Gaspar, as did Urban Plates restaurant

owner **Saad Nadhir** and wife Lillian. According to the group's website, Urban Plates is currently closed due to the COVID-19 pandemic.

Though she came up short in the campaign cash-raising derby, Gaspar benefited from an ostensible independent expenditure by the San Diego Regional Chamber of Commerce Political Action Committee. The PAC spent \$57,070 on anti-Lawson-Remer hit pieces during the first half of the year, says its financial disclosure report, as well as kicking in \$27,500 in support of Assembly Democrat **Todd Gloria** for mayor. Financial backers of the chamber's PAC included Caterpillar, Inc. (\$10,000, March 28); H.G. Fenton, Inc. (\$20,000, March 4); Kilroy Realty, L.P. (\$10,000, February 24); Republic Services (\$10,000, March 19); and XJD LLC (\$25,000, February 21). XJD of Beverly Hills is run by **Michael Schlesinge**r, a controversial developer of condos on the former Escondido Country Club golf course.

> The document notes that "both the campus and SDSU Research Foundation evacuation procedures were in draft form" and that "emergency preparedness training was not consistently completed by new staff within one year of hiring."

> Adds the audit, "The campus did not have a formal building safety coordinator program or policy that addressed initial and refresher

> > specialized training or roles and responsibilities." Worse yet, building safety officers included "employees who were no longer active, and some [who] had not completed annual refresher specialized training." ...San Diego County's Parks and Recreation Department has some explaining to do about some missing pieces of equipment, says a county audit. 'Out of a sample of 24 items from the minor equipment list, 3 (12.5%) items could

not be located," according to the document. Lost items included an Apple Studio Display Monitor, valued at \$645, a Simmons SD7PK Electronic Drum Set (\$599), and Skate Equipment, Knee & Ankle (\$860).

"This tax increase has already been carried out, and it was a severe blow to the economy of the 15 million smokers in [Mexico]," reportedly said Cuauhtémoc Rivera, president of ANPEC, the National Association of Small Merchants. "What happened in these two [plus] months in proportion to fallen cigarettes [sales] was due to the lack of income, because 83,000 jobs have been lost in the country." Rivera added that prior to the pandemic, a person might have purchased two packs, but now their consumption had dropped to one pack, or they opted for the "illegal market," which is estimated to be more than "6 billion cigarettes a year." The "illegal market" refers to store operators or street vendors that open up cigarette packs and sell individual cigarette sticks for about 6 pesos, an equivalent to a quarter a piece.

"People quit smoking and hardly drink because there is no work and money," Ensenada-resident Alex corroborated. "The minimum wage here in Mexico is equivalent to \$80 a week." Alex is a wood fabricator by trade, and brings his San Diego family cartons of cigarettes from Ensenada. He tacks on a small fee to cover his gas and toll booth expenditures. "If you are able to work a minimum wage job here during these times, count your blessings, although I can't imagine some will buy cigarettes and/or liquor while their family eats less."

"Sometimes I run out of U.S. made cigarettes before my monthly visit, and I buy the Mexican cigs," noted Rosarito's Tucker. "But they are really harsh and they make me cough a lot. I normally smoke American Spirit yellow, but they can only be found at the Smoke Shop in downtown Rosarito, and are expensive." They are expensive in San Diego, too - usually around \$10 a pack at a 7-Eleven or liquor stores. But, says Tucker, "I can get a 10-pack carton at the duty-free stores in San Ysidro for about \$42; so that's less than \$5 per pack. The reason the American Spirits are so much cheaper at the duty-free stores is because of the taxes that California implements. All cigs at duty-free are cheaper, but you have to buy them and take them into Mexico. Then you can bring them back into the U.S. but it must be declared."

That part is serious business. "The dutyfree stores require you to register your driver's license number and phone number — and it is all in their computer. So before you check out, they have to log in with your info. You are not able to take the cigarettes out of the store yourself. You have to sign the receipt, which is in three parts — I was told that one part has to go to the government for taxing issues. You get one copy and wait outside for your purchase, then the employee brings out your merchandise in exchange for your receipt. They also have your license plate number, car color, make and model, and they watch you take it to your vehicle and then follow you to the border entrance via the freeway. Or if they are really busy, they have a person standing on the side of the road at the entrance and let them know via FM radio that you are coming; if you don't take that entrance you get reported and get banned from making purchases there in the future."

Carlos, a 35-year-old business owner from Tijuana, has been smoking since his teen years; he didn't elaborate on how many packs he smokes a week, but he said he smokes about the same amount nowadays as pre-pandemic. "I'd rather smoke the Mexican Marlboro Blancos (white-colored packs); here they are about 65 pesos (\$2.92) per pack."

VISTA Death by taxes? Legal marijuana has to fight outlaws and city hall

The city of Vista has rewarded its six medical marijuana dispensaries with a remarkable thank-you gift for playing by the rules turning in an estimated \$175,000 a month in extra tax dollars for city coffers. "They told us we are turning in three times what they expected," says Justin Christman, owner of Flora Verde, which has been open since October. So imagine his surprise at what came next. "Our annual business license fee used to be \$640 a year," says Christman. "They just told us it will now be \$28,000. We never got a phone call or any discussion that this was even being considered. It's a f*cking joke."

that much time to do this. What they are trying to do is come in and look at our books."

City clerk Kathy Valdez oversees marijuana licensing in Vista. She says that the new \$28,000 fee, passed by the city council June 23,

Christman says the reason the city of Vista gave for this mandatory 4375 percent increase in fees was that it will cost Vista that much to launch a new accounting program, wherein a city-hired auditor will come on site to do extensive auditing at each dispensary. He says the increase is "not legitimate. There is no way it will cost them that much money and take

is not actually a business license fee, but rather a "required auditing fee." Valdez says the city has hired an outside consultant to determine if the \$28,000 amount is too high, and if so, it could be adjusted downward after the first year.

None of the Vista dispensaries contacted wanted to divulge their monthly tax payment to the city, but some estimate that the busiest

dispensaries pay as much as \$75,000 a month. City Clerk Valdez says that as of June 30, the six dispensaries had turned in \$1.3 million in new, so-called Measure Z taxes, named after the initiative that forced the city to allow medicinal

dispensaries to open. News of Vista's pot tax windfall reached Oceanside Republican city councilman Christopher Rodriguez, who just announced that he is running for mayor. At Oceanside's June 24 council meeting, he gave a dramatic speech that referred to the Vista model as the right way to tax and regulate this inevitable industry, and urged his fellow councilmembers to allow the opening of storefront dispensaries. "My father was a Latin King," Rodriguez said at the June 24 meeting. "He moved cocaine and dealt drugs." Marijuana, said Rodriguez, was his "beginning." And now, he claimed, "two-thirds

> of the marijuana that's circulating through our city right now is from illegal operations. It's government's responsibility to look at facts and think, 'How can we stop the black market?" He said that it is up to local government to fight back against "black market thugs who are illegally bringing it into our city and funneling it to our kids, who are now using it more than alcohol." And he implored his council colleagues to schedule a special meeting in July so it could craft a ballot initiative, asking Oceanside voters continued on page 34

The nearly century-old estate at 2212 La Callecita in Mission Hills, once dubbed Longview Manor, "is truly a one of a kind treasure," according to listing remarks published at *realtor.com*.

"This architecturally significant home was built by 'San Diego's only master designer' Ralph Hurlburt and is in the Mills Act," the listing continues. Hurlburt, uniquely distinguished in San Diego's list of established masters as a designer rather than an architect or builder —

there are dozens of each — came to San Diego in 1916 following World War I. He had a hand in real estate sales, law, and finance before focusing on architectural design and forming a decades-long partnership with influential local builder Charles H. Tifal. Never actually listed as an architect, Hurlburt was still responsible for the design of dozens of distinctive houses from Point Loma to Kensington to La Mesa before his death in 1942. The Mills Act refers to a property tax scheme whereby owners of historically significant properties receive a discount on property taxes in exchange for an agreement to maintain homes in a fashion substantially similar to their original construction. The La Callecita home's current annual tax bill (in excess of \$22,000), however, doesn't seem to reflect that discount.

"Incredible ocean views will dazzle you from the kitchen, backyard, master bedroom and balcony off the master," the listing continues. "Original hardwood floors are found throughout most of the property, as well as original tiling through the entryway. The timeless coffered ceiling in the sunfilled living room dates back to 1926 when the home was originally built." "The fireplace in the living room is an original Ernest Batchelder piece, which has the largest single tile on register in San Diego County," the home's description boasts. Batchelder's hand-carved tiles are a highly-prized centerpiece on the mantles of pre-WWII homes across Southern California.

While retaining much of its historic charm, the Manor has also been updated to accommodate modern living standards. The home was replumbed in 2018, and low-voltage audio/video wiring was added the following year, along with fresh carpet and paint. The home has six separate zones for Sonos smart speakers, including one for outdoor entertaining, and the home's three full and one half bathrooms continued on page 31





Two years of turmoil at Gompers Prep

ONLY 16 YEARS AGO, gang fights were constant at Gompers Secondary and Middle Schools in Chollas View. That changed when teachers, parents, and a new administration banded together to turn them into charter schools. Part of the decision involved removing the teachers union that had long been in place and going nonunion. In 2012, a high school, Gompers Preparatory Academy was added on the grounds. If success can be measured in a 100 percent graduation rate and college acceptance numbers, Gompers Prep as a charter has been a success. All seniors in the 2020 graduating class were accepted into college, including 75 out of 133 into four-year colleges, while the remaining 58 were accepted into two-year colleges.

But another kind of fighting returned to Gompers when the union arrived back on campus.

Gompers has always done the "heart work" for the kids, in addition to the regular hard work of education, says Dolores Garcia, "and the union does not want to do that."

This summer, after a contentious yearand-a-half aftermath to the teachers union taking hold at Gompers, the school's leadership team laid off 29 out of 67 teachers, or close to 40 percent. They cited greater costs, including low enrollment, for the fall semester as the reason for the June 1, 2020 move. A little over three weeks later, the affected teachers were ordered to remove

all their belongings from the classrooms. Then, on July 6, the school rescinded the layoffs.

The confusion exacerbated the divisiveness on campus over the presence of the union, says math teacher Azucena Garcia, who notes that a few of her colleagues left as a result. She grew up in the Chollas View neighborhood and attended Gompers Prep, which lies immediately south of State Route 94 on 47th Street. After graduating from Reed College in Portland, Oregon, she joined Teachers for America, an organization which helps inexperienced young people land their first jobs. Garcia is now 32. In 2013, she became a math tutor at Gompers Prep, and two years after that, a full-time teacher there.

"I was always aware that Chollas View is an underserved community and came to believe in educational equity. I still live in the community and walk to work," Garcia said.

When you ask teachers at Gompers when the union activity started, they tend to say November 2018. That's when actual recruiting began. It was also then that the union was first "recognized." But Garcia remembers agitation having started in the spring

of that year. "It happened largely as a result of a series of negative articles in inewsource in 2017 that reported on former Gompers students and teachers complaining that poor training had caused a lack of preparation for the students' classwork at UCSD. There were charges of low scoring on standardized tests and grade inflation to make sure students graduated, even though they weren't ready for college."

The Gompers leadership seemed embarrassed by it, according to Garcia, and, to compensate, worked the staff extra hard in preparing their classes during the spring and summer of 2018. "Gompers teachers already work 205 days a year compared to 185 in San Diego Unified District schools. So that's when a lot of grousing began, especially among newer teachers," she said. "And we wanted to have a greater voice at the school. There's too much top-down decision making now."

Why mess with success?

Those who had fought the union's coming to Gompers, spearheaded largely by chemistry teacher Kristie Chiscano, produced a 197-page document petitioning the California Public Employee Relations Board (PERB) to decertify the union. But it took them all of 2019 to produce and, at the last moment, their attorney forgot to file it by deadline. The board refused to act on the petition, which eventually did arrive in early January 2020. Given the circumstance of "omission," as opposed to simple failure to submit, the organization promised to get around to considering the petition later.

In the meantime, union members filed their own objections, namely, three charges of "unfair labor practices," against the union opponents and the Gompers administration. The Public Employee Relations Board then announced that the decer-

tification petition would have to wait for a hearing until the unfair labor practice complaints were adjudicated.

Now everybody waits for the results. And waits. And waits.

Chiscano argues that unions undermine charter schools. In the bad old days, before Gompers went charter, the school had difficulty hiring teachers who wanted to stay. The school district would make the choices, usually rookies who would use the Gompers assignment as a jumping off point for moving to a more preferable (and safer) assignment.

Chiscano is one of the veteran teachers at Gompers. She is a former surgeon who wanted to make an educational difference in a low-socioeconomic-status community. She became credentialed in biology and advanced placement chemistry. At Gompers, she has started a robotics program as well.

"The decertification petition, if successful, would allow us the opportunity for a secret ballot overseen by a third party," said Chiscano. "All along we have wanted every teacher to vote on whether to have a union. But the San Diego Education Association, or SDEA, [the organization that represents teachers throughout the school district] has blocked any chance of voting by means of the unfair labor practice complaints."

The problem, said Chiscano, was that some teachers were never made aware that a union was in the works. One such is computer technology instructor Sean Bentz, who told me, "I am the most veteran teacher at Gompers, and get extra pay for doing extra work. It's like a merit system. So the organizers must have known I would not have been a good person to approach."

Chiscano continued: "Some people say they were told by union organizers that the new organization was going to be an 'association' only, not a union. Others said they

were rushed or pushed to sign," she says. "In fact, we have never seen what those who signed actually agreed to. The tactics of the organizers were never fully transparent."

Having an active union at Gompers Prep promises not only to raise pay for teachers but it's likely to lower their working hours as well, thus eliminating certain extra preparation activities and beforeand-after school efforts that many new teachers don't like. Chiscano believes that would jeopardize the success Gompers has enjoyed since becoming a charter school in 2005. In addition to graduation and college acceptance rates, she cites another impressive statistic: since 2013, Gompers students have been given 200 scholarships to attend UCSD through a program the school's director, Vincent Riveroll, worked out with the university.

No success of similar scale ever occurred at Gompers before 2005. "And these days, they show that Gompers has been two to three times

more successful than similar schools nearby," said Chiscano.

Especially at the time Gompers was getting off the ground as a charter, the before-and-after school time the faculty put in paid huge dividends. In a 2009 article titled "Gompers Takes a Bow," Reader writer Ernie Grimm showed how deploying teachers at the entrances to the campus helped prevent the many gangs in the area from distracting and harassing students as they arrived in the morning and left in the afternoon.

That strategy has been successful ever since, even as the local gangs (52 of them, some say) have never left the area. But some newer teachers don't see that as a part of their job as faculty members.

Gangs ran Gompers

Dolores Garcia, the administrative assistant for student affairs at Gompers, started her career there in 1997. She has vivid recollections of the before-and-after situations of becoming a charter school. At the time of the changeover, there was only a middle school.

Garcia grew up in Chollas View and had once belonged to one of the many gangs that dominated the area. The gangs "were in and out of classrooms," said Garcia, and the student dropout rate was high. Gangs ran Gompers until, in 2004, the school district sent a voung Vincent Riveroll in to fix it. "Put the students first" was the motto he immediately instilled. He initiated strong discipline, including mandatory uniforms and, as a master teacher, did not hesitate to go into classrooms to help struggling classes. "The SDEA hated that and managed to convince the district to remove him," said Garcia.

"That's when parents and community members came together and fought for Riveroll to come back. Together they decided the only way to turn Gompers around was to establish it as an independent charter school. By doing that, they were also able to eliminate SDEA."

Early this year, Gar-

cia started serving the bargaining committee from the leadership perspective, trying to hammer out a teachers' contract with union representatives. The San Diego Education Association's Anthony Saavedra has been chairing the meetings. After the Covid-19 shutdowns started everyone working from home, some union participants began getting increasingly "disrespectful," she claimed. "They were also sounding off on social media, misrepresenting our beliefs. We've had a huge involvement in the school by our students' parents. But suddenly they too were being insulted as not smart enough," said Garcia.

Gompers has always done the "heart work" for the kids, in addition to the regular hard work of education, she says, "and the union does not want to do that."

Garcia stepped down from the bargaining committee in early July. "I do not want a union at Gompers so that we relive 2004," she continued, "and now I am free to say that. If I'd said it while still on the committee, they'd have taken it to PERB as another 'retaliation' against the union."

Garcia believes that eventually parents and local community members may rise up and force the union out. Too many people don't want it.

Bullying and silencing

Before contract negotiation meetings take place, union representatives meet with the various departments of the school to collect the concerns and requests faculty members want them to introduce as the bargaining for the new contract takes place.

In April of this year, Spencer Mills, an English teacher and union member on the bargaining team, met by Zoom with the English department. As the meeting was about to close, Viridiana Word, who was named Teacher of the Year for 2019-2020, pressed Mills to make sure he would take "everyone's" interests to the negotiations. What followed, according to Word, was an insulting and demeaning tirade against her. In a long letter, Word complained

about the way she was treated.

In part, the letter reads as follows: "I asked Mr. Mills if he would please consult the department before he decided things on our behalf, especially as things move forward with bargaining. What resulted was a back and forth discussion that ended up in him silencing me by muting my speaker while he continued to berate me."

In another section of the letter, Word wrote: "I feel this action to be incredibly egregious because, as my bargaining representative, I expect Mr. Mills to really capture what each of the members of the department feels regarding certain topics, rather than him assuming what he thinks we feel, because, as he stated last night, he is 'a smart guy' and can gauge where everyone is."

On April 28, Word sent the letter to the union. "The only response I got was a referral to a union colleague. I wanted someone in charge to discipline Mills for bullying and silencing me, not a colleague." (When I caught up with

Mills later, he said of the incident only that he used "protected speech.")

The concerns Word wanted Mills to take to bargaining revolved around a flexibility she has enjoyed since coming to teach at Gompers eight years ago. "A union contract cannot capture caring for students," she says. "It does not allow for flexibility. I want to have the option to call a student at night and not be stuck to 3:30 pm as the official end of the day. If the leadership wants me to tutor, I don't want to be told 'No, it's break time."

Intimidation

Mills is one of the more strident union activists at the school. He will be going into his fourth year at Gompers Prep this fall. In his first job in education, he worked for the La Mesa-Spring Valley School District assisting before-and-after school programs.

I asked Mills why, in order to establish itself at Gompers, the union didn't stage a secret ballot election for all teachers to see how many favored collective bargaining, then begin promoting its advantages to anyone opposed. (The opposite approach has caused a charge that the effort was clandestine.) Although Mills did not take part in the union's early recruiting campaign, he told me: "We knew that the school leadership would not like the idea of a union and that there would be criers and screamers. Also, there was the likelihood that veteran teachers would have too much negative influence on how younger teachers should vote. So it was decided that first contacting a small group was needed to get started. Eventually, we reached 75 percent of the teachers who said they were interested."

Ever since, the union has interpreted the 75 percent to be the vote.

Mills agreed that being "deployed" at crucial times around campus does not seem to be work for teachers. But there are a number of other important issues, salaries probably being the most compelling. In 2017, Mills's first year at Gompers, he earned \$43,000. "If I had been working in the district," he said, "I would have made \$7000 to \$8000 more.

"Then there is fa-

voritism. Certain people have gotten summers off, not because of merit, but simple loyalty.

"And there is a culture of fear at the school due to 'at will' employment. People have a lot of anxiety about speaking their mind. They realize that they could be gone at the drop of a hat. The administration does not have to throw its weight around. The intimidation is latent.

"But I will say I have great respect for our director, Dr. Riveroll. He has great qualities I admire. I've learned a lot from him."

Although the layoffs were reversed, the rationale for their original adoption was disingenuous, Mills believes. Increased costs for the fall did not acknowledge \$2.7 Gompers received from Paycheck Protection Plan funds, the Care Act, and other funding. "Teachers were to bear the brunt of the layoffs," said Mills. "Zero percent of the layoffs aimed at a reduction in leadership. When asked, the administration said they were not considering that."

Mills has been participating not only in bar-

gaining but on the organizing committee as well. This intense involvement, he thinks, resulted in his being reassigned by the administration from tenth grade, for the start of the 2018 year, to seventh grade for 2019.

"I think of myself as a high school teacher," he told me. "I understood what was going on. They were trying to provoke me to quit Let me mention also that one day while I was in my classroom teaching, my supervisor walked in and wanted to know where my badge was. I had only forgotten to put it on. I emailed the supervisor about the interruption and was told later that that was disrespectful."

Good attrition rate

issue with a number of

union complaints. "They get mad at leadership for coming into struggling classes," she said. "But that can help a class. They say the school's teacher attrition rate is bad. However, the national average since 2010 has been 50 percent in high-poverty regions. As of three years ago, 85 percent of our teachers have been remaining at Gompers. We have a good attrition rate.

"Gompers has an open-door policy in its various campus committees. But union faculty who had concerns that bothered them, they wouldn't go through the committees. Most union teachers are fairly new.

"All of these issues make me doubt whether a union contract is really needed at Gompers. I think it will be counterproductive."

Alphabet soup

Cheryl Coney is a labor organizer at the California Teachers Union. Like Azucena Garcia and Dolores Garcia, Coney grew up in Chollas View. As Azucena began participating in the effort to form the union at Gompers, she reached out to Coney for advice.

Coney was adamant that she only answered Garcia's questions and did not participate in the campus recruiting efforts or contract negotiations. "All of that is done exclusively by the new union itself," she said. And she said she can only provide background information, not any kind of personal or official stance toward the union effort.

No longer David, Stone Brewing recast as Goliath

Stone Brewing is inarguably one of the cornerstones of San Diego beer, and of the craft brewing industry as a whole. Behind marketing slogans such as "yellow fizzy beer is for wussies," Stone has long positioned its brand as an underdog: a scrappy champion of small, artisan brewers taking on a corporate big beer establishment that treats the beverage as a commodity.

That fight became less symbolic in 2018, when Stone launched a highly publicized lawsuit against **MillerCoors** and its budget beer brand, **Keystone**, alleging trademark infringement over Keystone cans that put a clear emphasis on the word "stone."

Stone itself is not so small anymore. Entering its 25th year, the brewery that gave us Arrogant Bastard ranks as the 18th largest brewery in a nation of eight thousand. It operates large brewing facilities on both coasts, and briefly served beer internationally, with a brewpub

So when Kentucky nanobrewery Sawstone Brewing emerged from obscurity last month to accuse Stone of using bully tactics over its own trademark dispute, Stone found itself on the opposite end of a big beer-versus-small beer public relations battle.

Earlier this year, Stone's trademark attorneys hit Sawstone, which opened last August, with a petition-for-cancellation filing with the United States Patent and Trademark Office. Subsequently, a July 19 Kentucky Sports Radio story entitled "Shame on you, Stone Brewing" went viral, painting Stone as a heartless company using its superior resources to go after "a micro-brewery that is trying to stay above water during a global pandemic."

Reinforcing the Stone-as-bully narrative is the fact that Stone has filed nearly a hundred such petitions for cancellation since January 2018. The agency's web site records reveal petitions against scores of alcohol production or retail businesses incorporating some variation of the word Stone in their trademark applications.

While Stone's aggressive efforts to protect its Stone registered trademark may be easily traced to its lawsuit against MillerCoors, that trademark took a bruising hit in the court of public opinion. Craft beer fans across the internet, including plenty of longtime local fans, quickly "jumped on the hatewagon" against Stone.

At least, that's how Stone Brewing cofounder Greg Koch characterized it in a wordy July 27 blog posted to the Stone web site entitled "In response to the wildly irresponsible actions of... Sawstone Brewing" — to date the brewery's only official response to the "bully" allegations.

In the post, Koch, last seen in a documentary about himself entitled *The Beer Jesus From*

America, contends that the Sawstone kerfuffle is a "coordinated harassment campaign aimed at our company," complete with "fraudulent reviews of our locations on well-known review sites."

He goes on to point out that trademark protection against "confusingly similar" branding is "a routine part of doing business," and repeatedly asserts that these efforts, which are ultimately decided by the trademark agency. are resolved "amicably."

A representative from Stone denied repeated requests to back up Koch's claims by providing examples of fraudulent reviews or examples of amicable settlements reached in prior trademark disputes.

As to whether or not Stone is a bully, the majority of Stone's trademark petitions appear to have merit. For example, it contested a **Stoney's Brewing Company** in the Pittsburgh area, and a **Cask & Stone Brewery** in Napa, California, where Stone operates a brewpub. Others seem more open to interpretation, such as the **Stone Bowl**, a fruit bowl restaurant in Georgia, or **Holystone Distilling** in Salt Lake City. Stone has also sought trademark protection over the word Bastard — objecting to such beer names as Magnificent Bastard and Approachable Bastard.

However, closer to home was the August 2019 petition aimed at a small local brewery, La Mesa's **Helix Brewing Co.**, and its flagship IPA that goes by the name "Stoner Moment."

From a lay perspective, it would take a true stoner moment to find the term "confusingly similar" to the Stone brand, to use Koch's metric. In light of the current dustup, one would think that Stone would have more interest in preserving cultural cachet than going after a small brewer in its own backyard. However, as of this writing, Stone lawyers remain engaged with Helix over the use of the term. Helix Brewing founder Cameron Ball declined to comment on whether Stone's overtures to settle the matter could be described as "amicable," he does report that "Stone Brewing is not going to drop their objection to Stoner Moment."

And while backers of Sawstone Brewing Co claim any similarity to Stone Brewing Co. is moot because the historic building housing its brewery was constructed from sawstone, history suggests Stone's trademark protection was always going to succeed. Which leaves little doubt Sawstone has engaged this fight primarily as an opportunity to gain national attention (and set up a GoFundMe campaign that has raised nearly \$15K).

In that respect, Greg Koch is the last person who should be casting stones (no trademark violation intended). Koch made his name and fortune leveraging a David-against-Goliath stance. If he's content to play Beer Jesus, settling into the Goliath role should be a cinch.

A tale of two happy hours

This could be the best experience on the waterfront.

e arrive at six bells. They're ringing out aboard the Star of India. Love it!

(We're talking 3 pm, landlubber's time.) Pursuant to our campaign to find places with a ton of fresh air blowing in, the Scottish Lady and I are down here at the Embarcadero beside the *Star of India*, but actually staring at this egg-shaped glass geodesic

dome. Brand new. It juts out over the waters, right beside what looks like a giant black sushi roll. "What da ...?" I start to say.

"It's a restaurant," says Annie. "Och, it's ane, twa, tree, four restaurants!"

She's right. Starting at the geodesic dome, they have Portside Gelato and Coffee, then Miguel's Cocina, then The Brigantine, and upstairs, Topsail, which looks like the upscalest of them all. And the good Covid news is they all have this sea breeze sifting fresh Pacific air through the place. It turns out these guys opened only a couple of weeks ago. But no shortage of customers. This being the Embarcadero, tourists are traipsing in and out all day long. That doesn't mean food's cheap. Here at the Brigantine, small plates start at \$10 (for most soups and salads), and top out at \$23, for shrimp and crab Louie. Large plates start at \$24 (chicken Milanesa), and go up to \$55 for lobster tails.

"Forget it," says Annie. Except this is when the *receptionista* goes inside and comes back with a print-out page. "Happy Hour," she says.

Oh yes. Now we're talking. Basically all draft beers (and they have nine) go for \$5 each, and so does a glass of house red or white wine. Food deals too. They include three oysters on the half shell, two oyster shooters, a plate of calamari strips, a bowl of clam chowder, potato skins, "Napa Valley Nachos" (whatever that means), a flatbread, and a house salad. Also a bunch of slider options like ahi tuna, Wagyu beef, fried fish, pulled pork, or "free birder" chicken. Not a bad set of choices for five Washingtons.



Of course, we have to wait. But that's no pain. This is a spectacular building, with an even

> more spectacular view, once you get through the odd egg-roll back part. The glass frontage looks out at a Big Bay panorama from the Midway aircraft carrier on the left, around past the active-duty carriers at North Island, to Point Loma to HMS Surprise, the

square-rigger frigate from Master and Commander, past B-39, the Russian sub, to - suddenly, in your face — the giant bowsprit of the Star of India. It really does make you go "Oh wow," first glimpse you get. You sit down so close you feel you can touch her.

So Scottish Lady and I order a Karl Strauss Boat Shoes Hazy IPA each, which is kind of appropriate, because IPA — India Pale Ale — was what Star of India for sure carried out to the British troops stationed in "Inja" back in the 1860s. And it was the extra hops they threw in that kept the beer from going bad on the monthslong voyage.

So yeah, barista Julie's waiting for us to get on with it. "Uh, the house salad?" says Annie.

"It's got hearts of palm, cranberries, glazed pecans," says Julie.

"I like sweet," Annie says.

Dang. So do I, but since Ensenada, I'm also loving oysters again. So I get the three in half shell, plus — was there ever any contest? — the skins, five of them, bristling with bacon, chives, drooling golden cheddar. Dee-lish! But so are the oysters, with stinging horseradish and a sweet, tomatoey cocktail sauce.

The hazy IPA goes down so well, we order another, while it's still happy hour. And in the end, we've hung around so long chomping, slurping, and waiting for the sun to dip, we get the bowl of chowder and a slider, the ahi one, just to keep our seats. And, have to say, chowder's great, but the slider, with its big chunk of tuna flesh and a wasabi-soy aioli that's not shy about giving you

a slow burn, is the top story of the day.

And guess what? Next afternoon, we're back, this time to Miguel's. (Nice touch is the walk-

way around all **Oysters:** surprisingly filling four restaurants

is open to the public.) And here, kinda roasting in the afternoon sun — there are no awnings — we check their HH offerings. As with the Brig, everything is \$5. Along with more of that cloudy beer, Annie gets a cup of albondigas soup and a flatbread. And the flatbread is the deal. It's nice and thin, but weighted down with jalapeños, olives, melted cheese, and Annie pays \$4.25 extra for chicken. Scrumbo!

Me, I go for the empanadas piccadillo. I'd feared there would be too much pan and not enough flavor, like some I've had. But no, these

little half-circles are deep-fried, a little crispy, and full of ground beef, jack cheese, roasted corn. Plus guac and salsa, and a crema.

Only complaint is out on deck, they have no shade. People next door are so broiled they hang their menus from the glass barrier to shelter their faces. The crew takes pity on us and moves us into the shade, but hey, why didn't the architects think of this?

Still, short of sailing away on the Star, this could be the newest, best experience on the waterfront.



Lopez responded with Loco Lopez, and it doesn't take a detailed study of the menu to see where the "loco" comes into play. Inspired by the style of griddled cheese tacos popularized

Sundara alum, local chef Richard Lopez, was

up his own take-out operation.

Iocally by the likes of Puesto and Famoso Mexican Street Food, the \$10 breakfast burrito wrapped in cheese melted right on the flat top is only one

of the over-the-top breakfast items to be found. Hard to miss is the donut grilled cheese, which sees a glazed donut sliced into two sandwich slices, between which three kinds of cheese are grilled along with bacon and serrano chili jam. The whole decadent thing is finished with

powdered sugar for \$10. So is the "El Chingon breakfast sando," a \$12 breakfast sandwich made with a croissant given the French toast treatment, and stuffed with fried egg, bacon, two sau-

wo sausage patties, and more m e l t e d cheese. This literally heavy breakfast sandwich is not for the meek. W h i l e such uber-

indulgent items certainly stand out, those seeking relatively toned-down fare can look to the avocado toast (\$8), or a pair of breakfast tacos (\$10). For those who prefer lunch, \$12 gets you a pair of bacon-wrapped TJ hot dogs, or a *plancha* (a.k.a. flat top) burger served on a potato bun with

goopy American cheese. Pre-paid online ordering makes this an easy take-out option for Obecians, or anyone within a short drive. Lopez has a table set up at the Sundara entrance, so I just pulled up, hopped out, grabbed my orders, and made it home while they were still hot. Of course, after eating some of these hefty breakfast items, I didn't much feel like going anywhere for a while.

Thai Joints rule in the Heights

Thai Joint; 3456 Adams Ave, Normal Heights. It sits within an inconspicuous stucco strip on Adams Avenue, smack in the middle of Normal Heights, with a generic sign bearing a generic name: Thai Joint. How many times have I driven past without stopping?

I had to be told it's a sister restaurant to the University Heights Thai spot, Plumeria, and to Chi Extraordinary Kitchen, which is also on the stretch of Adams spanning the upper end of North Park (we might as well call it North Park Heights). I've been fond of

Plumeria's vegetarian and vegan Thai Cuisine since it opened in 2012. And in the past five years, I've also been wowed by Chi Extraordinary's focus on Thai seafood dishes. In other words, Thai Joint is worth stopping for.

Turns out, the original Thai Joint opened more than 15 years ago at a different Adams Avenue location. This one's only been open since 2018, but it doesn't seem like the residents of Normal Heights forgot the brand. Thai Joint has no patio or parking lot space to dress up as outdoor seating. Nevertheless, during the current pandemic closure, I continue to find a steady stream of customers picking up take-out.

There's a steady stream of delivery drivers representing pretty much every delivery app — Thai Joint works with all of them. One of the drivers I meet while picking up an order shares how challenging it can be to lose weight while running deliveries. How he's on an intermittent fasting diet, which means he fasts during the day and only eats in the evening. He used to drive people around for Lyft, but switched to food during the pandemic. Now every time he picks up great smelling meals, it makes him hungry.

Thai Joint is one such challenging place, he says. When he clocks out, he occasionally returns as a customer. He vouches for the crispy tamarind wings.

I vouch for the house made E-sarn (a.k.a. Isan) style sausage. The ground pork sausage has a crispy skin, flavored with ginger, galangal, lemon grass, chilis, and herbs. You can spot the occasional grain of rice in there, responsible for a satisfying tang distinct from that of hot dogs. The \$7 appetizer will appeal to sausage fans, and while you may find the same wings at Chi Extraordinary Kitchen, the sausage is exclusive to Thai Joint.

Entrees represent the usual suspects of American Thai restaurants: coconut and lemongrass soups; curries of red, yellow and green; noodles and rice dishes featuring ginger, soy, and/or chili based sauces. To some extent these are all better than average, and cost \$10 to \$12 apiece, depending on your choice of protein, which at this location includes chicken and BBQ pork. Or, you can order a vegan version of just about any of them.

I don't know how the heights came to be blessed with such abundance, but it's an easy area to pick up a great family-style feast. Just be warned, these Thai Joints revel in spice: anything higher than level 3 should truly burn.

Bradley's house Reggae trio Pepper's version of Sublime's "Work That We Do" is the lead single off a new compilation, *The House That Bradley Built*, due September 4 and featuring neverDiego in 1999, and took up residence in Carlsbad, Vista, and Oceanside. In 2003, they landed a record deal with Volcom Entertainment and began working with Matt Phillips of Silverback Management Common Kings, the Skints, Long Beach Dub Allstars, and Trevor Young (SOJA). Descendents contributed a ukulele rendition of their song "Hope," a song Bradley covered on 40 Oz. to Freedom. Half Pint performs his song "Lovin," which was the original sample for Sublime's "What I Got," and Jim Lindberg of Pennywise covers "Boss D.J." A duet of the Melodians' classic "Rivers of Babylon," which Sublime covered on an acoustic release, is sung by Brad-

released acoustic covers from the catalogue of the late Bradley Nowell's band, performed by more than 20 guest artists. Nowell died after a 1996 heroin overdose.

"Work That We Do' has always been one of my favorite Sublime tracks since the first time I ever heard it on the Robbin the Hood album," says Pepper singer-guitarist Kaleo Wassman. "It was so hard to get that CD in Kona in those days, and I was lucky enough to have a friend who owned it. I remember sitting in the parking lot of Taco Bell listening to the album for the first time. It was magic for me, hearing those great songs with so many different sounds and textures. There were a lot of different recording styles on that album, and we wanted to recreate the raw vibe of that track in our cover of it. So, with quarantine in place, we were able to work remotely at my home studio with the production team."

The duo that would become Pepper formed in Hawaii when Wassman and bassist-singer Bret Bollinger began playing together in middle school. They found a drummer named Yesod Williams, left Kona for San (Fishbone). They went on to play as many as 200 shows a year as tour support for 311, Flogging Molly, and on multiple Warped Tours. The band landed on top of Billboard's Reggae Chart last year with their eighth studio album, Local Motion, and they've often shared bills with another Sublime-ly inspired local act, Point Loma's Slightly Stoopid. Other performers on *The*

House That Bradley Built include locals Hirie, also heavily influenced by Nowell and Sublime. "When you have a band like Sublime, the Clash, or Big Audio Dynamite that fuse so many styles of music effortlessly," says Wassman, "you understand that they are true music fans at their core, not just musicians but lovers of music. That energy, that frequency resonates through people and is felt with this authenticity. San Diego is a border town and we have so much culture here. I live in Oceanside now, and it's the only place besides Kona that I'll live in the States. The vibe in San Diego has so many layers, which is why these types of bands continue their influence here." The album also features

G. Love, the Expanders,

San Diego bands still have in common with the music Bradley Nowell made with Sublime so many years ago? "Passion for what they're playing and singing about," says Wassman. "And authenticity, a unity of cheering each other on in the genre, always giving the maximum respect to the artists that started it all, our Jamaican brothers and sisters.

mal "I should say first and foremost, that I always just wanted to play music in general and I really didn't have any barriers between genres," says musician Nathan Hubbard. "The first two CD's I bought were Charlie Parker and the Art Ensemble of Chicago, and the first rap I heard was Public Enemy's *It Takes a Nation of Millions To Hold Us Back.* As a kid, I didn't really make those distinctions."

Perhaps having grown up with such an open mind can account for Hubbard's latest accomplishment: a double win at the San Diego Music Awards — "Best Jazz album" for *This Stream* featuring a trio with Harley Magsino and Kevin Jones; and a win in the "Best Hip-Hop" category,

for *The Bully Pulpit*, a new release by the cooperative group Parker Meridien which combines Jack King and John Rieder.

Jazz and hip-hop are two very distinct worlds, and I was curious how Hubbard is able to navigate that terrain. "I just like music. I listened to my parent's records, and my older brother was giving me music. I appreciate all of these different things. Some people think of me as a jazz drummer, but I have classical training, and I've been making recordings and beats all of my life. But I don't want to just dabble, both jazz and hiphop require a lot of discipline

think. There's a lot of common history, and I think you can pretty easily go back and forth. One hand, you have Chuck D from Public Enemy mentioning John Coltrane in one of his lines. It can be specific, too, like someone sampling a Roy Ayers or Gary Burton album from the seventies. So there's a shared knowledge, and in each situation, digging deeper into those specifics is the key. That's been a major part of how Parker Meridien makes music." How is he spending his

time in the pandemic?

"I've been recording a lot of music. I make tracks, then send them to people and have out too much like we would in a normal summer. My kids are used to me putting on my nice shoes after dinner and going off to play music somewhere."

What does he miss most about playing live?

"I don't know if I could even sum that up. It's clear that I love performing. It's a physical thing and a mental thing. I think the lack of playing gigs has made me realize that it's kind of an addiction in a way. After a while you realize you're willing to do almost anything to keep playing. I've always thought of myself as a night person, and I tend to miss that the most."

What's the new normal for you now?



ACE FREHLEY

Original Kiss guitarist Ace Frehley moved in 2009 to San Diego, where he lived in a condo near Balboa Park with local singer Rachael Gordon, who turned up on his next solo album. By the end of 2015, Frehley was recruiting locals like Ray Brandes to help with his covers album *Origins Vol. 1.* The following year, he and Gordon moved to Rancho Santa Fe, though the duo has since had a very public and acrimonious falling out. Frehley hasn't let that or the pandemic shutdown deter his plans to release *Origins Vol. 2* on September 18. A video is streaming online for his cover of Deep Purple's "Space Truckin.'" The single was recorded with his longtime studio drummer Matt Star and keyboard player Rob Sabino (Peter Frampton, Simon & Garfunkel). "'Space Truckin' was recorded years ago, and then I just re-recorded some parts and changed it a little," says Frehley. "We never ended up putting it on a record, so it was just sitting around. It turned out very well. Rob Sabino is a very accomplished studio musician, and we actually grew up in the Bronx together, so we go way back." Other album guests include Robin Zander of Cheap Trick, former KISS comrade Bruce Kulick, John5, and Lita Ford.



TRAVIS BARKER

Blink 182 drummer Travis Barker is still building his reputation as the busiest drummer in California, guesting on tracks covering multiple genres, as well as working on new music of his own. He recruited Lil Wayne and Rick Ross for his song "Gimme Brain," the first release under his DTA Records label, a joint venture with the Elektra Music Group to explore cross-genre collaborations and develop new artists. "All Of Me," a new single from the second album by Los Angeles duo The Score - comprised of Eddie Anthony (vocals, guitar) and Edan Dover (keyboards, production) - features Barker guesting on drums. He also appears on the newly-released deluxe version of POORSTA-CY's debut album *The Breakfast Club*, drumming on the track "Choose Life," inspired by a famous monologue from the UK film *Trainspotting*. In addition, there's a new collaboration track with Run the Jewels called "Forever." Other artists Barker has recorded with recently include nothing, nowhere, ILLENIUM, O3 Greedo, and Lil Nas X.



TOLAN SHAW

Having first gained local attention with the New Archaic, who won Best New Artist at the 2009 San Diego Music Awards, Tolan Shaw began honing his solo act around ten years ago, performing at local coffeehouses and opening for touring artists such as Matt Costa, Jon Foreman, and the Format. He won first place as Best Songwriter at the 2011 San Diego County Fair in Del Mar, and took first place in the Fair's 2013 Singer-Songwriter Contest. Over the past couple of years, he's been selling music to TV shows including his track "Good Day," heard on MTV's *Undressed* and an SDSU recruitment ad, and both "Eyes" and "Never Met You" were on CBS' *The Young and the Restless*. "Last week, I found out a song I co-wrote with Marti Amado Corr for German film and TV company, Sonoton Music, was placed in an end scene of a Turkish TV show on Fox Turkey called *Sen Çal Kapımı*," says Shaw. "A week later, it has over a hundred thousand plays on Spotify, is number six on the Top Viral chart in Turkey, has 250 thousand hits on YouTube, and hundreds of people from Turkey and other foreign countries are reaching out about the song. What a cool way to connect globally with people through music and media."



ANDY ROBINSON

Acoustic/electronic/world/folk performer Andy Robinson first earned notice as a drummer, formerly with local progressive rockers Horsefeathers and L.A. underground groups like Elton Duck and Invisible Zoo. He's known as an accomplished dulcimer player, and he recently became an endorsing artist for Louson Drums, which manufactures a wearable Cajon. In addition, "I play the kalimba [and] I play mostly acoustic instruments, but I really love synthesizers, with their infinite sound-making potential. I drum, I play harmonica, I loop, I sample, I sing, but I don't sing actual words very often." His track "The Open Door" was nominated Best New Age Song at the 12th Annual Independent Music Awards, with judges including Suzanne Vega, Tom Waits, Ziggy Marley, Judy Collins, and Weird Al Yankovic. His albums include *Exotic America, Music Bucket*, and 2017's *AndyLand*, which he promoted with a series of performances at area garage sales. "I've released another song from my album-in-process," says Robinson. "'I Thought I Knew America' is about how we seem to be waking up from the American Dream. Tripp Sprague on bass, Chelsey Moore on backing vocals, I play dulcimer and everything else."



THOUSAND BELOW

Based in Ramona, Eyes Like the Sun was a popular rock band harkening back to the sounds of the 1980s. After splitting, several members re-formed as post-hardcore band named Thousand Below and signed to Rise Records, releasing their debut album, *The Love You Let Too Close*, in October 2017. Fronted by singer James Deberg, last year's release of their second album *Gone In Your Wake* was preceded by a single for "Chemical" and a video for a new track, "Disassociate," followed by a tour with Of Mice & Men. They just debuted a video for their song "171 xo," featuring the band performing indoors and on a rooftop. Their upcoming acoustic remix EP *Let Go Of Your Love*, featuring four reworked tracks from *Gone In Your Wake* and one new song (the title track), drops August 21 via Rise Records. Sumner Peterson of Dead Lakes appears on the new version of "Chemical."

Nudity, uncovered

e open as the curtain rises on the #MeToo movement. When our return to cinemas is finally ensured, there will be a new closing credit aberration to reckon with, a job described simply as "Intimacy Coordinator." Hired by the studio, it's their task to oversee sex scenes, to choreograph them such that the line between actors and sex workers is never blurred. If ever

there were a film in which nakedness was essential to the plot, it's

My first job managing a theatre was a Landmark single-screen that changed double-bills daily. The year was 1980, and the City of Chicago, which still required theatre owners to acquire permits for each movie they exhibited, would frequently send a deputy around to keep exhibitors honest. A knock on the door echoed through the lobby 30 minutes prior to the matinee performance of Josef Von Sternberg's The Scarlet Empress, a scandalous-to-this-day adaptation of the life of Catherine the Great, and one of the last films to be released before the infamous Havs code became law.

No sooner did the Catholic Legion of Decency publish its ratings list to churches than lines began forming at theatres showcasing the condemned titles. Movie censorship, regulated by both city and state when The Scarlet Empress opened in 1934, led to the film's "Adults Only" classification. The rep was older than cinema itself, puritanicalism personified, cloaked in grey business dress and topped with a marled blue lambswool mane wound tight in a bun. Tugging at the leather knot button of her color-coordinated gloves, from which dangled an unfiltered Chesterfield, the relic from the Hays Office insisted that we display an X-Rating sign in the box office. The revenue lost by tuning away a teenage throng eager to watch a black-andwhite costume picture from the 1930s was incalculable.

It was called the Hays Office,

called pre-code actually refers to films released between 1929 and 1934, that glorious period before the code actually became enforceable.

I am not going to pretend that I have not enjoyed my fair share of onscreen nudity - my first nipple was Ali MacGraw's in Goodbye, Columbus - but in retrospect, a starlet's nude scene seldom lives up to her agent's "essential to the plot" incentive. With rare exceptions

Release Roundup

After denuding a great deal of information, the film begins to fall apart — around the same time as the studio system - all but abandoning historical perspective as it collapses into a checklist of favorite flashes. Russ Meyer and Pam Grier are given their due, but damn if the filmmakers don't gloss over the 1970s, by far the most fertile era for nudity in mainstream cinema. Though it's directed by Danny Wolf, the true auteur behind the film is producer/talking head Jim "Mr. Skin" McBride, aided by fellow professional flesh-spotter and publisher of Celebrity Sleuth, Barry Kemelhor.

It could be argued that American Pie introduced sex comedies to a new generation of teenagers, but Wolf veers far off the mark by spending more time on Howling 2 than the original, and fawning over dross like Terminator 3 or the overall inexorable Not Another Teen Movie. Ditto Blake Edwards, whose masterful 10 is given short shrift in favor of Julie Andrews taking a pause amidst the forced hysterics of S.O.B. to flash her "boobies." And a little fact checking is in order: actress Camille Keaton claims that I Spit on Your Grave was the first film in which a rape victim goes back to get revenge on her attackers. But the subject was covered four years earlier, and to greater effectiveness, in the exploitation marvel Act of Vengeance, aka Rape Squad.

In closing, one must applaud the filmmakers for their wisdom in including the single most important full frontal romp committed to film in the past 20 years: Ken Davitian's nude wrestling match with Sacha Baron Cohen in Borat. A better film on the subject awaits. Until that time, we'll have to make do with a solid opening hour and the random parade of tits and giggles that follow. $\star \star \star$

Cliches Come to Life

 Gabriel and Tracy Brawn moved into Gabriel's childhood home in Dover-Fox-croft, Maine, in 2012 and enjoyed a warm relationship with next-door neighbor Steve Ritter, whose garage had been partially built on the Brawns' property decades ago. But after Ritter passed away in 2016, his wife and grown children took over the property, sometimes renting it out, and "this place turned to craziness and chaos," Tracy Brawn told the *Bangor Daily News* on July 16, leading finally to Gabriel Brawn grabbing his Sawzall on May 26 and cutting the Ritters' garage in half, right down the property line. "We're putting up a fence," Tracy Brawn said. "Fences make good neighbors." Dover-Foxcroft police Chief Ryan Reardon said, "We were aware of the situation and believe it's been resolved at this point."

Latest Alarming Headlines

- A roving gang of baboons in Knowsley Safari Park in Merseyside, England is known to vandalize cars and otherwise alarm visitors, but lately, The Sunday Times reported, they've been seen carrying knives, screwdrivers and a chain saw, which workers believe they've acquired from visitors. "We're not sure if they are being given weapons by some of the guests ... or if they're fishing them out of pickup trucks and vans," an employee said. Park officials have pooh-poohed the reports, saying, "We believe that many of these stories have grown in exaggeration as they've been retold."

Lost and Found

- Chris Marckres of Hyde Park, Vermont, went skydiving on July 25, but, he told NECN, "I think my adrenaline was so high and I was just so excited, I didn't realize I had lost it." "It" was one of Marckres' two prosthetic legs. The double amputee was harnessed to an instructor and landed safely, but he didn't know where the leg ended up. His plea for help on Facebook was answered the next day by farmer Joe Marszalkowski, who found the prosthetic in his soybean field. Marckres said the leg suffered a few scratches but was otherwise unharmed. "We kind of take for granted sometimes how many truly good people there still are in the world," he mused.

The Street Where You Live

- Concerned friends of Hartford, Connecticut, retiree Victor King contacted police on July 26 when they couldn't reach King, who had recently reported being threatened with a samurai sword by a man he rented a room to, according to an arrest warrant. The Hartford Courant reported that first responders arriving at the house on Asylum Avenue found King's body, badly slashed and decapitated. Police began a search for the renter, Jerry David Thompson, who was soon found and arrested, but refused to cooperate with detectives, referring them instead to paperwork in his car indicating he believes himself to be a sovereign citizen and therefore not subject to the law. He was arraigned on July 28 and held on \$2 million bail.

Bright Ideas - Farm families in Botswana living beside the Chobe River have long battled herds of elephants that often pass through their fields at night, trampling crops as they move to-ward the river. Barking dogs and fences have failed to stop the elephants, the BBC reported on July 7, but farmers are having remarkable success with a new weapon: disco lights. Scientists from Elephants Without Borders placed solar-powered strobe lights that flash color patterns along the sides of fields elephants are known to walk through, frightening the elephants away. One farmer re-ported that before he had lights, "I had more elephants raid ... but in these two seasons with lights I have harvested successfully."

Predictable

- A \$64,000 glass replica of a Disney castle on display at the Shanghai Museum of Glass in China was shattered in July after two kids "hit the exhibit counter when they were chasing each other," a museum spokesperson posted on Weibo. The Today Show reported Spanish glassblower Miguel Arribas spent 500 hours creating The Fantasy Castle in 2016, but "luckily it's not destroyed," said Arribas Brothers company spokesman Rudy Arribas. When COVID-19 restrictions are lifted, Miguel will go to Shanghai to repair the castle. "We're used to kids and this kind of stuff happening," said Rudy. "Glass breaks."

Awesome!

- A Gwinnett County (Georgia) Sheriff's deputy is recovering at home thanks to

three inmates who came to his rescue. The unnamed inmates noticed the deputy didn't seem well as he conducted security checks, the sheriff's office said in a July 28 statement, and then saw him lose consciousness and fall to the floor, "splitting his head open." The inmates began shouting and banging on their doors, which roused the deputy enough that he "thought an inmate needed help and somehow managed to rise to his feet and press the control panel to open cell doors." The inmates rushed out and called for assistance as the deputy lost consciousness again, the Gwinnett Daily Post reported. "These inmates had no obligation whatsoever to render aid to a bleeding, vulnerable deputy, but they didn't hesitate," the sheriff's office said. "We're proud of them."

The Foreign Press

- The Associated Press reported that an unnamed man in Vienna, Austria, was hit with a 500 euro (\$565) fine for "offending public decency" when he broke wind following an encounter with police on June 5. Authorities said that "of course no one is reported for accidentally 'letting one go,'" but after behaving "provocatively and uncooperatively," the man rose from a bench and "let go a massive intestinal wind apparently with full intent. And our colleagues don't like to be farted at so much."

to approve dispensaries, in time for the November election. He pointed out that Vista's six legal dispensaries are helping to keep minors from getting marijuana, and suggested Oceanside should be getting some of that pot tax that is enriching Vista. The council declined.

Oceanside city council candidate Amber Newman and her husband David have long supported legalized cannabis in Oceanside. The Newmans own A Soothing Seed, which has been making door-to-door deliveries to individuals for years. David Newman told me in April that they plan to continue operating A Soothing Seed.

When asked by email if he meant to call a fellow candidate a thug, Rodriguez responded: "Those that sell and illegally profit from minors are thugs. If the Newmans illegally sell to minors, then yes, they fit my statement." Amber Newman did not respond to a request for comment.

The Oceanside Police does not actively pursue illegal marijuana delivery services. OPD Lt. Matt Cole has said there is no noticeable crime activity connected with the deliveries. City attorney John Mullen declined to comment on Oceanside's decision to make illegal delivery services a low priority. And while three members of the legal cannabis industry in North County wish there was more enforcement against illegal deliveries, they do not all agree with Rodriguez's "thug" slur.

Mike Mellano owns Coastal Wellness in Vista and would like to eventually open a similar shop in Oceanside. He says it is not fair that he will be paying the new \$28,000 Vista fee as well as an additional \$40,000 a year in annual license fees to the state Bureau of Cannabis Control while those who drop weed off at houses pay nothing. "I don't know if I would have used [thug]. But it is absolutely unlawful what [illegal delivery services] are doing. What do you call a person who is committing a crime?"

"Calling anybody out like that is unprofessional, and will not get us where we got to go," says Flora Verde's Christman. "Tm opposed to the black market as much as anybody out there. They are getting an unfair competitive advantage. It's not a level playing field. However, I don't blame the black market, because the barrier to even enter the market from the financial and regulatory standpoint is asinine."

"I feel there are better terminologies [than thug]," says Gracie Morgan of Medleaf, Oceanside's first and only dispensary. Medleaf is deliveryonly, which means it will be competing legally against A Soothing Seed and all the other delivery services which aren't licensed. She says illegal storefronts get immediate attention by law enforcement, but that delivery services just don't get the same attention. "We haven't seen pressure applied to all of the illicit market."

ful in clearing up some issues. For instance, I wanted to know what the new union's name is. "Gompers Preparatory Academy/San Diego Education Association," she said. [The association is a subsidiary of the California Teachers Union.] "Sometimes the membership at the campus refers to themselves as the Gompers Teachers Association," indicating that it is a subsidiary of the SDEA. When teachers become members of GTA, they will eventually pay union dues to SDEA. "But while the first contract negotiations are still ongoing, the SDEA is not yet collecting dues," said Coney.

Coney was helpful, too, in clarifying the unfair labor practice charges against their opponents that the union took to the Public Employee Relations Board. Spencer Mills filed the first one, complaining that the school engaged in "retaliation" against him as a union activist in reassigning him to teach seventh grade. A second one involved Mills as well. It was retaliatory, the charge said, that the school singled him out for not having his badge on when a number of others also were guilty.

The 29 teacher layoffs Gompers announced on June 1 were cited as a third unfair labor practice, although that became moot after the school reversed itself on July 6.

Union members are complaining, too, that their first contract negotiations are going much slower than they should be. "The amount of time it's taking is mind-boggling," said Mills. "It's

like a chess game or Game of Thrones." Coney notes that a Board judge has warned Gompers that it has to bargain in good faith.

From the union opponents' point of view, the unfair labor practice charges have functioned a little too efficiently to block their petition to decertify the union. So far, the Public Employee Relations Board has not seen fit to adjudicate them and move on to the decertification's demand for a vote by all teachers on whether there should be a union at Gompers in the first place. Some are suggesting that mediation might be considered by both sides. "I believe that the issues and differences we have at Gompers can be worked out over time," suggested Chollas View's Azucena Garcia.

continued from page 3 rarely seen by longtime political observers. Anita Busquets, listed as a biotechnology management consultant from San Diego, lent \$10,000 to Success San Diego on February 25. Repaid \$5000 during the period. Busquets was still owed \$5000 on June 30 with the total due at the end of this year. Gwen Rosenberg, a corporate communication consultant for Integrated DNA Technologies, according to the filing, lent the committee \$5000 on February 25, with the balance due December 31. Similarly, Bry's daughter, La Jolla real estate developer Sarah Kruer Jager, lent \$5000 to the committee on February 25, due at the end of 2020. According to the disclosure, the committee spent \$65,717 on a pro-Bry mail piece on the day of the loans.

Gloria's combined donation haul of \$280,244 narrowly beat Bry's total contributions as of June 30, virtually all collected before the pandemic set in. An independent expenditure committee calling itself the San Diego Small Business Coalition Supporting Todd Gloria for Mayor 2020 got \$27,500 on February 21 from the Republican-leaning San Diego Regional Chamber of Commerce Political Action Committee.

Another ostensibly independent pro-Gloria group, San Diegans from Every Community in Support of Todd Gloria, picked up \$5000 from the San Diego Police Officers Association PAC on January 21; \$25,000 came from the American Federation of Teachers union on February 10; and AMR Holdco, Inc., trying to hold onto its city ambulance contract, gave \$5000 on February 17.

Fundraising by all cityregistered committees in the final three months of the reporting period was well

below the average of recent political years, reflecting the coronavirus pandemic's toll. But in an uncertain political year, the mayoral funding race remains fluid, as exemplified by the July 20 filing of a new pro-Gloria independent expenditure committee calling itself **Neighbors for Housing** Solutions Supporting Todd Gloria for San Diego Mayor 2020. Failed city attorney candidate Gil Cabrera, per the document. is treasurer. The assistant treasurer is consultant Shawnda Deane of Sacramento's Deane & Company. Deane is also treasurer for another pro-Gloria independent expenditure committee calling itself United San Diego, a **Coalition of Citizens Sup**porting Todd Gloria for San Diego Mayor 2020. The committee raised nothing from February 16 through June 30, ending with a cash balance of \$84.62 and debts of \$6732.


