

# From fuel to fertilizer Battling blazes via silvaculture

There's something missing from San Diego's fire prevention arsenal. That's according to advocates of a little-known practice called silviculture, a fuel reduction method that draws on forest thinning and management techniques such as trimming the sides of trees and brush and then packing chopped-up piles of cuttings into the ground as mulch. While that may sound like something San Diego is already doing, supporters say it goes beyond the city's current main brush management strategy of requiring private landowners to clear 100 feet of defensible space and five feet of hardscape around structures. "The 100-foot defensible space is not nearly adequate — and it's probably got 20 percent compliance citywide," said Moshe Krafchow, the San Carlos owner of Tree Culture, at a recent meeting of the public safety committee.

Another speaker, who lives a mile from the Rancho Bernardo fire that occurred that day, described difficulty getting neighbors to follow the defensible space regulation or the city to respond to complaints. Still another remarked that Black Mountain, Ruffin Canyon, Rose Canyon, along the San Diego River, and many more "are simply kindling waiting for a cigarette butt."

Given their budget deficit of over \$250 million, it's no surprise that fire and rescue officials said they are understaffed. The danger inherent in that situation was made clear by a 2023 brush management audit that called on the fire department to monitor city-owned land proactively for compliance of brush management regulations. That monitoring led to a grim outlook: only .16 inches of rain so far this season, when the average is over four inches. That makes a substantial difference in flam-

mability, they said. Further, the area is riddled with steep, brushy slopes and ridges. "We have 46,000 acres in the city on the canyon rim in the very high fire severity zone," said deputy fire chief Tony Tosca.

Now, fire staff has the huge task of going door to door to find out if people are complying with brush management. There is also the real estate defensible space inspection program, which checks compliance when a property is sold; a weed abatement vacant lot program that sends out annual notices; and the weed abatement and brush complaint program, which covers both private and city-owned property and is an easy way to find out if land is city or privately owned, fire officials said.

Grant-funded projects have helped with brush management in city-owned open spaces; an EPA approved fuel treatment sprayed 46 acres of evacuation corridors, and there were fuel reductions for 32 acres in the city considered evacuation routes from the city to the county. In addition, the department plans to hire staff who can identify other areas of the city in need of attention.

In July, a new service will offer a defensible space course that will provide homes

with a zone zero (read: "ember-resistant"), defensible space, and information on how "to make the home hardened or insurable, which is more survivable."

Chris Pearson, a member of Spring Valley Community Planning Group, commented

or repeat processes every two years, as with clear-cutting. It's also better than replanting, because it builds up the soil and allows native seedlings to spring up naturally, reducing the need for nursery plants and frequent watering. "Unfortunately, few people know about or have even heard of silviculture, much less inspected an actual site."

As Krafchowif explained, once the dry fuels are down, distributed and compacted on the ground, fires cannot get that large. "That's what a silviculture management plan does." Its methods are currently being used by researchers at San Diego State University's Institute for Ecological Monitoring, as part of efforts to save southern California's mountain forest. But is it a good strategy for San Diego's brushy canyons, its public and private lands laced throughout neighborhoods around the county? Krafchowif, who has several demonstration sites around the county, including 67 acres on Palomar Mountain, thinks it is - even if the city has yet to agree. "I've been trying and banging on doors for years and I was just told this is not how we do it."

that those efforts are all good — "but please add silviculture to the list." He said that in the work he once did with then-Park & Rec's Chris Zirkle, "Chris administered contracts to Alpha Project and Aztec Landscaping clear-cutting. The invasives grew back every two years." In other work with San Diego canyonlands in City Heights, he replaced invasives with seedlings from nurseries that died if not watered every three years. "We can do better," he said, noting that silviculture is a cost-effective way to reduce fuel load. "It's cheaper because we don't have to carry out chopped-down vegetation"

was intensified by an osprey's bird nest on top, according to 911 Video News. "The nest caught on fire and partially collapsed. The embers fell onto the road into a homeless encampment below the nest." Just two days prior, 911 Video News had been one of the first at the scene in Fallbrook where the I-15 meets with historic 395 by The Good Earth Nursery. There, the news outlet reported that firefighters pulled up to a military vehicle whose trailer had caught As the fires were raging in Tijuana that Thursday, the daygomob\_ Instagram page posted a video of a man filming a fire north of Alvarado Canyon Road in Mission Valley. The video's title: "San Diego woman gets detained after people say that she allegedly started the fire in Fairmount Avenue by the Grantville Trolley Station." Around the same time that Thursday, the Department of Forestry and Fire Protection was called in to fight a vegetation fire by the Otay Mountain Truck

fire. The likely culprit was a faulty tire. "The fire caused a fuel spill of around 150 gallons, and EPA and Hazmat were called in to assist with the hazardous spill."

Across the border, in the Leandro Valle neighborhood of Tijuana on January 23, two people lost their lives, and 30 homes were burned, displacing many families, reported *Telemundo 20*. Rafael Carrillo Venegas, the

On January 23, at about 7:30 pm, in Escondido, firefighters arrived to find a burning Tesla; the fire was beginning to spread to nearby vegetation, burning just over 1/4 acre, reported 911 Video News. The outlet added that hazmat was called in to address the Tesla's battery, and that one individual was rushed to

head of the Tijuana fire department, reported 248 fire incidents during the recent Santa Ana wind events. He noted that in the 24 hours between January 23 and 24, firefighters had responded to 80 fires. Adding to the horror of the tragedy, the NMás news outlet aired a video showing a man intentionally starting a fire, noting, "A witness captured on video the moment when a man set fire to a grassland area in Colonia Leandro Valle in Tijuana, where a strong fire broke out shortly after."

Other fires that burned on January 21-22, according to the Department of Forestry and Fire Protection: by Old Highway 395, there was the Lilac Fire, which burned about 85 acres; the Pala Fire, which burned about 17 acres; and the Riverview Fire in Fallbrook, which burned about an acre. On January 20, 619 News Media reported a fire at a recycling yard at 1750 Broadway in Chula Vista.

#### **UNDER THE RADAR**

**Gate crashers** When San Diego airport officials announced a new non-stop flight to Washington D.C.'s Reagan National Airport last month, the *San Diego Union-Tribune* greeted the news with a puffy write-up. "The new, highly coveted nonstop when new federal legislation opened up five slots at the tightly regulated Reagan National airport," according to the December 24, 2024 *U-T* report. "As a smaller national airport, it is subject to the perimeter rule, which limits nonstop

flights in and out of Reagan to 1250 miles from Washington, unless the government grants an exception. According to the Washington Metropolitan Airports Authority, there are 40 flights out of the airport's more than 800 daily flights that fall under that exception. San Diego will now join four other West Coast destinations — Seattle, Portland, San Francisco and Los Angeles — that also have nonstops to Reagan via Alaska Airlines."



But the paper missed a troubled backstory. "Over the airport's objections, Congress last year forced it to add more daily flights, and Virginia Sen. Tim Kaine, a Democrat, warned of the consequences," wrote *USA Today* in a January 30 account the morning after that Wednesday night's fatal collision between an Army helicopter and an American Airlines jet from Wichita. "Speaking in Congress last May, Kaine said there had recently been an incident where two planes nearly collided on a runway and criticized efforts to further increase flights.

"The NTSB report on that runway incursion has not yet been released." The story

continued, "In May, airport officials and other experts also warned that adding more daily flights under what's known as the slot-and-perimeter rule posed concerns. In 2023, Reagan National broke its all-time passenger traffic record with 25.5 million passengers, according to airport managers. Passenger data for 2024 is not yet available. 'DCA is currently at capacity and at risk of being seriously overburdened should there be changes to the



**Penalty boxes** The state's Fair Political Practices Commission is out with its annual summary of fines and penalties for last year, showing San Diego cases resulted in a total of \$35,973. The biggest penalty in the county,

\$13,500, was paid by the Poway Unified School District, which violated the state ban on Mass Mailings at Public Expense, per an online "heat map" posted by the agency last week. As previously reported here, Poway spent \$34,506 of taxpayer money on a mailer for a 2020 school bond campaign that ultimately failed to carry, leaving the district woefully short of funds to pay for desperately needed repairs and other expenses, officials have said.

Another notable 2024 fine recipient on

the list was the El Cajon Police Officers Association, with a \$3324 penalty for a series of late filings.

#### **Politics and money**

The ultimately-failed campaign to raise San Diego sales taxes tapped three of the city's high-dollar political consultants with ties to Democratic Mayor **Todd Gloria**, a newly filed disclosure statement shows, making the pain of the narrow defeat even more

of a blow for local movers and shakers who poured more than a million dollars into the costly effort. The ironically-named Penny for Progress committee raised and spent a total of \$1,383,550 in 2024, per the January 24 filing. Big final month donors included BioMed Realty LP (\$25,000), the Committee to Expand the Middle Class, Sponsored by Airbnb, Inc. (\$10,000), and Waste Management & Affiliated Entities (\$5000).

Earlier donors included the San Diego Police Officers PAC (\$60,000), H.G. Fenton Company (\$20,000), engineering behemoth HDR of Omaha (\$15,000), the Peace Officers

Research Association of CA Issues Committee (\$20,000), New York-based engineering firm WSP USA Inc.(\$30,000), San Diego City Firefighters Local 145 (\$129,880), and the Balboa Park Cultural Partnership (\$40,000). A committee funded by the Municipal Employees Association kicked in \$500,000 on September 16. Top among political consultants listed by the committee was The Gemini Group, run by **Jennifer Tierney**, which





got \$55,000 from the committee, the January 24 filing shows. Polant Growth Strategies, owned by **Corey Polant**, was paid \$31,187. **Ryan Clumpner**'s Public Dynamics received \$20,000.

Tierney also acted as campaign manager for incumbent mayor Gloria's successful reelection bid, per a September 19, 2024

reports of close poll margins. "As for Survey USA," Tierney, was quoted as saying, "they showed Todd losing by three at this point in the mayor's race in 2020 and he won by 12 points, so we don't put much faith in their polling. Our polling shows Todd with a very comfortable lead."

According to her company

webpage, "Jen splits her time between San Diego and Williamsburg, Virginia." Adds the profile: "She has helped elect candidates for San Diego City Council, Mayor, District Attorney, Superior Court Judge, California Assembly and Board of Supervisors. She has been named one of the '50 people to watch' in San Diego. When she isn't working in California, Jen stays busy in Virginia, where she is chair of the Historic Triangle Democrats, a member of the Virginia Democratic Party Central Committee for the 1st Congressional District, and Vice Chair for the Eastern Region of the Virginia Association of Democratic Chairs.

She volunteers for many candidates on the Peninsula and has helped guide the campaigns of Monty Mason for Delegate (93rd) and State Senate (1st) and Mike Mullin for Delegate (93rd)." Clumpner, the third consultant to Penny for Progress, is, like Tierney, a Gloria ally. A February 27, 2004 dispatch by the O.B. Rag noted he was among three plaintiffs in an unsuccessful lawsuit to keep Gloria challenger Larry Turner off the mayoral ballot, identifying Clumpner as a "political consultant who also serves as vice chair of the San Diego Housing Commission." Also like Tierney, Polant has been paid by other Gloria political efforts, including in 2023 during the mayor's bid for the San Diego Democratic Central Committee.

#### The sherpas of YouTube

The first time I tried climbing Mt. San Miguel, I went up the wrong mountain. About an hour into the effort, I rounded a bend and spied the actual Mt. San Miguel off in the distance. "Huh," I said to myself, "If that's San Miguel, then where am I?"

Let me explain: I had looked on All Trails, and the only trails that contained the name "Miguel" that weren't also labeled "CLOSED" were those titled "Mother Miguel." That must be it, I had thought, ignoring the mountainous gender-flip. Nope. Turns out Mother Miguel is the short peak in front of Mt. San Miguel. (It's still a nice hike with great views of Sweetwater reservoir, even if it is a bit crowded on weekends).

Ever since moving to East County about a decade ago, I have been obsessed with the idea of climbing Mt. San Miguel. Even though it's far from the highest peak in San Diego County (officially, it ranks 84th), it is perhaps the most prominent when seen from the city. It looms into view from Chula Vista up into La Mesa and out to Rancho. As you drive around town, it's always there, saying, "Come, climb me, I am here." And unlike its slightly shorter but more accessible cousin Mt. Helix to the north, it's undeveloped, scarred only by numerous TV antennas dating back to a time when TVs had rabbit ears and a high point was needed to broadcast signals effectively around our hilly city.

Finding my first attempt thwarted and All Trails to be of little use, I turned to Google Maps. Now, if you look at Google Maps, the way looks simple enough. Take Millar Ranch Road and drive

on up. It's not hiking, but at least I could go to the top. Nope again. I found the road gated off, plus No Trespassing signs. What? The highest, most iconic point of the San Diego City area, and you can't hike it? What is this?

A Brief History of Mt. San Miguel...or, How They Managed to Screw Up East County (Part 72 of 1001): Once upon a time, Mt San Miguel was

going to host the Hotel Del of East County. In 1890 Alfred Isham, who had made his fortune selling water from Spring Vallev as a miracle cure called "California Waters for Life," and H.L Story, a partner in the construction of the Hotel Del, planned to build an "astronomical observatory, park, hotel, and music pavilion on 160 acres atop Mount San Miguel" (Adema, Thomas J. 1993. Our Hills and Valleys. pg. 102), complete with a gondola providing rides to the top. Unfortunately, purveyors of Spring Valley Miracle Water don't always make the most trusted of partners, Isham took the money, went back to selling his water, and nothing was built.

When you tell a hiker they're not allowed to hike a peak, you can bet they're going to try to hike that peak. Having struck out twice, I was determined. All Trails had failed, Google Maps, had failed...what say you, YouTube? Eureka! I found several videos of people making the journey (including one of a guy paragliding down after his ascent).

**Strike Three?** 

Using satellite maps, I retraced the route those YouTubers had taken, starting from Millar Ranch Road. I picked a date and started training. My hiking partner of choice was my brother, who has completed three Ironman triathalons and more marathons than I can remember. When the day came, we parked at the trailhead for the Millar Ranch Road Hike. (There's a longer way from the base by the Sweetwater Bridge, should you be in better shape than I am, which seems entirely likely.) At first, we followed the utility access roads that crisscross the mountain under the powerlines. These were broad trails, fairly steep, and a little slippery at points. We met a rattlesnake stretched out and sunbathing across the trail. My brother poked him (not advisable), and he coiled, rattled, and hissed until we convinced him that we were not going back the way we came and he moved into the bush. Then we got lost. The access roads don't go all the way to the top. There is a small dirt path that you can just barely make out on the satellite map, but it's super hard to find. This had me going back

and forth for quite some time until my little dot on Google maps lined up with the path.

I'm not sure when the satellite images were taken, but I think it must have been a while back, because the "path" was really hard to follow: overgrown in spots, always steep, and sometimes passing over rocks, so that there was no trail to be seen. We climbed on, picking our way through the growth. No switchbacks, just straight up. After my fourth or fifth stop to catch my breath, my brother assured me, "Don't worry. I'm not thinking of this as exercise."

Eventually, the little trail popped out onto the paved road that took us the rest of the way up to the antennas — and the view. And what a view: Otav Lake, Sweetwater, the Pacific, Coronado, Downtown, Mexico, and so many beautiful peaks further east: El Cap, McGinty, up to Iron Mountain — you name it. We took the requisite selfies and made our way down, this time on the paved road. Uh-oh! Halfway down, we hit a "No Trespassing" sign. Who knew? (Technically it was the first we had seen along our route). We veered off onto a side path, passed by a lovely seasonal pond, and followed Millar's Ranch Road back to our car. Success!

#### **The Verdict**

Is it worth climbing? Oh yes. In addition to the view, there's different plant life at the top. Up there, the Sage Brush, Coyote Brush, California Buckwheat are joined by Ceanothus and countless other plants that prefer a higher elevation and whose names I don't yet know. But as it stands, it seems that 1960s TV antennas are more important than opening up one of San Diego's treasures to the public. As usual, East County is left unplanned, unsupported and treated like a disreputable poor relation., not worthy of the nice things given to people on the coast. If we East County residents weren't all so busy trying to afford rent and groceries, I'd say a movement towards freeing Mt San Miguel could sweep the lands east of the 805. Hikers Unite!

#### **DANNY SOMMERS**

Mabel's Gone Fishing 3770 30th Street North Park



Last month, I wrote about some of the humble pleasures of one of San Diego's best dive bars. Let's do something a little different this month. Allow me now to take you West on University Avenue from The Tower Bar in City Heights all the way up to 30th Street, where we'll take a left and find Mabel's Gone Fishing.

The food here is lovely: seafood and

tapas. But I'm here to talk drinks, mostly with Danny Sommers, but also with Taylor Mall, tonight's bartenders. They are both exceptionally cheerful, well-versed in their menu and its ingredients, and generously informative. Here's Sommers on the Nordes gin used in Mabel's Spanish Gin & Tonic: "Very delicate, very floral, sage-forward, herbaceous, very green. Inviting, not really piney and big and junipery and Tanqueray-y, like a lot of people think about gin."

As far as I know, this is San Diego's only *gintoneria*, so while the bar offers more than gin, it seems right to order a gin cocktail. It happens to be my favorite liquor anyway. Sommers suggests two drinks as good representatives of this establishment, one from each of the two categories he thinks a good cocktail bar should deal in: envelope-pushing specimens of mixology and solid standards. He proposes the Spanish G&T as an example of the former; their Dirty Martini, he says, is an example of the latter: "It won't make you say, 'Wow, I didn't know a dirty martini could taste like this,' but it will make you say, 'Wow I really love a dirty martini."

I opt for the Spanish G&T. While he makes it, he tells me a bit about gin and tonics in

Spain: how they are served not in rocks glasses but in globe glasses, how they might feature "maximalist garnishes" or whatever garden garnish they have on hand (rosemary, mint, basil, juniper berries, grapes) or, in college bars, gummy bears.

Sommers tells me the Nordes he is pouring is distilled from Albarino grapes — creating a brandy — and then distilled with gin botanicals. To 2 oz. of that Nordes Gin, he adds Mabel's housemade tonic. Mall is called over to tell me a bit about it. The tonic includes cinchona bark (where we get quinine from), grapefruit peel, orange peel, lemon peel, coriander, cardamom, fennel seeds, white pepper, sage and gentian root. They make it as an extract, so for the cocktail, 1 oz. of it gets mixed with 5 oz. of soda water, preferably Topo Chico or Mineragua. Mineragua, according to Sommers, has "the most aggressive bubbles." The cocktail is garnished with a white grape, some juniper berries, and a lavish sprig of sage; sticking your nose into the herb with each sip adds a lot to the experience. The whole thing is very fragrant and slightly fruity. It's the most complex and delicious G&T I've ever ordered. I can't imagine that there is a better one in San Diego.

- 2 oz Nordes gin
- 1 oz. house tonic (see column)
- 5 oz. Mineragua soda water

Combine gin and tonic with ice in cocktail tin and give it a short shake. Pour into globe glass filled with ice and top with soda water. Garnish with a white grape, juniper berries and sprig of sage.

Target for a quick errand, and leave your shopping cart unattended for just a moment. When you return, your gym bag — complete with sweaty clothes, headphones, and designer sunglasses — is gone. Stolen. Yes, even your sweaty gym bag isn't safe in San Diego. Or rather, my sweaty gym bag. But I'm not the only victim. Arturo Gonzalez, a local influencer, had it worse in 2020 when his designer Coach fanny pack was snatched while he was wearing it as he covered the downtown San Diego riots on Facebook Live. And if dudes' gym bags and fanny packs are fair game, what about designer purses? Spoiler alert, but not really: women's designer handthieves are striking more often than you might think.

Once upon a time, a purse snatcher was probably after whatever cash might be inside. But in the Age of Instagram, thh brand is its own reward. Luxury handbags and wallets from brands like Louis Vuitton, Hermès, Gucci, and Dior have become irresistible targets for thieves in San Diego County. These high-stakes crimes highlight the relentless demand for designer goods — whether secondhand treasures or status symbols so coveted they can spark significant consequences. Let's take a look at 2024: The Year of the Bag Bandits.

#### **Christmas calamity**

The irresistibility of a Louis Vuitton wallet recently spoiled a San Diego family's Christmas. Early in the morning on December 5 of last year, someone broke into Andrea Nicole's late-model Kia in front of her home in Fairmount Park and stole her black Louis Vuitton wallet from the car's center console. "It was a \$1500 wallet," she told me in a December 23 interview. "It was definitely not in my price range, as it was a gift I had received the year prior." The wallet, bearing a silver LV insignia and long enough to hold unfolded bills, contained her rent money for December.

The thieves bypassed the alarm and door locks, likely via a method popularized by the Kia Boys on the TikTok app in the last couple of years. "I have learned that Kia's are burglary magnets, they have ways to bypass locks and start the engine easier than other cars." Losing the wallet was painful, but losing what was inside was much worse. "The wallet also contained gift cards, health insurance cards for my children

and me, and SENTRI cards to cross back and forth from Mexico at a faster pace," she said. "All the cards were reported, and the police were already involved."

Later that Thursday, Nicole posted an update on NextDoor: "I have video surveillance of them ... The surveillance shows the original individuals using my cards." She posted photos and video of a "Hispanic woman" wearing an all-black outfit with white accents and an "Asian male" wearing a blue jacket, a red shirt, and black pants — shopping at the World Food Supermarket on 52nd Street and El Cajon Boulevard in City Heights. The couple then spoke to a security guard before walking out with a cart full of groceries. The woman drove an older Lexus ES250, and the male drove a Dodge Ram truck. They then traveled to other stores in the area to use her cards.

On December 8, Nicole got a notification on her phone regarding someone attempting to run her credit card. "It was just made at 1:07 pm by a black male,"

she posted on NextDoor, "now pictured below at City Heights Market, Jack in the Box, and several other spots. Possibly, the original duo trashed my cards, or they passed them off. I took descriptions of the individual from the merchants, canvassed the street, and found him." She posted photos of the man in question, "recovered one of my stolen debit cards, and once again called the police to report, and they never showed. My goal is to get as much of my personal and kids' information off the street, and so far, I got one card."

Things got a little better for Nicole and her family as Christmas neared: "I was refunded all of the funds to my credit and debit cards with fraud claims and the addition of the police report number." But the rent money and the Louis Vuitton wallet were still missing.

#### Carlsbad bling ring

On November 15, Carlsbad police responded to a residential burglary after a homeowner, who was out of town, received an alert from his security cameras. The foot-

age showed two suspects wearing gloves, hoodies, and bandanas in his backyard. The suspects accessed the second-story balcony and broke in through a window. Once inside, they stole luxury handbags, \$10,000 in cash, passports, and Social Security cards from an unlocked safe.

Officers documented the scene and transferred the case to the Property Crimes Unit, which quickly identified a suspect vehicle. On December 12. Carlsbad detectives assisted the San Diego County Sheriff's Office in locating the vehicle, which was also linked to a burglary in San Marcos. After spotting the car, a brief pursuit ensued, but was called off for safety reasons. Later, the vehicle was found to have crashed and been abandoned. With the assistance of a K-9 unit, two suspects were apprehended and taken into custody.

Further investigation led detectives to a residence in Los Angeles, where they uncovered multiple designer handbags, including classic Louis Vuitton pieces valued at thousands of dollars on the secondary market. They also recovered cash, jewelry, passports, smartphones, foreign currency, and a stolen handgun tied to a prior residential burglary in Los Angeles County. In a Facebook update, detectives noted that they are currently collaborating with law enforcement agencies across the state to identify additional victims linked to the recovered items.

# Larcenous landscapers In September, Nadine D.,

a resident of Pacific Highlands Ranch just east of Del Mar, faced a similar ordeal, when landscapers allegedly stole her \$1750 Dior purse and its contents — cash, a diamond ring, and make-up from her house. "My mom bought me the bag when she was on vacation in Europe," she said in a recent interview. "It

was sentimental to me and the only bag I had. I don't have the heart to tell her what happened."

Instead, Nadine took to the NextDoor app and posted about her pursesnatching situation to her neighbors — hoping she could get more intel on the landscapers. "Horrible, they used to work for Standard Tel, a telephone company that went out of business," Timothy S replied to her.

Asked how she tied the landscapers to her missing baby-blue Dior Cannage purse, Nadine said the landscapers had pulled out a blank check from her purse and "wrote fraudulent checks addressed to Victor Chavez to cash at David's Friendly Market Liquor & Check Cashing. The memo line said 'landscape work,' and the back of the check showed it was cashed at David's Friendly Market." Nadine added that she called the police for an update a week before our interview and "was told my case was closed. I reopened it and was told someone would call me the same day, and no one called."

As this article goes to print, on eBay, the same model Dior purse in the same color is selling used for \$1350 in Japan, and another one from the United Emirates is priced at \$1121.

#### San Marcos sneakthief

Back in August, Katie Rhew, a Temecula resident, was arrested after authorities discovered stolen items, including designer handbags, during a search of her home and vehicle. The San Diego County Sheriff's Department reported that detectives from the San Marcos area executed a search warrant at a Temecula property as part of the then-ongoing investigation into a residential burglary. Rhew was identified as the primary suspect. During the search, detectives recovered several items reported stolen from a home in San Marcos, including unnamed designer handbags valued at over \$5000.

# Social media, social decay

The theft of luxury items is driven by the internet, massive primary market, and booming secondhand market. (The used luxury market was projected to grow from \$2.47 billion in 2023 to \$2.66 billion in 2024, according to Statista.) Online platforms like eBay, Poshmark, Etsy, and

#### No respect for Asian elders


On June 15, a trio of people who had been targeting the purses of senior citizens in Mira Mesa and National City were caught. According to mainstream news reports, prosecutors identified Kenya Frazier (29), Shan T. Davis (32), and Anthony Foster (67) as suspects in custody for allegedly targeting elderly women of Asian descent aged 64 to 89 in a string of robberies across San Diego.

Authorities said the trio primarily targeted victims as they left grocery stores and loaded their groceries into their cars. While the victims were preoccupied, the suspects reportedly seized the opportunity to snatch purses — often left in plain view on passenger seats of unlocked vehicles. A getaway car was said to be waiting

nature of the thefts in an interview with ABC 10 News: "Sometimes they walk up, and all of a sudden grab a necklace, grab the bag, and then all of a sudden go inside the car." In a recent interview with Gale Bryan, who teaches the local senior citizen community how to defend themselves against criminals, she advised

carrying a purse with the shoulder strap across the body, resting it in front, with a hand over it. If the purse has short handles, she said to try to put it over the shoulder and hold it tightly under the arm. "Make sure all buttons and zippers are closed," she said. "Carrying your purse this way also keeps your hands free to defend yourself

Bryan, a retired employee of the Riverside County Office and now a women's self-defense instructor, teaches women of all ages how to protect themselves against pickpocketers and pursesnatchers. "Don't leave your purse in a shopping cart, even if you bury it under your purchases," she advised. "A thief could walk away with the entire cart and not look the least bit suspicious. Also, don't leave your purse in the passenger seat while pumping gas. A thief can open the car door and take your belongings while you are looking the other way."

#### The smash and grab trio

On March 19, three men were charged with orchestrating an organized retail theft operation that netted more than \$300,000 in designer goods, including expensive handbags, reported Patch.com. Over two years, the trio committed thefts, many smash-andgrabs, throughout California, and often in San Diego County. According to court documents, Isaiah Abdullah, Nickolas Mallory, and Ishmael Baptist are accused of acting together to steal \$309,752 worth of merchandise with the intent to "sell, exchange, or return the merchandise for value." In San Diego County alone, their thefts totaled over \$182,000.

The spree in our backyard began in February 2023, when \$15,900 worth of Prada merchandise was stolen, followed by a \$20,282 theft from Burberry in March. In July, \$30,277 worth of goods was taken from Bottega Veneta, with another \$16,950 stolen

from Louis Vuitton in August. In September, the suspects struck Louis Vuitton again, stealing \$33,140 worth of goods, and in October, \$22,340 worth was stolen from Prada. November saw two additional incidents: \$5095 taken from Coach and \$4500 from Burberry. In December, with \$23,080 stolen from Louis Vuitton, and in January 2024, \$11,295 worth of Versace merchandise was reported stolen.

Attorney General Rob Bonta stated that the operation involved storming into stores, grabbing high-ticket items, including purses and bags and simply running out. (Other retail thefts are more elaborate. In 2021, thieves used fireworks as a diversion during a robbery at the Coach store in Carlsbad, stealing purses and accessories, according to Fox 5 News.)

#### **California Girls**

Michelle Mack, a Bonsall resident accused of leading an organized crime ring responsible for stealing nearly \$8 million in makeup and luxury goods, has been sentenced to more than five years in state prison and fined over \$3 million. According to mainstream news outlets, the sentence was handed down by a San Diego County

Superior Court judge on July 18, 2024. Mack, 53, pleaded guilty in February to running a theft ring known as the "California Girls," which operated across more than a dozen states. The group targeted retailers such as Sephora, Ulta, Bloomingdale's, T.J. Maxx, and other cosmetic and luxury stores. Prosecutors stated that Mack resold the stolen merchandise at discounted prices through an Amazon storefront.

Authorities also revealed that Mack and her husband, Kenneth Mack, ran the operation from their \$2.75 million, 4,500-square-foot mansion in Bonsall, located north of Vista and Escondido. Video evidence showed a stockpile of stolen items in their garage, including what

appeared to be a Louis Vuitton purse among the cosmetics.

#### Redditor robbed

In January 2024, a local Redditor who goes by the handle tarzhaybae posted about her stolen designer purses, which fetch over \$1000 a piece — used. "Hi Reddit," she wrote, "my house was burglarized tonight, and many of my bags were stolen. If anyone sees any of these bags pop up for sale, please, please alert me. I'm located in San Diego." She posted a photo of her Chanel black Mini Flap style with a gold and silver lion head charm. "I'm fairly certain this style is pretty rare? It should be easy to find, and flag."

On eBay, I couldn't find a Chanel Mini Flap purse with the same lion charm, although I found Mini Flaps without the charm which cost \$4000 to \$6800. However, I did find a match on Carousell, a site in Singapore similar to our eBay. The the purse was listed at \$9999 Singapore dollars, — about \$7300 US dollars. Also stolen from her house was a Louis Vuitton Alma BB Vernis in the rose-angelique colorway. (She even had the original 2013 receipt still in the bag.) On eBay, only one was listed in the same color; it sold for \$1183 in Japan. She

also posted about a Louis Vuitton Damier Ebene purse: "The lock on the bag is noticeably shinier and newer looking than the rest of the hardware," she said, "because I'd kept it stored for so long." Also stolen was a black colored Celine Nano luggage unit and a beige YSL Loulou—those have sold on eBay for between \$1500 and \$3000.

#### Alcala and awareness Westfield Plaza Bonita

mall has seen its share of thieves over the years. In December of 2023, I met with one J. Alcala and he pointed out vulnerabilities holiday shoppers often overlook at the bustling two-story mall. Alcala has over two decades of experience in substance use and crime prevention, and is trained in Crime Prevention Through Environmental Design (CPTED) principles. He's a subject matter expert in urban crime, and a veteran bodyguard for the sort of people who carry these sorts of handbags. "High-traffic areas near entrances and exits of the malls are prime spots for purse snatchers," Alcala explained. "They can quickly grab a bag and escape before anyone can react."

We walked past groups of shoppers, pausing to observe their behavior. Alcala noted how distractions like checking a phone or carrying multiple shopping bags could make someone an easy target. "Pickpockets and purse-snatchers thrive on distraction," he said. "They look for people who are too busy or unaware of their surroundings." We noticed a woman with a Dooney & Bourke purse sitting at a table with her back

towards us and the purse next to her on the chair to the right. Someone at a distance on her left yelled at his friend and she looked in that direction — all the time a thief would need, said Alcala.

"So, what's a safer way to sit at a table and protect your bag?" I asked.

"Put the bag on the opposite side of where people are passing by. Keep it further away from the foot traffic."

"What about putting it on the floor with the handle through one of the chair legs?"

Alcala responded, "Some women won't put it on the floor because of certain customs and superstitions." A Chinese proverb translates roughly, "A purse on the floor is money out the door."

As we walked past a sneaker store, an alarm started blaring at a distance. A security guard walked right past us. "You see how he's on his phone, and look at the alarms going off," Alcala said, "And he's still on his phone? All these stores should tell the mall to pay security more. The security guard probably doesn't have the experience, because they are unwilling to pay."

We walked by the large Christmas tree, and he pointed to a woman wearing a gray dress with a medium-sized Michael Kors bag. "People worrying about their aesthetics make them easy targets," he added. "We were all younger once. Do you remember when we were younger? This was where you showed off your outfit. And sadly, the thieves know that. For her, one guy can distract her by talking her up, and another guy, the accomplice, is just eyeing to get the bag."

We found our way by the food court on the second floor, and we noticed a woman with a stroller and a handbag hanging on one of the push handles. "That purse literally is just right there," he noted. "That guy can just grab that and run, and on the opposite side, there's all kinds of barriers, and he could be gone."


Alcala emphasized that prevention is possible. "Proactive measures like visible security patrols and shopper education programs can significantly reduce incidents. Shoppers need to remember that safety starts with awareness," he concluded.

#### Tips from the Purse Collectors

There's a Reddit thread called, "Have you ever been robbed for your designer handbag?" Women from all over the country post that their purses have been snatched from them in broad daylight; some were beaten for their purses. One even mentioned an influencer being robbed of her designer purses after the thieves found out where she lived.

Some of the collectors suggested insuring purses and keeping the receipts. Others noted that home insurance policies won't cover the loss if the purse was stolen outside the home. Another added, "I know someone who uses Chubb to insure her bags. She told me it covers breakins and also if you're mugged. She has like five Hermes Kellys and three Birkins" Depending on the material and colorway, some of those can cost over \$100,000 apiece, even used.

# **Hummingbirds dive bombing, Ice** plant brightens roadsides, Pleiades

**Hummingbirds Are Zipping Around San Diego County's Backyard** Gardens, scrub-covered coastal hillsides, and the warming Anza-Borrego Desert. Seasonal hummingbirds are making their way back to Southern California in preparation for breeding season in early Spring. Resident hummingbirds like the Anna's often dive bomb invaders to defend their turf. Male hummingbirds tend to patrol larger areas (up to a ½ acre) to defend mating territory. Female hummingbirds dive-bomb too, but tend to be localized around smaller nesting areas. Dive-bombing tends to be accompanied by a sound which the birds make by fluttering their tail feathers while diving. Males will also dive as a mating "dance" to impress a female. Ice Plant Is Responsible For Many Of The Carpet-Like Splashes of yellow, pink, red, and purple we're beginning to see around San

Ocean Water Temperatures, Of Late In The High 50s Fahrenheit, are finally on the upswing this month as the daylight hours lengthen and the sun arcs higher overhead in the sky each day. It will take about five months of spring and summer sunshine before the ocean's enormous mass and large heat capacity fully respond to the input of solar energy. A maximum water temperature in the low to mid-70s is expected by August or September.

The Quarter Moon Will Blot Out The Stars Of Pleiades on February 5 and 6 at around 11:15 pm PST. This time of year, the Pleiades cluster will be low on the horizon in the western sky near where the sun sets. The Pleiades star cluster is also called the Seven Sisters. In Greek mythology the seven sisters were the seven daughters of Atlas, who held up the sky, and the Oceanid Pleione, the protectress of sailing. They are also on the car logo for the Japanese brand Subaru — the ancient Japanese term for the star cluster.



There's an estate sale tomorrow, followed by an auction, and then finally, there's the matter of the house, with its problematic graveyards - one for the family, one for the slaves who used to reside on the premises. Problematic from an environmental point of view for any prospective buyer; and from a personal

point of view for any former resident. The family gathers for the occasion: dutiful daughter Toni, who took care of the old man through his declining decades; successful son Bo, who never liked the place and lives in New York with his Jewish wife; and even uninvited black sheep Franz, who has come a long way in the last ten years.

There are also members of the next generation, who give the play's title its meaning. As 13-year-old Cassie puts it, "Do you think there's a danger in knowing too much?" Might not it be better — if, contra Faulkner, such a thing were even possible — to let the past die with those who lived in it? Is rooting around in a dead man's leavings beneficial? Is it...appropriate?





#### The Priests 2: Dark Nuns —

Ten years separate The Priests and The Priests 2: Dark Nuns, an in-name-only successor that, apart from the satanic heave-ho, a pair of holy-rolling role reversals, and an eleventh hour cameo by Gang Dong-won, barely qualifies as a sequel. Director Hyeokjae Kwon's idea of establishing a character's insubordinate streak involves Sister Junia (Song Hyekyo) taking a drag off a butt before slipping into her habit. Along with Sister Michaela (Jeon Yeo-been), the two nuns join forces to trick a demon trapped inside a young boy into revealing his identity. An unordained nun performing an exorcism on a child is hardly a unique concept - Prey for the Devil (2022) comes to mind. But the script deftly smuggles in scads of contemporary talking points, among them a pro-choice view that equates ignoring a possessed child with murder and men of science who scoff at the thought of demonic possession. An off-kilter sense of humor prevails: our eponymous duo cart around 5 gallon polyethylene jugs of holy water. When asked why she doesn't quit smoking, Sister Junia reassigns guilt with, "Secondhand smoke is worse." Once the casting out begins, claustrophobia sets in; the demons are free to leave the room, but not the audience. (2024) — S.M. ★★ (ANGELIKA CARMEL MOUNTAIN)

Wicked — They sure do grow their Munchkins large in this unofficial, at times painfully woke musical prequel to *The Wizard of Oz*, told from the point of view of the witches, Wicked Elphaba (Cynthia Erivo) and Good Glinda (Ariana Grande). The characters and situations are ingrained since birth, the messages — there's no place like home/everyone deserves a

chance to fly - simple and similar. Hence the mass appeal. Warner Bros. owns the rights to the MGM original, leaving Universal unable to reference the 1939 version lest the running time expand to include an epilogistic courtroom battle. The studio went so far as to engage an on-set copyright wizard to verify that nothing was accidentally "borrowed." (If anyone has cause to cry infringement, it's the designers behind Candy Crush Saga.) What kept me going was watching the mindful screenwriters tiptoe through the minefield of intellectual property while managing to smuggle in points of reference: a cowardly lion cub replaces Toto in the wicker basket of Miss Gulch's bicycle; bewitched flowers knock out a classroom quicker than the poppy field felled Dorothy and the boys, yesterday's Emerald City is today's Universal CityWalk. But the newfangled effects can't compare: blue monkeys — little people dressed as winged bellhops — are far more terrifying than a sky dotted with CG flying Caesars. Erivo proves there's nothing scarier than a smart, colored woman with super powers, while given her computer-generated appearance, Grande blends right in. Jon Chu doesn't so much direct as he gives the appearance of busyness. (2024) — S.M. ★★ (IN WIDE RELEASE)

hopes are that it will match the intensity of the aforementioned festivals and perform on a comparable level.

Zak Prescott is no stranger to organizing local music events; he was the man behind the curtain for the recent My Town festivals. After this past year's My Town, a vision for something more bubbled up, and he got right back to work, cooking up the upcoming Punk Rock Rodeo. And while My Town involves strictly local San Diego bands, the Rodeo will be open to groups from anywhere — though it's true that a lot of this year's lineup is California-based. "Financially, we couldn't fly people in," Prescott admits.

As his ambitions for the festival's growth get realized, he intends to get groups from UK and other parts of Europe to come. "I found myself wanting to include other bands outside of San Diego, but it didn't really fit well with the My Town theme. The Punk Rock Rodeo gives us the opportunity to have bands from all over the world play, and still have the same kind of energy of different genera-

"It works out that there's multiple venues on one street," says Prescott. "It's essentially a block party. The street isn't closed off, but it's a block party because all the clubs are involved." Host venues include The Holding Company, Winstons, The Harp, Humble Heart, and Hodad's. "We have the Hodad's parking lot as well. So we'll have an outdoor stage, a food truck, a mechanical bull, and a bunch of vendors set up. That will serve as the hub for the event." The outdoor Hodad's stage will be both free and all-ages. (Humble Heart will be the other site open to all ages.)

Boasting some 30 bands on the bill, the event will kick off at noon and bang away until midnight. Early shows will be at Winstons and The Holding Company. Set times will be organized so concertgoers can have tickets to multiple shows and bounce back and forth. "I went down there and walked from venue to venue timing how long everything took," says Prescott. "From The Holding

Company to Winstons is

less than a minute. So, if one band finishes, you can walk a minute and be checking out the next band." (He does note that "there is some overlap. There has to be for it to work.") Later shows will be held at The Harp and Humble Heart before the night eventually concludes back at The Holding Company.

Notable groups in the lineup include Spray Allen and Change Today, with Joe Wood doing a set from his ten years with TSOL. "It's a good mix if you have a wide taste in music and want to

> check out all the bands." But if you "just want to see a few, we've made it an option to have individual club tickets."

The involved venues are getting a unique chance to create something together. "All the venues are pretty stoked," Prescott says. "It's been a good opportunity

for them to connect with each other. Everyone's promoting each other's clubs and events through the Rodeo. It's a new idea, so I had to sell it to them. I helped them envision what I envisioned. Everyone's been super supportive. The response has been great."

The Punk Rock Rodeo's pre-party will get things underway on March 21 at The Holding Company. The bands helping to fire up the festival that night will be Chaser, Urethane, Jon Cougar Concentration Camp, TiltWheel, Beta7, Reckless Disregard, and the group Prescott fronts, Big Attitude. "It came together really smoothly," he says. "When you have something in your mind and see it coming together, it's fulfilling and exciting. I'm happy where we're at, and looking forward to the day of the event, being able to walk around with a hoodie on, nobody knowing who I am, just enjoying the shows."



# Kids in the pit, Harleys in the lot

P.O.D puts on an impromptu show for San Diego

It happened, and then it didn't: the social media platform TikTok was banned in the U.S., then it was restored. When I opened the app the morning of the ban, the message put forth was clear: the video-creating factory was closed. For now. But the app stated the new administration coming in could reverse the ban. Then the lights were quickly turned back on. Questions remained. Was it a good thing to block? Is it a Chinese vehicle for espionage? Does it melt our brains into a stew of meager attention spans? I'd answer "probably" to a couple of those. But censorship is rarely a cool thing.

The impending ban didn't stop my friend Bloodgood from posting footage of the P.O.D., Dogwood, and No Innocent Victim benefit concert a week before the big bad day. He noted that the shittiest part of losing the platform would be losing connections with the people

who shared stories about whatever band he had just posted. I wondered if it would be one of the last shows he posted on his channel. It seemed...significant.

The idea for an impromptu show held in a Harley-Davidson parking lot came about from a recent episode of the Emo Brown Podcast. The episode featured P.O.D. band members Traa Daniels, Marcos Curiel, and Sonny Sandoval, and during the conversation, Sandoval said he wanted to do something for the hometown San Diego community. This was before they set out

on a world tour with Godsmack and Drown-

To get into the event, fans were asked to donate to Sandoval's charity, Youth of the Nation Foundation. Twenty bucks was what was asked, but you could throw more, less, or nothing and still get access. I secured a spot in line around noon, the time the gates were supposed to open. But it wasn't until about 1:30 pm that the line began to slowly creep. Eventually, some guy in a white vacation-y shirt came out and grabbed the line's attention. "Look," he said, "the bands want to get started, so we're going to open the gates and let everyone in. If you want to donate later, just go back to the booth." The show turned into a free-for-all on

account of daylight availability.

Before the bands started their sets, a camera crew moseyed around asking fans what their favorite P.O.D. memory was. The footage, it was said, would be used on an upcoming documentary. "I brought my wife to a P.O.D. show in 2004 for our first date," said one dude with an arm draped around his teenage son. It seemed TikTok wasn't the only place people could share their band stories, after all. Just maybe the easiest to access by the general public.

At the family-friendly event, I watched toddlers no older than three running around in little mosh pits. I'd never seen anything like it before. The youth of the local community had all gone insane. Nobody's ankles were safe from the bites of children in this barricaded parking lot lined with food trucks, classic cars, beer tents, and grunting Harleys. The scene had the feel of a mini music festival fused with the twisted, conjoined heads of Sturgis and Disneyland.

As P.O.D. took stage, a motorcycle began whipping shitties, aka doing donuts. Then it sped away, obscuring part of the crowd with plumes of white smoke. I turned to a friend. "I'm not going to lie," I said, "that was pretty rad." While we were still choking on the smoke and fumes, the opening bass lines for "Southtown" thumped forth. Gripping a neon orange mic, Sonny Sandoval shouted out the hits, wedging in a few newer songs from the 2024 album Veritas. To protect the kid pits, Sandoval told the crowd not to get too crazy. "Just make it look cool and watch out for the little ones."

Earlier in the day, rumors had swirled that P.O.D. would be putting on a similar charity concert in the Harley Davidson's parking lot annually. Following the hour-long set, the hometown rockers confirmed it. They'd see us again next year. On my way out, I made a quick stop at the foundation booth to drop off the twenty dollars I'd planned to donate earlier. The sun still had some glow left in it. Just down the road from the Harley parking lot, Latchkey Brewery beckoned to us. The moment I walked in, I started chatting with a Canadian dude. "Oh fuckin' great show, eh?" he stated, or asked.

"It'll probably be even better next year," I answered back, "when they've had more than a few weeks to plan it." ■





#### Digging into the famous and familiar

There is, of course, an unfathomable amount of classical music that is available to us. But here are a few pieces that everyone needs to know. Many of them are partly known by many people, but getting to know them in their full glory is much more satisfying.

The first might be the most famous tune ever written: everyone knows this one as "Pomp and Circumstance." However, it is only the first of six pomp and circumstance marches written by Edward Elgar. The tradition of using this piece for academic commencements started at Yale University in 1905, when Elgar was awarded an honorary doctorate by the university.

If you like "Pomp and Circumstance," then you will probably like "Jupiter" from *The Planets* by Gustav Holst. Holst was deep into what today we would call spiritual-

ism. In *The Planets*, Holst depicts the metaphysical aspects of the solar system, as opposed to the astronomical. "Jupiter" has the same form as "Pomp and Circumstance." There is an opening section of robust music followed by a stately procession. Then the opening returns, followed by a massive statement of the procession music, which finishes the piece.

The next piece is also a contender for the most famous tune of all time. Known as "The Ode to Joy," the conclusion of Ludwig Beethoven's *Symphony No. 9* has taken on a life of its own, separate from the work. The text, written by Friedrich Schiller, encapsulates the finest ideals of the European Enlightenment, such as the interrelatedness of all humanity.

The third most famous piece of music of all time is Pytor Tchai-kovsky's 1812 Overture. The piece

was written for the dedication of The Cathedral of Christ the Savior in Moscow in 1882. The music first depicts the Battle of Borodino, which the Russians lost. It then goes on to depict Napoleon's dwindling army as it is devoured by the Russian winter and the pursuing Russian Army.

Giuseppe Verdi wrote his *Requiem* to honor the great Italian writer Alessandro Manzoni. While it is technically sacred music, this requiem is quite operatic in tone and vocal requirements. The "Dies Irae" section depicts the day of wrath and judgment that is to come. The world will be broken into ashes. Listen to this piece before that happens.

Mozart's *Piano Concerto No. 20* is a perfect representation of the elegance depicted in Viennese classicism. The second movement is particularly beautiful as the piano and

orchestra discuss Voltaire or perhaps the latest wig styles.

Finally, "The "Flower Duet" from Lakmé by Leo Delibes depicts Lakmé, the daughter of a Brahmin priest, and her servant, gathering flowers at the river. The story of the opera is one of forbidden love, that which Lakmé bears for a young British soldier



#### Sashimi and aguachile meet at **Tsunami**

Tsunami Modern Cuisine; 205 Town Center Pkwy, Santee: Smoke fills the small plastic dome before me, obscuring my guacamole and the glistening chunks of raw salmon that rest atop it.

It's a tasty little bit of theatrics adorning the salmon guac (\$18) at Tsunami Modern Cuisine. When the dome is lifted and the smoke clears, there's my ring-pressed serving of sashimi and guacamole, dressed with pickled red onions, micro cilantro, and tajin, sitting in a pool of green salsa. The subtly smoky appetizer may be scooped up with either crispy corn tortillas or the saltine crackers provided.

The chef making it, Enrique Ibarra, explains to me that he's taken on a couple of very distinct roles in the restaurant business: making sushi at spots including Harney Sushi, and operating a couple of taco shops. Ibarra figured if he

as well own it. Other appetizers include jumbo shrimp flautas (\$12) and mini tostadas (\$17), featuring ingredients such as Oaxaca cheese and macha salsa.

But make no mistake—this is primarily a sushi restaurant. You can limit your appetizers to edamame and veggie tempura, and dip right into the familiar litany of maki rolls: rainbow, dragon, caterpillar, California, and etc. If you want to take it further (to the special rolls menu), you'll find Ibarra's more elaborate signature seafood combinations, the most popular being the OMG Roll (\$20), with shrimp tempura, snow crab, salmon, and jalapeño.

And if you want to get really wild, he offers a couple of sushi options that leave out the fish altogether, including El Vegan Roll (\$17), each bite a veritable salad, packing in tempura sweet potato, asparagus, cucumber, cherry tomato, avocado, tofu, green onion, jalapeño, and a sliver of lemon. All this should make Tsunami welcome news for both sushi and plant eaters in Santee, where it can be found in the same complex as



spiced with the Peruvian rocoto pepper, returns as a delicious base for another new-tome sushi formulation: sushi toast (\$15). The "toasts" consist of pats of sushi rice fried to a crusty crisp, then topped

with avocado and a choice of sashimi (I went with albacore). It's avocado toast made into a crunchy nigiri, and the delicious Peruvian heat puts it over the top.

Tsunami has a loungey dining room with a small bar serving beer, wine, and sake, as well as patio seating, and occasional live music. As you walk in, an animated neon sign reads, "Let the Magic Happen," and I think there probably does need to be some magic to make all of this work. And with or without the smoke and lights, I think it does.



# Plenty of elbow room with low angler turnout for the local fleet – Large bluefin caught off San Quintin

**Dock Totals 1/26 - 2/1**: 315 anglers aboard 19 half-day to 3-day trips out of San Diego landings over the past week caught 8 calico bass, 1 halibut, 113 sand bass, 65 sanddab, 318 sculpin, and 478 whitefish.

Saltwater: It was a very slow week for the local fleet, given low angler numbers for the trips concentrating on sculpin. sand bass, and whitefish. The catch per angler, however, was consistent for the few folks who got out and enjoyed the extra elbow room. We tend to hit a lull in angler numbers this time of year due to closures and lack of pelagic species to target, but it won't take more than a good bluefin bite on the 9-Mile Bank or a couple vellows caught off La Jolla to get the numbers back up a bit. For what we can target in US waters until sheephead and rockfish open in March and April, respectively, fishing has been pretty good for the less glamorous sculpin, sand bass, and whitefish.

With the big tide swings this week, the halibut bite slowed in the bay, especially where the current is moving fast along the channel edges they haunt. Still, when we have the high tide phases, fishing while going into slack low or high until it starts flowing again can be productive. I always like some current when targeting halibut, but the flatter days have served me better. Hopping a thick grub along the bottom while slowly drifting a channel edge has produced most of my largest halibut catches.

Sand bass are a little less affected by current than halibut. But when fishing sand bass in shallower water, lure presentation gets tougher when moving too fast, and as they like to school up in the winter in deeper water, it can be tough to stay with them on days when wind or current, or both, are pushing you out of the zone. Still, in winter mode, heavier leadhead with a larger grub like a Berkley Mogambo with a tempting squid strip pinned on it can go a long way toward putting a limit in the sack. Sand Bass tend to bite better with a little more current, but not when it is raging. I tend to focus on the downstream side of structure when fishing in current for sand bass and use plenty of weight, whether a dropper loop with bait or using plastics, to stay in the zone as long as possible.

There was a bit of bluefin action last week from off Ensenada to the 240 Bank outside of

San Quintin. I was able to confirm a few caught out of Ensenada, and a couple out of San Quintin, including a 260-pounder caught by Jaime Garcia of Jaime's Pangas. He. his son, and nephew were out looking around the 240 Bank about 10 miles west of the coast after hearing about several breakoffs on larger fish. The day before most boats were catching yellowtail, rockfish, whitefish, and such, which is normal wintertime fishing for the area, but speculation about larger tuna was confirmed when, while dropping a yoyo iron through some meter marks, they hooked a fish that fought for over four hours. It took all three of them, each with a gaff, to get the fish into the boat. It weighed in at 120 kilos (264.5 pounds) on the scale back at Jaime's place.

Further south, the *Independence* got into some good fishing between blows that had stymied boats working off the southern Baja Peninsula. Wahoo were biting well when it wasn't howling, and some really nice yellowfin hit the deck. In the morning hours of Saturday while things were still relatively calm, four large yellowfin were hooked, and two impressive units made it to the deck at 290 and 255 pounds. The other two survived to fight another day.

Breakoffs and pulled hooks are common heartbreaks when targeting tuna pushing 300 pounds, even when using

the best gear, heavy line, and all the right techniques. Pulled hooks, chewed lines, other lines tangling, mistakes due to fatigue...there are too many things that can go wrong when fighting a 250 pound beast with a stick and a glorified winch wound with string. Cutting-edge gear will definitely improve the odds of landing a large tuna, but it has been done for ages on basics like Penn Senators and broomstick-thick fiberglass rods. It is that challenge that drives most anglers, who tend to spend much more than they would at the fish market for a chance to battle a large tuna. We can always hit Tommy The Fishmonger Gomes' Tunaville Market and Grocery at Shelter Island or the Tuna Harbor Dockside Market on the Embarcadero for excellent fresh off-the-boat fish, but the taste of sweet victory adds the special spice that keeps anglers coming back for more. Whether the beach, bay, lake, or offshore, they're out there so go out and get 'em!



#### It's Good To Have a Hobby

- In 2023, friends Boone Hogg and Logan Jugler found a nice stick on the side of a trail in Utah - it had "some excellent grain on it" and a "nice grip," they said. They liked it so much, they shared a review of it with their friends, National Public Radio reported on Jan. 23. Two years later, Stick Nation has about 3 million Instagram followers from all over the world who post pictures and reviews of their favorite sticks. Some are "modded," or altered by humans; others are "natty," left in their natural state. One poster from Antarctica wondered: "There are no sticks here. ... I found an ice stick. Does this count?" Stick Nation allowed the submission. "This is an Antarctica stick," Jugler decreed.

- In November, high above Riedering, Germany, Friedi Kuhne and Lukas Irmler walked across a slackline strung between two hotair balloons flying at more than 8000 feet, United Press International reported. The two were awarded the Guinness World Record for highest slackline walk on Jan. 27. Irmler went first, calling the successful walk "a glorious moment." Kuhne admitted, "Watching Lukas struggle on the slackline was also very intimidating for me," noting that the balloons went up and down while they were mid-walk. "At one point we were walking kind of downhill -- the next minute uphill. The tension of the line was going up and down." He celebrated by parachuting off the line.

#### It's a Mystery

- The Los Angeles Times reported on Jan. 27 that police were called to a property along the Los Angeles River where Google Earth images had captured multiple HELP signs scratched into the dirt. The land is owned by the Union Pacific Railroad, and it turns out the satellite images were captured in 2023. But a KTLA-TV news helicopter flew over the property on Jan. 27 and saw that the words were still there. Jill Micek, a spokesperson for Union Pacific, said the railroad is aware of a man who has trespassed on the company's property repeatedly and who is responsible for the alarming messages. While she stressed that no one is in danger, the conspiracy theory community lit up with tales of underground tunnels: "The truth is in the tunnels," one wrote on X. But LAPD is also familiar with the individual who frequents the area, and they said he "has refused housing or a mental health evaluation. He has been at the location for a few years."

#### Weird in the Wild

- In rural Willows, Australia, a man in his 50s suffered serious injuries on Jan. 29 when a "massive" kangaroo attacked him as he walked from his house to his car, The Guardian reported. Fortunately, a neighbor witnessed the attack and was able to call for help. Rick Underhill of the Willows Rural Fire Brigade said the man encountered two kangaroos, one male and one female, and the female ran off before the "other bastard turned around and attacked him."

He said the male roo was about 6 1/2 feet tall and probably weighed 220 pounds. Underhill warned community members to stay at home. "A lot of elderly people live in this little community, and they like to go and walk their dogs in the morning," he said. "And that's just asking

- Twelve thousand humans, alongside dozens of humanoid robots, are scheduled to compete in a half-marathon in Beijing in April, Oddity Central reported on Jan. 29. Experts say experienced human runners have the edge over robots, partially because of battery life, but battery changes mid-race will be allowed.

#### **Don't Try This at Home**

- JAMA Cardiology published a case on Jan. 22 that might put followers of the carnivore diet off their meat. The subject arrived at a Tampa, Florida, hospital with yellow oozing nodes on his palms, elbows and soles of his feet, the New York Post reported. He told doctors that he was following a diet consisting of entire sticks of butter, six to nine pounds of cheese and hamburger patties daily. He said his overall health had improved - he had lost weight and gained energy and cognitive functioning. But the painless ooze had started nearly a month earlier. Blood tests revealed his cholesterol level was more than 1000 mg/dL - about five times what is considered healthy. He was diagnosed with xanthelasma, in which excess lipids ooze from the blood vessels. The report didn't reveal the man's fate.




